The meeting convened online at 9:06AM. Stephanie Fritts (Chair) introduced herself as the Chair and welcome the Board and guests. Jesse indicated to Stephanie that a quorum was present.

Stephanie asked if there was consensus to approve the August agenda.

Next, the Board reviewed the May minutes. Stephanie asked if there was a motion.

Raechel Alderete moved to approve the May minutes. Jessica Fann seconded the motion.

Announcements:

- Staff Announcements:
 - o Jesse Hansen Announced:
 - Laura Bravo has submitted her resignation and gave her a farewell. He also announced that this would be Elliot Moen's last meeting as he would be leaving DCJ at the end of August.
 - That the decision to shift the recurring date of the Board meeting has not been finalized. The Executive Committee wanted to solicit more information about the impact of such a change. Board members noted several conflicts with the alternate 1st and 4th Friday's of the month. Jesse indicated that he would explore other options with the Executive Committee hearing this feedback.
 - The Colorado Department of Public Safety (CDPS) and Violence free Colorado conducted a
 press conference regarding the Juvenile Guidelines that can be accessed here.
 - There may be a need for some temporary support to assist the Application Review Committee (ARC) in processing renewal applications. He inquired if there are Board members available and interested to help. Nil Buckley, Jeanette Barich, and Jessica Fann all agreed to help temporarily.
 - The Office of Research and Statistics are collaborating with the DVOMB to conduct a validation study on the Domestic Violence Risk and Needs Assessment (DVRNA). Reviewing the data is underway and will have information by November, 2021.
 - There was language in the recently approved Administrative Policies that was erroneously excluded during the review process. The ARC reviewed the language that was omitted and agreed that the language should be included. Jesse shared the language with the Board and indicated that a notice would be given to Providers and stakeholders.
 - o Carolina Thomasson announced:
 - So far there have been 144 renewal applications created in the Provider Database Management System. Renewals were due by July 31, 2021. She noted that there is an automatic extension to the July 31st deadline through August 30th, 2021.
 - Probation is unable to provide reference letters for the purpose of new and renewing applications.
 - o Marina Borysov announced the following updates regarding training events:

- 11 Providers were subject to complaints, seven cases were dismissed
- Three new Board members and one new chair
- Approved Revisions to Section 1.0 and the Administrative Policies
- The Board met 11 out of 12 months
- The Board created the Diversity, Equity and Inclusion Committee
