RE: 2021 Justice Assistance Grant Formula Awards

Attached is a list of projects which have been approved for funding by the Governor-appointed Justice Assistance Grant (JAG) Board and the Division of Criminal Justice. The JAG Board assists the Division in distributing Colorado's Edward Byrne Justice Assistance Grant from the U.S. Department of Justice. These awards to state and local agencies will begin between July 1, 2021 and January 1, 2022.

Colorado's Justice Assistance Grant supports a wide variety of programs designed to improve law enforcement, prosecution, adjudication and prevention programs. A substantial number of the proposed awards are for continuing projects throughout Colorado. The recommendations were made after the Board conducted a formal process, including appeals that began in May 2021 and concluded this month.

A total of 77 applications were received totaling \$8,938,729. Out of these applications, 63 projects will be funded, totaling \$4,784,680. Of these, 6 are state level projects totaling \$619,449. The remaining 57 projects totaling \$4,165,231 are local projects.

A summary of funding recommendations by program purpose area precedes a description of each project.

Application Number: Agency: Federal Award: Summary:	DJ-21-01-35-1 Colorado Bureau of Investigation \$200,245 External grant funds continue to play a vital role in maintaining and improving the forensic science services provided to our law enforcement partners and citizens of Colorado. The goal of this application strives to ensure high standards of quality and timely delivery of forensic services specifically in the Latent Print and Firearms disciplines of the laboratory. The Colorado Bureau of Investigation Forensic Services (CBI-FS) serves a population of over 5,456,574 citizens in a geographic area of 103,641.89 square miles (statewide). The CBI-FS system includes four ISO 17025:2017 accredited full service laboratory facilities located throughout the state in Denver, Pueblo, Grand Junction, and Greeley; and works with all law enforcement agencies within the state boundaries. The CBI-FS seeks funding for overtime for latent print and firearms examiners. The overtime would reduce the turnaround time and the overall backlog of cases resulting in better customer service.

A prosecuting attorney must explain in writing why the delayed release is justified; that statement will have to be released to the public when the video is released. A new system would bolster the safety of LCCC staff who operate the facility, the safety of the offenders in LCCC's care, the accountability for rule and law violations by LCCC offenders, and the integrity/transparency of the program and staff.

OMPD will serve as a "front door" to help clientele who are often disconnected from support services. Many clients are homeless or at-risk, face charges for low-level crimes, and have behavioral health issues.

These hard-to-reach clients are already involved with OMPD, which represents them for law violations. Goals are to increase connection to benefits and support services for OMPD clients; promote system integration of human and criminal justice services between DHS and OMPD; and help reduce homelessness and recidivism among OMPD clients, which will be measured quarterly. The project aligns with the JAG goal to reduce recidivism and improve outcomes for those affected by crime, including families of the person charged, using best practices.

The Municipal Opportunity to Secure & Sustain Treatment program (MOSST) will increase access to meaningful treatment and reduce the financial burden experienced by probation clients court ordered to participate in therapeutic interventions. At the municipal level with no funding to pay for treatment, financial barriers prevent offenders from participating in treatment services that could divert them out of the justice system. The MOSST program will be evaluated for effectiveness based on success in getting offenders enrolled into court-ordered treatment, successful completion of the court-ordered treatment, and whether offenders are able to locate sustainable funding sources to ensure continued follow-through with recommended treatment.
