RE: 2022 Justice Assistance Grant Formula Awards

Attached is a list of projects which have been approved for funding by the Governor-appointed Justice Assistance Grant (JAG) Board and the Division of Criminal Justice. The JAG Board assists the Division in distributing Colorado's Edward Byrne Justice Assistance Grant from the U.S. Department of Justice. These awards to state and local agencies will begin between October 1, 2022 and January 1, 2023.

Colorado's Justice Assistance Grant supports a wide variety of programs designed to improve law enforcement, prosecution, adjudication and prevention programs. A substantial number of the proposed awards are for continuing projects throughout Colorado. The recommendations were made after the Board conducted a formal process, including appeals that began in May 2022 and concluded this month.

A total of 42 applications were received totaling \$4,826,625. Out of these applications, 36 projects will be funded, totaling \$2,430,234. Of these, 1 are state level projects totaling \$100,000. The remaining 35 projects totaling \$2,330,234 are local projects.

A summary of funding recommendations by program purpose area precedes a description of each project.

The goal of this application will specifically address backlog reduction in the disciplines of Drug Chemistry, Toxicology, Trace Chemistry, Latent Prints, and Firearms; this application does not include the DNA section of the laboratory.
	The Colorado Bureau of Investigation Forensic Services (CBI-FS) serves a population of over 5,456,574 citizens throughout the state. The CBI-FS system includes four ISO 17025:2017 accredited full service laboratory facilities located throughout the state and works with all law enforcement agencies within the state boundaries. The CBI-FS seeks funding for overtime to be used by examiners in the

and the overall backlog of cases resulting in better customer service

This person will work with MCSO sworn personnel from multiple teams to fill a gap and a need that currently exists as the way evidence is gathered continues to change due to changes in technology. This person will also promote increased specialization and efficiency and will be part of the real-time-crime unit which will provide rapid information to MCSO leadership and deputies in the field.

DDWT's thorough evaluation plan measures outputs and outcomes monthly.

JAG grant dollars will provide partial funding for the Chaffee County Sheriff's Office (CCSO) to replace the entire V-Viper 9-1-1 system, which is at "end of
	life," and to add a 4th 9-1-1 computer station to the center. The CCSO's goal is to ensure enough console positions in the center due to handle the increased call volume and to have a 9-1-1 system that is up-to-date with a service contract.

This project aims to have zero admittance of contraband into the jail at all times. This goal will be measured by having each inmate/visitor pass through the scanner before entering the facility. Summary:	The City and County of Denver has seen a significant increase in counterfeit M30 tablets that contain Fentanyl. Keeping with the efficiency of the Chemistry Unit's presumptive identification of fentanyl, 48–72-hour turnaround time has been challenging using the traditional GC/MS instrumentation. The Denver Crime Lab is requesting the purchase of a MX908 instrument. MX908 is a mobile device that can analyze suspected narcotics in 2-5 minutes compared to the four-hour traditional method. The Chemistry Unit will then implement the use of the instrument to include validation of the MX908 and training of laboratory personnel. The Chemistry Unit will compare new instrumentation analysis time to the traditional methods of analysis. This project aligns with the 2022 JAG goal of addressing crime through implementation of forensic science methods.
