

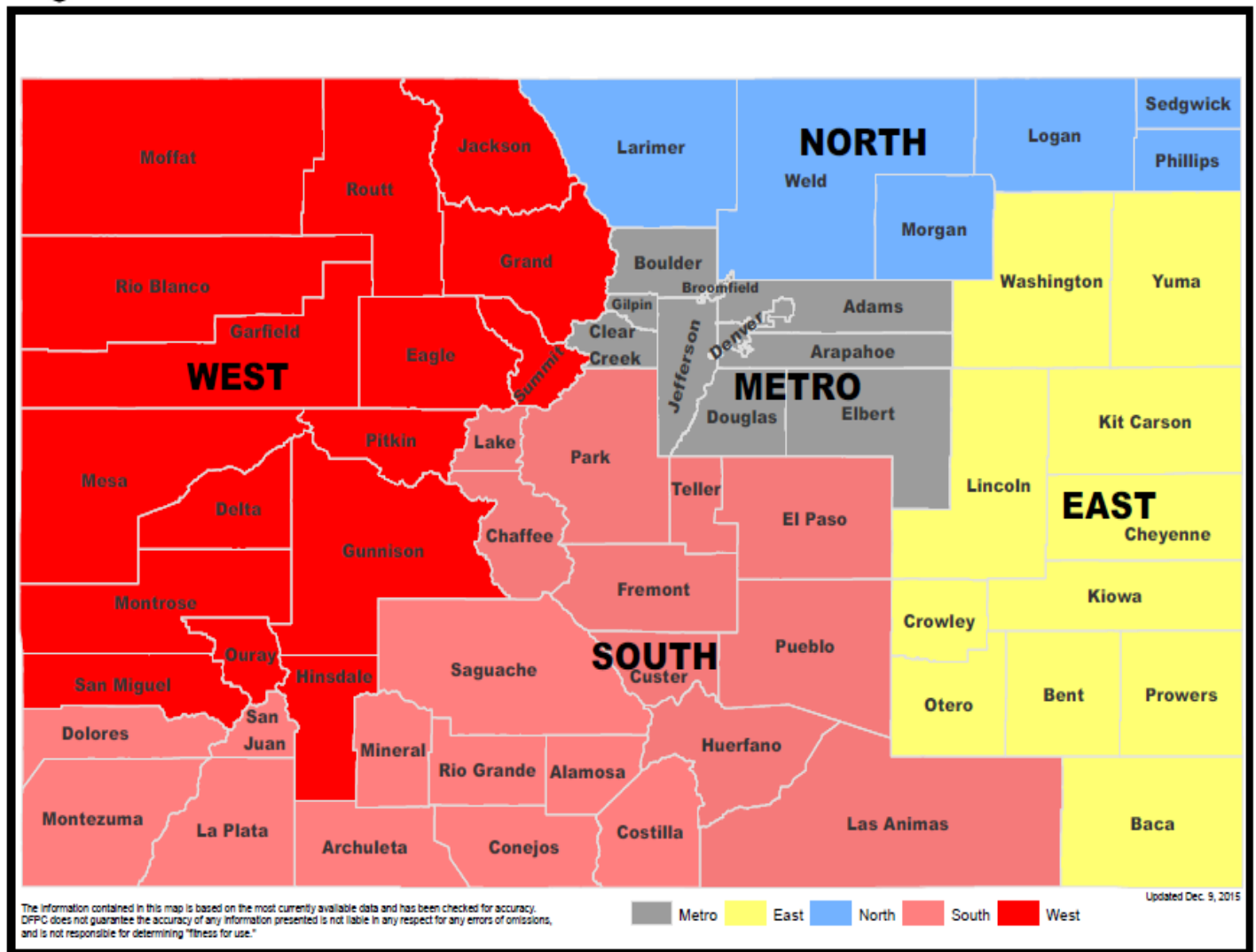
REGIONAL & DRIVER OPERATOR PROCTORS FOR COLORADO DIVISION OF FIRE PREVENTION & CONTROL
