NOTE: As a part of the 2017 FireWomen Conference, this course is geared towards women seeking to obtain their Fire Officer I certification. We will accept applications from all interested parties with priority going to women firefighters. If there are open seats as of May 1, 2017 those will be filled by any qualified applicant in the order applications were received.

Coordination with 2017 Firewomen Conference: To ensure participants get to benefit from the 2017 FireWomen Conference, attendees in the Fire Officer I class will attend opening ceremonies and Chiefs Luncheon on June 7th and the Banquet on Friday night June 9th. These events are included in the cost of the class. This is a great opportunity to meet and train with women firefighters from around Colorado.

This class is designed to prepare students for the challenges of the Fire Officer I level responsibilities. If the student successfully completes the course, they will have all Fire Officer I JPR's Completed and evaluated by a proctor. The class is not designed to prepare the students for taking the written test, students must study the class textbook to prepare for the written exam. Students should expect homework each evening related to the JPRs. Students will need to have access to a laptop computer/tablet for the completion of the JPR's. The Fire Officer I course satisfies the requirements of the National Fire Protection Association (NFPA 1021), and provides the tools necessary to obtain certification through the Colorado Division of Fire Prevention and Control.

Important!

Students will be given a pre-course assignment that **they must bring with them on the first day** of the class on Monday, June 5. Some JPRs will be evaluated during the week of the course. At the conclusion on Friday, students will be given an assignment to complete the rest of the JPRs assigned to them and will have until June 26th to submit all of their completed JPRs to their proctor prior to sitting for their exam. Failure to submit final JPRs will result in candidate then being required to submit all JPRs in the traditional method for review.
