 - Crisis Response Unit with 4 FTEs
 - Administrative personnel with 3 FTEs
 - Office Director
 - Grants Manager
 - Budget Analyst
 - Increased funding for threat assessment training
 - Three additional trainings each year for 4 years
 - Increased funding for classroom locks and exterior doors
