❖ NEW Monitoring the Future Study

- <u>Monitoring the Future</u> is an ongoing study of the behaviors, attitudes, and values of American secondary school students, college students, and young adults.
- According to the most recent data from the national Monitoring the Future (MTF) study:
 - The percentage of US high school seniors reporting past month marijuana use continues to gradually increase
 - o In 2012, 22.9% of 12th graders reported using marijuana in the past month, a 25% increase since the most recent low of 18.3% in 2006
 - While the current prevalence of marijuana use is far below the peak of 37.1% in 1978, it has returned to a level not seen since the late 1990s

Help-Seeking by Young People

- Help Seeking by Young People, based on "Associations between suicidal high school students' helpseeking and their attitudes and perceptions of social environment," Journal of Youth and Adolescence, 2012.
 - The reluctance of teens who have seriously considered suicide to seek help is not simple embarrassment or a lack of information, but often based on their perceptions – accurate or not – of whether asking for help will result in assistance that effectively addresses their problems.

Measuring School Climate: A Toolkit for Districts and Schools Produced by the Colorado Legacy Foundation and Colorado Department of Education

• Effective approaches to addressing bullying focus on improving school climate as a key approach to prevent bullying in addition to teaching adults and students skills to respond appropriately to bullying when it occurs. Given the importance of school climate in bullying prevention, we recommend that

- districts and schools focus on measuring school climate rather than narrowly focusing on measuring bullying.
