THE DIRECTOR'S CORNER

The School Safety Resource Center was proud to present our 2013 Legislative Report to the Colorado Joint Education Committee in January. Highlights from that report with increases in all areas include:

- Expanded Electronic Capabilities
 - ListServ members increased from 5,345 to 7,628
 - LiveStreaming of Keynotes Initiated in 2013 1,261 views
 - Online Courses Increased from 2 to 5
- Training Milestones:
 - 17 Topic-Center Regional Trainings:
 - Adult Sexual Misconduct
 - Positive School Climate
 - Proactive Discipline Alternatives
 - Threat Assessment
 - Youth Substance Abuse Prevention
 - Youth Suicide Prevention Intervention

IPM is an effective, environmentally sensitive, and commonsense approach to pest management. IPM programs use a combination of pest management options. Implementing IPM in schools has several benefits: (1) Controlling pest problems in schools decreases asthma triggers, caused by pests such as cockroaches and mice; (2) IPM leads to reduced pesticide use; limiting children's contact with pesticides may protect them from chronic health issues correlated with these chemicals; and (3) savings from reduced pesticide applications can be used in other ways to improve the school environment.

- Bullying is one type of youth violence that threatens young people's well-being. Bullying can result in
 physical injuries, social and emotional difficulties, and academic problems. The harmful effects of bullying
 are frequently felt by others, including friends and families, and can hurt the overall health and safety of
 schools, neighborhoods, and society.

- The CDC defines bullying as any unwanted aggressive behavior(s) by another youth or group of youths who
 are not siblings or current dating partners that involves an observed or perceived power imbalance and is
 repeated multiple times or is highly likely to be repeated. Bullying may inflict harm or distress on the
 targeted youth including physical, psychological, social, or educational harm. A young person can be a
 perpetrator, a victim, or both (also known as "bully/victim").
