#### THE DIRECTOR'S CORNER

**Happy Safe Schools Month!** We hope your school will find a way to highlight your safety efforts to your parents and community this month. If you would like the Center to highlight them in next month's E-Update, please send them along. Photos are always welcome.

We have over 130 folks already registered for our **2014 Colorado Safe Schools Summit** and space is limited. We hope you will join us as we believe you will find the information shared and the networking invaluable. Please see the information below.

Finally, I am pleased to announce that the Colorado Department of Education working in collaboration with the Colorado School Safety Resource Center has been awarded a \$413,411 grant for school emergency management training. The main goals of the grant are:

- 1. To improve state structures through the development of an inter-agency model to support Emergency Operations Plan (EOP) regional training. Two key strategies will include the formation of a training engagement committee and the development of cooperative agreements to organize training and address barriers to participation.
- CDE will leverage its role and relationships in working with schools and districts to emphasize the important
  aspects of school safety and promote EOP training. The grant will provide opportunities for CDE to build on
  its current partnership with the Colorado School Safety Resource Center, who will be the subject matter
  experts for the training.
- 3. The grant will build local capacity by providing training to 420 participants, representing 100 local education agencies, charter schools, and non-public schools to create high-quality EOPs over an 18 month period.

Once CDE has hired a grant manager and formed the training engagement committee, more information will follow as to how schools and districts can benefit from this grant.

## **❖ NEW** Healthy Kids Colorado Survey Results Soon Available

- The 2013 Healthy Kids Colorado Survey collected self-reported health information from Colorado middle and high school students. The HKCS was administered in the Fall of 2013 to approximately 40,000 randomly-selected students from over 200 middle and high schools. The survey is administered to students in odd-numbered years with the next full administration in Fall 2015.
- HKCS is supported by <u>Colorado Department of Public Health and Environment (CDPHE)</u>, <u>Colorado Department of Education (CDE)</u> and <u>Colorado Department of Human Services (CDHS)</u>.
- The primary use of the data is to identify health priorities in order to better implement school- and community-based strategies to improve and maintain the health of youth.
- An executive summary, regional data and other topics will be available later this fall.
- Due to some results being incorrectly reported, the HCKS data may not be available at this time. Please check back periodically for updates. State-level data

- The <u>Office for Victims of Crime (OVC)</u> grantee <u>Northeastern University</u> in Boston, Massachusetts, is seeking
  victim assistance providers and their first responder partners to pilot test the <u>Vicarious Trauma Toolkit</u> (VTT).
- The VTT will be an online repository of resources for victim assistance providers, law enforcement officers, firefighters, emergency medical services (EMS) providers and other first responders to learn about and respond to vicarious trauma.

- Four pilot sites will be selected from around the country to test the VTT. Each pilot site will have an eightmember team, with two representatives from each of these disciplines: law enforcement, firefighters, victim assistance, emergency medical services providers.
