COLORADO SCHOOL SAFETY RESOURCE CENTER NEWS

NEW FEATURE - <u>School Safety Steps</u> Realizing how daunting the subject of school safety can be, especially for administrators with multiple responsibilities, each month the Center will provide suggested steps for districts to take/review as the school year unfolds. These steps will incorporate best practices and help your district be compliant with the Safe Schools Act. The name of the staff member who composed the step and can offer the best assistance will follow each entry. We hope it helps to lighten the load.

August School Safety Steps: As we get ready to return to school, we need to ask ourselves, are we prepared? Not prepared for the return of all those students or prepared for the fall sports season, but are we prepared for emergencies or incidents on school grounds. One of the best ways to ensure we are ready for an emergency is to **train our district safety teams**, even those who are highly trained could do with some refresher training from time to time.

Did you know that the Colorado Safe Schools Act (C.R.S 22-32-109.1) requires that all schools, "institutionalize the Incident Command System (ICS)," and the recommended action to accomplish this is to have all, "Safety Team Members & Backups complete IS 100.C, Introduction to the Incident Command System and that all District Crisis Plan Developers complete IS 100.C, Introduction to the Incident Command System and IS-362.A, Multi-Hazard Emergency Planning for Schools?"

FEMA recently revamped the IS 100 course in **June of 2018**, removing the industry specific versions. So if it's been awhile since you took this course, now might be a good time to brush up on these important topics. If you've never taken these courses and you are on a safety team or have been asked to participate in your school's planning team, please take the time to understand your role and responsibilities through these courses. Courses are online for free.

Stay tuned for more tips on creating Emergency Operations Plans and safety planning in the coming months.

Legislative Update

Recent legislation has passed that may impact your work:

- ❖ First, HB18-1269 (now C.R.S.§ 22-1-130), requires local education providers to **notify parents** if an employee or former employee is charged with certain felony offenses. The time, place and manner of those notifications are spelled out in the new law, and may require policy changes in your school or district. The CSSRC convened a multidisciplinary workgroup last winter to address similar issues, and created a toolkit with sample letters to provide guidance. The legislation passed after the workgroup had disbanded, but the toolkit was updated to reflect the changes. You can access the toolkit HERE.
- Additionally, HB18-1064 (now C.R.S. § 19-3.5-105 et seq. and § 26-6.5-107) directs the Colorado Children's Trust to develop and maintain a **training program for the prevention of child sexual abuse**, directed to persons who interact with young children. Your evidence or research-based prevention program may be eligible for implementation grant funds. The Center will provide updates once the Colorado Children's Trust Fund has announced rules.
- As you know, Colorado has a juvenile sexting law that has been in effect since January 2018. See this webcast from Child Sexual Abuse Prevention Specialist, Margaret Ochoa, J.D. if you need some background. The Center was directed by the legislature to create a program for the courts and schools to aid our youth in understanding the law and identifying risks and consequences of sexting behavior. School Interoperable Communications Planning and Fundraising Workbook

- The bill (SB18-158) creates the SAFER cash fund and directs a \$5 million transfer to the cash fund each year between FY 2018-19 and FY 2023-24 from the State Public School Fund. It has been signed by the Governor.
- To help schools and school districts prepare in advance to take advantage of this opportunity when it is formally announced, <u>School Safety Partners</u> has posted a School Interoperable Communications Planning and Fundraising Workbook <u>here</u>.
- Interoperable communications enables schools and school districts to communicate in real-time with first responders during a school emergency.
- Over 10 years of pilot testing in over 200 Colorado schools has shown that a well-practiced interoperable communications program can: save and protect lives in the school; save and protect emergency responder lives; increase emergency responder effectiveness and coordination; improve response times, and reduce property loss
