THE DIRECTOR'S CORNER

A BIG thank you to everyone who participated in the 2015 Colorado Safe Schools Summit! We had 350 folks registered, 35 presenters shared their expertise, and 21 vendors and non-profit partners provided resources. We are still summarizing the evaluations but the initial responses were very positive. We are already scoping out a venue for next year's Summit in October. Stay tuned.

Update on the SB15-214 School Safety and Youth Mental Health Interim Committee:

- The committee had its final meeting before the legislative session begins in January from 10:00 until 4:45 on Thursday, October 27th. It was a very full agenda that started with morning testimony on FERPA (Family Educational Records Privacy Act) and ended with a discussion of bills proposed by some of the legislators on the committee.
- The FERPA discussion revolved around schools conducting threat assessments and the sharing of that
 information within the district and to others. A proposal was suggested by the Consortium of Colorado
 Special Education Directors to have the Colorado School Safety Resource Center take the lead on keeping
 Colorado schools updated on threat assessment best practices. It was easy to agree to this as we already feel
 this is one of our responsibilities. Resources and training are available from the Center. Please see the
 February 25th training mentioned below!
- The afternoon started with a panel of teachers from JeffCo, Boulder Valley, Genoa-Hugo, Wray and Skyview Academy in Highlands Ranch. They shared how their schools manage school safety and threat assessment.
- Kimberly Hult, an attorney with Hutchinson, Black and Cook, discussed district responsibilities under Title IX particularly as it relates to sexual assault which is one of the crimes schools are responsible for protecting students from under SB15-213.
- Former President of the State Senate, Brandon Shaffer, now with the St. Vrain Valley Schools then presented a proposal he believes would allow mental health professionals to disclose limited information about a client to school district personnel if there is a threat to a school or the occupants of a school.
- Finally, the committee took up the seven bills proposed by some of the legislators on the committee. Four of the bills were immediately tabled until the reports from the Davis Family and Littleton Public Schools are released after the first of the year. Those tabled included a bill to provide materials to all schools on Safe2Tell; one preserving governmental immunity when schools abide by all the components of the School

Safety Act (CRS22-32-109.1); another to require self-insurance pools to abide by the same regulations as insurance companies; and the fourth to require that school districts have written emergency procedures to include consideration of students' special needs, including but not limited to special needs related to disabilities.

- The three that were voted upon were all defeated although individual legislators may still choose to introduce these bills under their five-bill limit during the regular session. These included two bills by Rep. Willet. The first underscoring that "reasonableness" of a district to comply with SB15-213 include consideration of the school district's or charter school's available resources and making sure that the terms "reasonableness," foreseeability," and "negligence" do not contradict or alter any jurisprudent of the Colorado courts or the applicability of any jury instruction used in Colorado courts. The second bill that was defeated would waive governmental immunity for all public entities (not just schools) involved in an act of school violence as defined under SB15-213.
- The other bill not carried by the committee to the legislative session was proposed by Senator Newell to increase services to schools on suicide education and awareness by providing increased resources to both the Office of Suicide Prevention at the Colorado Department of Public Health and Environment and the School Safety Resource Center.
- A special meeting of the committee to hear the three reports being written on the Arapahoe High School tragedy is tentatively set for Friday, January 22nd at 1:30 at the Capitol. This too is an open meeting. Watch the December and January E-Updates for more information.

Please be sure to take note of the no-cost threat assessment training the Center will be sponsoring on February 25th to include team training in the afternoon.

- VIP Observers may arrive at any time, and will have access to early morning preparation activities, up-close vantage points throughout the exercises, and the all-hands-on-deck "hotwashes," or post-exercise evaluations, around lunchtime.
- Organized by: <u>Pueblo County Sheriff</u> Kirk Taylor, <u>Emergency Services Bureau</u> Chief Mark Mears, <u>D70</u> <u>Superintendent</u> Ed Smith, and <u>D70 Director of Student Services</u> Greg Keasling.
- Keasling maintains at D70 a school safety center of excellence that puts into practice latest response strategies and tactics, and develops new ways to integrate school security technologies. Keasling also records each exercise using up to 70 high-definition cameras, with footage captured by embedded video documentary crews, surveillance cameras, and body cameras worn by first responders, actors, and school participants. The video archive is freely available to researchers everywhere.
- D70 conducts full-scale exercises at least once a month, rotating among its 19 campuses. Exercises involve up to 18 response agencies at a time and sometimes more than 2,000 students, teachers, and staff members.

- The <u>Colorado Department of Transportation</u> (CDOT) has announced their 2016 Safe Routes to School (SRTS) Infrastructure and Non-Infrastructure Projects Grant Applications for project funding.

- The goal of SRTS is to help schools, school districts and local communities enable and encourage more children in Kindergarten through 8th grade to safely bicycle and walk to and from school.
- Eligible activities include, but are not limited to:
 - Planning, design, and construction of safe school routes for children to walk and bike to and from school
 - Planning, design, and construction of facilities for pedestrians and bicyclists to travel to and from school
 - Educating children, parents, and communities about safe walking and bicycling practices and the health benefits that result from walking and bicycling to and from school.

NEW Evaluation of the GLSEN Safe Space Kit

- The newly-released evaluation report assesses the utility of the *GLSEN Safe Space Kit* itself, which was developed to build on the power of the iconic Safe Space Sticker by supporting educators who want to become informed and active allies to LGBT youth. It is encouraging to see that educators found the kit to be a practical and useful resource that responds to their reality. Their responses give a window on the variety of ways that the kits are affecting school communities:
 - <u>Teachers and school staff who received the kit are taking action</u>: Faculty and staff report that they turn to the *GLSEN Safe Space Kit* for practical guidance on making their schools safer and more supportive for LGBT youth. Educators who read the guide were more likely to have supported LGBT youth and to have examined their school's policies and practices regarding LGBT youth. Even teachers in hostile environments who did not feel able to put the stickers up used the kit to figure out ways to take an action appropriate to their school environment to start sowing the seeds of change.
 - <u>GLSEN Safe Space Kits are starting dialogue and sparking change in schools nationwide</u>: Nearly 80% of educators who received the kit reported intervening to stop anti-LGBT bullying a higher rate than LGBT student reports of teacher intervention nationally. A significant number went beyond that baseline step. Half of the kit recipients had reached out to their colleagues to discuss the issues

facing LGBT students and how they might be able to make a difference. Building a critical mass of adult support within a school is key to transforming school culture and significantly improving the academic achievement and individual well-being of LGBT students.

"Signs of Suicide" in Middle Schools

- A study to evaluate the effects of the Signs of Suicide (SOS) program in middle schools found that children who reported suicidal ideation prior to participating in the program were 96 percent less likely to report suicidal behaviors (ideation, planning, or attempts) three months after participating in SOS than children with prior ideation who had not participated in the program.

White House Task Force Releases New Resources for Campus Communities
