- School Emergency Management (SEM) Trainings have begun. Please check the <u>flyer</u> for locations and dates and get your team on board!
- SB15-214 Committee Update:
  - The committee met for the third time on September 9<sup>th</sup> with presentations by school resource officers, the Colorado Juvenile Defenders Center, an overview of the Colorado Governmental Immunity Act, a panel discussion of risk management in Colorado schools and in other states, a discussion of liability and underwriting practices in the private market, a presentation by Mental Health First Aid and Mental Health America of Colorado and public comment by John MacDonald, Director of Security for the JeffCo Schools.
  - The fourth meeting of the committee on September 22<sup>nd</sup> opened with a presentation by John-Michael Keyes, Founder and Executive Director of the I Love You Guys Foundation. Other presentations included representatives from the Colorado Youth Advisory Council, Colie's Closet, Bridging the Gap, Court Appointed Special Advocates and Padres Jovenes y Unidos.

- Before concluding for the day, the committee discussed possible legislation moving forward and still subject to change. There were no specifics but the general topics included: clarifying the legal effects of SB15-213, expanding awareness of the Safe2Tell program, establishing terms by which a school district or charter school may prevent a waiver of governmental immunity, best practices for a school safety pilot program, training certain persons to assist youth in crisis, and directing certain public entities to take certain measures to improve school safety.
- The next meeting of the committee is set for Tuesday, October 27<sup>th</sup> beginning at 10:00 AM in committee room 271.

- <u>Safe2Tell</u>, a state-wide anonymous reporting line to report violent or troubling events, announces the launch of a new reporting resource for Colorado students, parents, teachers, and communities.
- The Safe2Tell Colorado mobile app for anonymously reporting threatening behaviors and safety concerns directly to Safe2Tell dispatchers in Colorado is available now for downloading. The mobile app is available from the Apple App Store for iPhones and Google Play for Android devices.
- The Safe2Tell mobile app is password protected, allows reporters to upload videos or photos, and has the ability to conduct two-way dialogue with the reporter and dispatcher using a unique login and password.

- VIP Observers may arrive at any time, and will have access to early morning preparation activities, up-close vantage points throughout the exercises, and the all-hands-on-deck "hotwashes," or post-exercise evaluations, around lunchtime.
- Organized by: <u>Pueblo County Sheriff</u> Kirk Taylor, <u>Emergency Services Bureau</u> Chief Mark Mears, <u>D70</u> <u>Superintendent</u> Ed Smith, and <u>D70 Director of Student Services</u> Greg Keasling.
- Keasling maintains at D70 a school safety center of excellence that puts into practice latest response strategies and tactics, and develops new ways to integrate school security technologies. Keasling also records each exercise using up to 70 high-definition cameras, with footage captured by embedded video documentary crews, surveillance cameras, and body cameras worn by first responders, actors, and school participants. The video archive is freely available to researchers everywhere.
- D70 conducts full-scale exercises at least once a month, rotating among its 19 campuses. Exercises involve up to 18 response agencies at a time and sometimes more than 2,000 students, teachers, and staff members.

#### NEW "Signs of Suicide" in Middle Schools

- A study to evaluate the effects of the Signs of Suicide (SOS) program in middle schools found that children who reported suicidal ideation prior to participating in the program were 96 percent less likely to report suicidal behaviors (ideation, planning, or attempts) three months after participating in SOS than children with prior ideation who had not participated in the program.

## **INSTITUTIONS OF HIGHER EDUCATION**

#### **Student Government Associations and Campus Safety**

- With the start of a new academic year approaching, student government associations (SGAs) are gearing up for another year's worth of student representation. SGAs perform a variety of important functions on campuses, one of which is organizing and managing student groups. In many cases, students and administrations are working together to enhance campus public safety.
- Examples of student-organized groups that serve campus public safety needs can be found across the country. Two successful examples to consider are: The <u>Student Auxiliary Safety Patrol (SASP) at Ithaca</u>

<u>College</u> and the <u>Student Committee for Safety and Security</u> at the University of North Carolina (UNC) at Chapel Hill. The SASP was formed with "the purpose of providing auxiliary support to the College's Office of Public Safety and Emergency Management." The group of 40 students conducts nightly campus patrols, assists with special events, and performs other campus public safety tasks. SASP also has an <u>escort program</u>, which connects group members with any member of the campus community that wishes to be accompanied while walking on campus between the hours of 9pm and 3am.

#### **NEW** White House Task Force Releases New Resources for Campus Communities

- The <u>White House Task Force to Protect Students from Sexual Assault</u> released two new resources for campus community members and health practitioners on Thursday, September 17th to help prevent and respond to sexual violence on campus. The release of these resources, a Resource Guide and Safe Place: Trauma-Sensitive Practice for Health Centers Serving Students toolkit, coincide with this month's 21st anniversary of the Violence Against Women Act (VAWA).
- The resource guide is a compilation of existing materials designed to support students; campus administrators, staff, and faculty; and local stakeholders and partners. The guide was created to serve as a central hub for the resources that have been created over the past few years. The guide includes:
  - o Campus climate surveys
  - Prevention tools
  - Training and technical assistance, including information on the <u>trauma-informed sexual assault</u> <u>investigation and adjudication training program from NCCPS</u>
  - o Sexual misconduct policies and procedures
  - o Community partnerships and MOUs
  - o Public awareness and engagement activities
  - o Data and information-sharing
  - Selected funding opportunities
  - Related law and policy sources

- The <u>Safe Place resource kit</u> was developed by the Department of Education's National Center on Safe Supportive Learning Environments Technical Assistance Center for campus health center managers. It is designed to expand campus health centers' understanding and implementation of trauma-informed response and practice to sexual violence. According to the National Center on Safe Supportive Learning, the new kit will "support health center staff at all levels to:
  - Understand the likelihood that they serve student patients and even work with colleagues affected by trauma.
  - Infuse trauma-sensitive approaches into their daily routine.
  - Create a care environment that supports students affected by trauma."
