- ✓ To Colorado Partners in School Safety: Please read the attached letter Safe2Tell sent to your school superintendents and learn how to continue to offer Safe2Tell to your students, parents and teachers.
 - On behalf of Safe2Tell and the Colorado Attorney General's office, Susan Payne is urging you to partner with them to make it Safe2Tell for all Colorado children. Safe2Tell has been recognized on the national and international level as a model strategy that demonstrates the ability to focus on prevention and early intervention through collaboration and partnership. Safe2tell provides education and awareness along with accountability and follow up on each and every report. Safe2Tell is anonymous through the "Safe2Tell" law in Colorado. Safe2Tell provides the anonymous, encrypted two-way dialogue, the technology to capture and disperse the information obtained; while providing a phone line that does not have caller id and will always be answered live 24 hours a day/ 7days a week by trained communication specialists.

Colorado Children & Youth Information Sharing Collaborative (CCYIS) and the Colorado Statewide Information Sharing Initiative

- ✓ The Colorado Statewide Information Sharing Initiative now has a newsletter highlighting the efforts and accomplishments of the State of Colorado's Information Sharing Initiatives. It highlights State efforts but focuses on children, youth and family initiatives involved with the Colorado Children & Youth Information Sharing Collaborative (CCYIS).
- ✓ The Colorado School Safety Resource Center has been involved in these efforts also. As part of its mission, the CSSRC advisory board identified information sharing for school and public safety as one area needing further study and planning. An information sharing work group was designated by the CSSRC in May 2009 to determine the barriers to and facilitate adoption and implementation of interagency information sharing agreements between local jurisdictions and school districts as outlined in HB 00-1119 and SB 00-133. This work group includes multidisciplinary participation and receives input and information from other agencies and efforts to examine school and public safety issues.

√ Trends in High School Dropout and Completion Rates in the United States: 1972–2008",
The National Center for Education Statistics

A <u>report</u> that provides high school dropout and completion rates in the United States between 1972 and 2008. Data also present students' age, sex, and race/ethnicity, and the rates of on-time graduation from high school.
