GRANT INFORMATION

Readiness and Emergency Management for Schools (REMS) grant- U.S. Department of Education, Office of Safe and Drug-Free Schools has been announced. Application deadline is February 26, 2010. Please see the U.S. Department of Education website for details http://www.ed.gov/programs/dvpemergencyresponse/index.html

Last year this federal grant program funded approximately one-third of the applications received with monetary awards from \$100,000 to over \$700,000 for school safety planning, training and some equipment. Districts are urged to either apply individually or as part of your BOCES. In the past, fourteen Colorado school districts have received this grant. The Colorado School Safety Resource Center is not able to complete the grant applications for your district but we are here to assist. Please contact us.

Building Excellent Schools Today (BEST) program Grant managed by the Colorado Department of Education is announced. Applications are due by 4 p.m. Friday, April 9, 2010. The BEST legislation increases the level of financial assistance provided to school districts, charter schools and Board of Cooperative Educational Services (BOCES) for capital construction projects, particularly in those school districts that can't afford to meet their own needs.

Are you aware of Project School Emergency Response to Violence (SERV) - U.S. Department of Education, Office of Safe and Drug-Free Schools? If ever needed, this grant program funds short-term and long-term education-related services for local educational agencies (LEAs) and higher education institutions (HEIs) to help them recover from a violent or traumatic event in which the learning environment has been disrupted. Generally, Immediate Services assistance covers up to 60 days from the date of the incident. Extended Services assistance covers up to one year from the incident.
