COPS Office Secure Our Schools Program Funding Available

- ❖ Program Goals: The Secure Our Schools program encourages law enforcement agencies and school districts to partner together to improve school security and safety. Through this program, applicants may request funding for the placement and use of deterrent measures such as new equipment, technology, training, and assessments at schools and on school grounds. The FY 2010 program is placing a greater focus on school safety assessments.
- ❖ Application Deadline: There will be two deadlines for the FY 2010 Secure Our Schools program. The deadline for priority consideration will be <u>June 21, 2010</u>, and the second and final deadline will be <u>July</u> 2, 2010.

New Data and Statistical Resources for Safe Schools posted

- ❖ Youth Risk Behavior Survey Results 2009 (released June 3, 2010). The YRBSS includes a national school-based survey conducted by the Centers for Disease Control and Prevention (CDC) and state, territorial, tribal, and local surveys. The 2009 report includes national data and data from surveys conducted in 42 states and 20 large urban school districts. These surveys monitor health risk behaviors including unintentional injuries and violence; tobacco, alcohol, and other drug use; sexual behaviors that contribute to unintended pregnancy and sexually transmitted diseases, including HIV infection; unhealthy dietary behaviors; and physical inactivity.
