## **Solution** Expelled and At-Risk Student Services (EARSS) Grant Program

- Applications due April 9, 2012
- At the <u>Colorado Department of Education</u> (CDE)
- The program exists to assist school districts in meeting their statutory obligations to:
  - 1. Identify students at risk of suspension or expulsion and provide them with a plan to provide the necessary support services to help them avoid expulsion, and work with parents or guardians to provide the services. The district may provide services through agreements with appropriate local and state governmental agencies, community-based organizations, and institutions of higher education.
  - 2. Provide alternative educational services, agreed to by parents, to expelled students which may be provided directly or in cooperation with one or more other school districts, boards of cooperative services, charter schools, and non-public, non-parochial schools.
  - 3. Develop plans to assist habitual truants to remain in school and to work with families regarding their child's attendance.

- What are Districts' Written Policies Regarding Student Substance-Related Incidents?
  - A new report from the <u>Institute of Education Sciences</u>.
  - Recent events have increased interest in district policies relating to substance use and whether they best serve the needs of their communities and students. News stories and research reviews have highlighted the potential negative academic and emotional consequences of long suspensions from school or transfers to new

schools resulting from "zero tolerance" rules ushered in over the last decade for students found to be in possession of, under the influence of, or distributing alcohol or drugs.

- To better understand the nature of substance-related discipline rules and guidelines that may be in use around the country, this study examines the features of the written substance-related policies for the 100 largest school districts. The study was conducted by RMC Research Corporation.

  - This user-friendly resource aimed at a 4<sup>th</sup>-6<sup>th</sup> grade reading level allows visitors to:
    - Learn the science behind how drugs affect bodies and brains.
    - Hear audio versions of each page while seeing embedded highlighting of the words being read.
    - View engaging videos about drug abuse and addiction, including: "Why Are Drugs So Hard to Quit?" and "Anyone Can Become Addicted to Drugs." For youth who live in high-risk communities, eliminating all potential risks for gang affiliation may be difficult. This research shows the potential value in increasing just a few key protective factors to help prevent youth from joining gangs.
