#### **CURRENT GRANT OPPORTUNITIES**

#### The Expelled and At-Risk Student Services (EARSS) - Truancy Reduction Planning Grant Request for Proposal (RFP) is now available.

- The purpose of this grant is to support district planning efforts to employ practices and research-based strategies to minimize the need for court action and the risk of detention orders against a child or parent. Planning should include collaboration with community service providers, the judicial system staff, students and family members.
   Approximately \$720,000 in funding is available for distribution. The estimated range of awards is between \$10,000 and \$35,000 for 30 to 50 awards. A simplified application will be due on Friday, October 14, 2011. Notice of award status is expected by Nov. 14<sup>th</sup>. Funds will support planning efforts between January 1 and June 30, 2012.

# ✓ Substance Abuse on School Campuses and New Information Resources from CDE

 Colorado K-12 public schools experienced a 10-year high of drug violation incidents during the 2009-10 school year and the upward trend continued during the 2010-11 school year. Annual school-by-school reports to the Colorado Department of Education defines drug violations of the Code of Conduct as "Use, possession, or sale of drugs or controlled substances on school grounds, in school vehicles, or at school activities or sanctioned events." # ✓ EPA Voluntary School Site Guidelines

- EPA has announced guidelines to help school districts and communities select environmentally healthy and safe locations for schools. The guidelines were mandated by the Energy Independence and Security Act of 2007 and were developed in consultation with other federal agencies, states, school districts, community organizations, health care professionals, and teachers, as well as environmental justice leaders and children's health and environmental groups. The guidelines provide recommendations on steps to evaluate potential environmental challenges and benefits at candidate sites. By following the recommendations in the guidelines local education agencies, tribes and states, can help provide a safe and healthy environment for children, teachers and staff.
