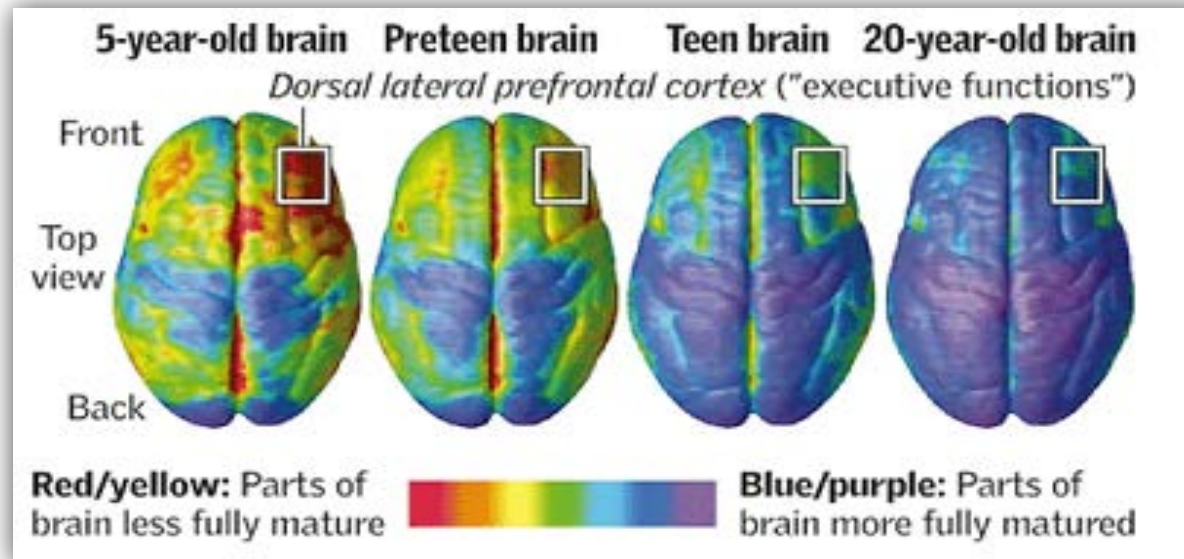

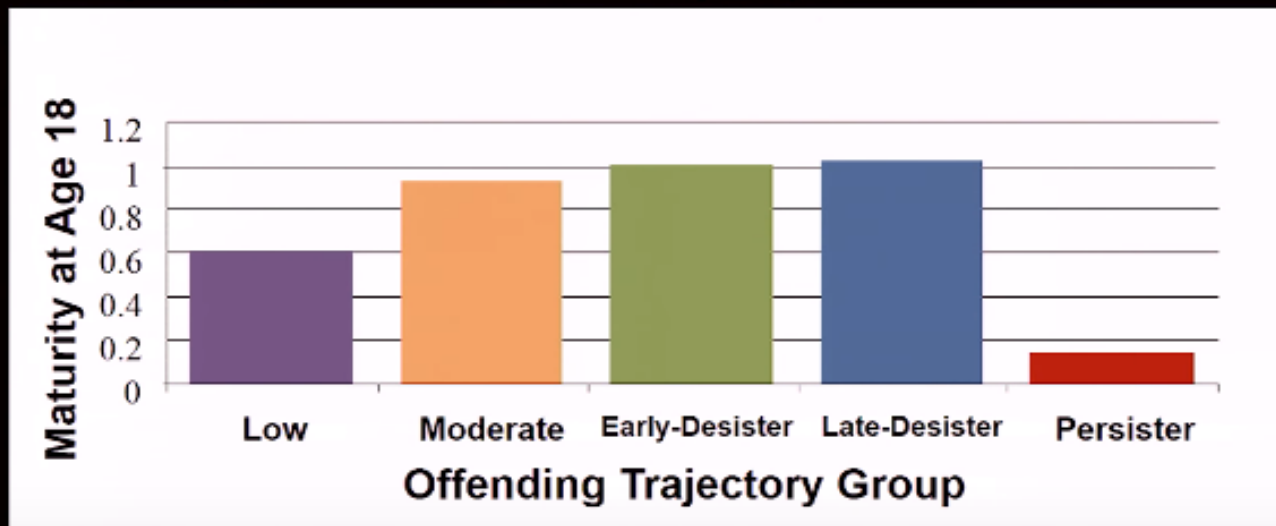
ADOLESCENT DEVELOPMENT

- Job applications
- College applications
- FAFSA
- Military entrance
- Immigration
- Housing



- School expulsion
- Extracurricular exclusion
- Labelling
- Lowered expectations & self-fulfilling prophecy
- Deepening system involvement

WHY DIVERSION?

- Early intervention, prevention, & rehabilitation
- Support meaningful accountability
- Reduce criminal risk by addressing needs and reducing collateral consequences
- Meet victims' needs
- Increase community safety

JUVENILE DIVERSION HIGHLIGHTS

- **Supervised diversion:**
 - Assessment-based case planning
 - Match services to need to drive down risk
- **Unsupervised diversion:**
 - Community-based interventions such as Public Health and RJ
 - Petty and misdemeanor theft, MIPs, and other low-level charges
- **Expanding program**
 - District Court, County Court
- **Diverting ~40% of all juvenile cases** (up from ~20% in 2013)
- **92% successful completion**, including expansion to include higher-risk/need
- **98% of offenders** say diversion was a valuable experience
- **100% of offenders** say diversion helped them make positive changes in their life

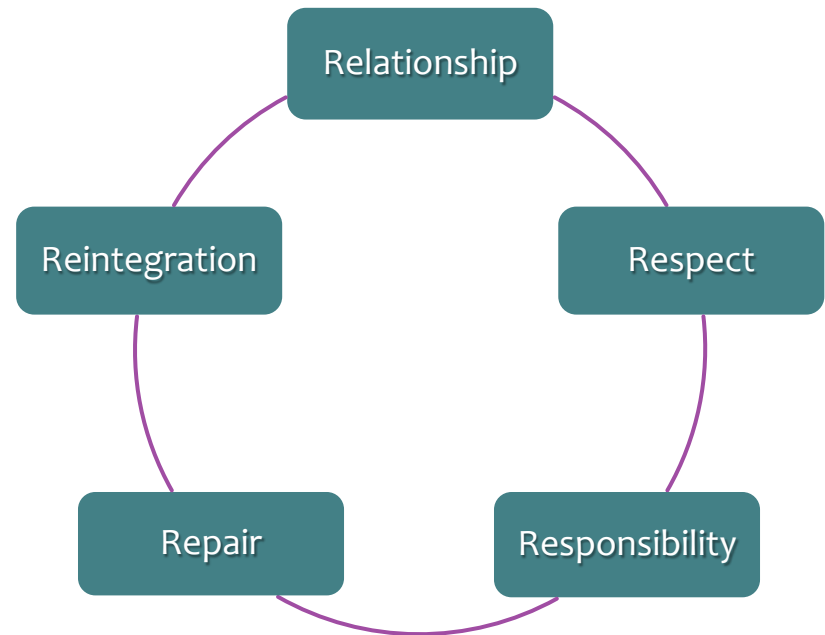

RESTORATIVE JUSTICE

- *Who was harmed?*
- *What needs to be done to repair the harm?*
- *Who is responsible for this repair?*



A **restorative justice process** brings together the people involved in the incident – the offender(s), victim(s), support people, and other community members, to decide what needs to happen to make things as right as possible after a crime has been committed.

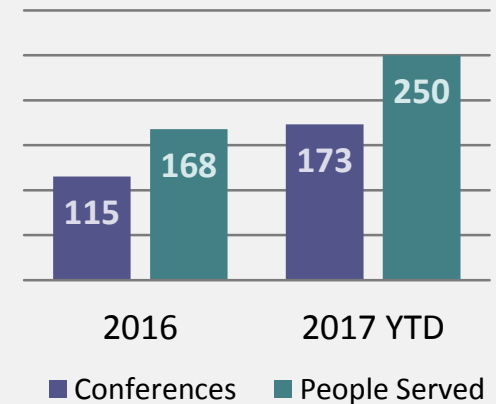
WHY RESTORATIVE JUSTICE *IN-HOUSE* ?

- **High quality RJ** with fidelity
 - Trauma-informed, victim-centered, culturally-sensitive
- **Greater equity** in service provision
- **Increased accessibility** to RJ:
 - Higher- and different-needs participants
 - Substance-related offenses
 - Complex cases
- **Victim-centered** RJ services
- Fewer contacts for participants
- **In-community** RJ services
- Recruit & utilize highly-skilled RJ practitioners state-wide
- Better **data collection**
- Ongoing program monitoring & improvement

DARJ HIGHLIGHTS

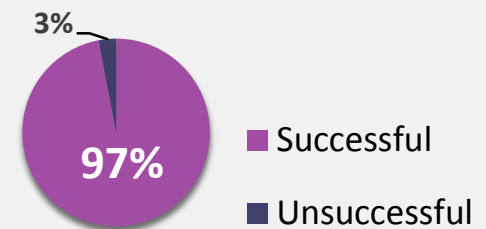
- Launched summer 2017
- **DARJ Outcomes:**
 - **97%** projected completion
 - **100%** victim satisfaction
 - **98%** of participants would recommend RJ to others
 - **100%** restitution collection for RJ agreements
- Specialized RJ model for **substance use violations**
- **Community involvement** in process of justice
- Trained, skilled, & **active volunteer base**
- **Staff expertise** in RJ program development, facilitation, training, & victim services
- **Collaboration** with community-based RJ providers

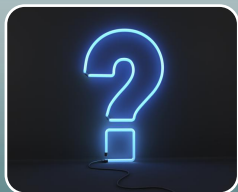

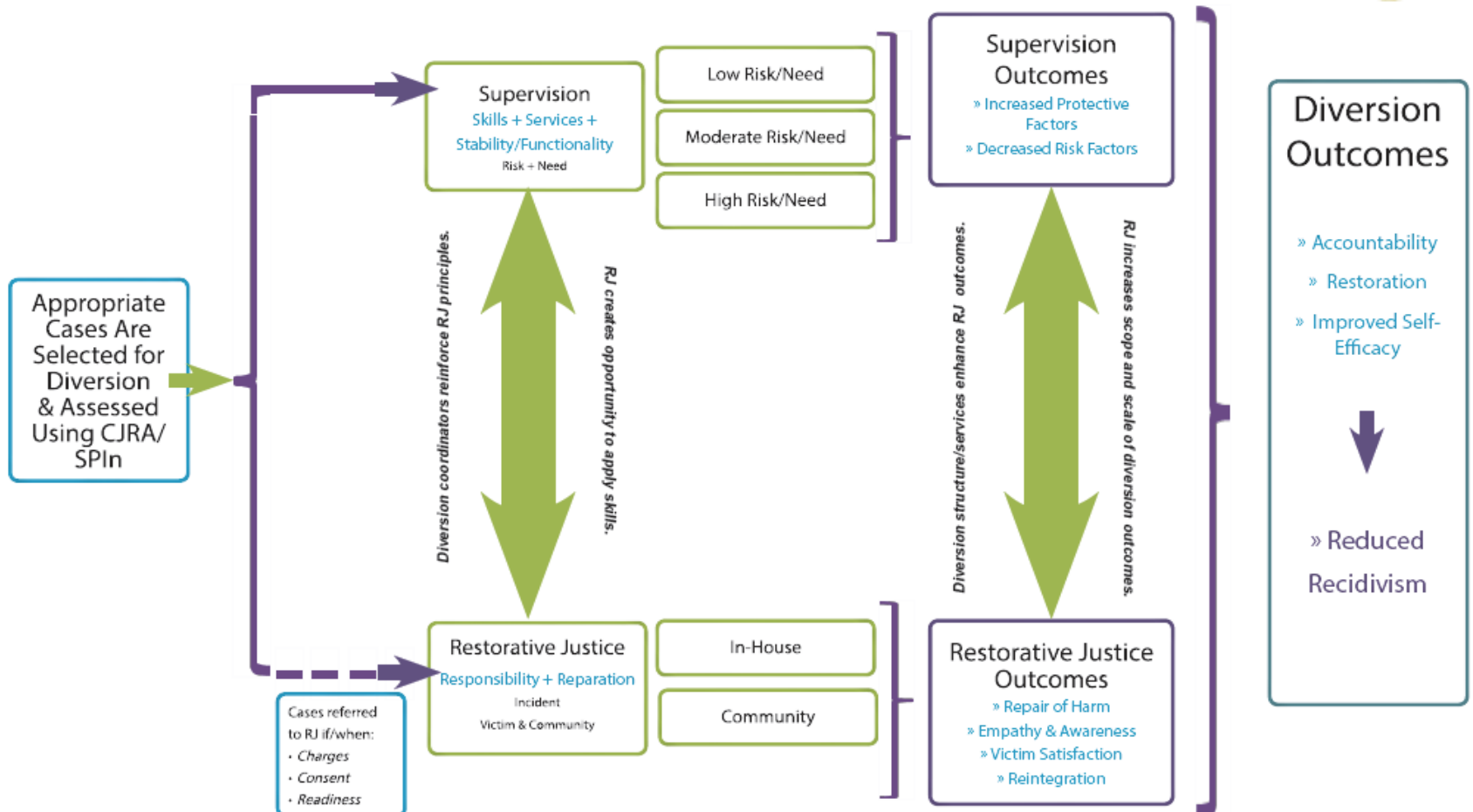

CPRJ DIVERSION PROGRAM MODEL

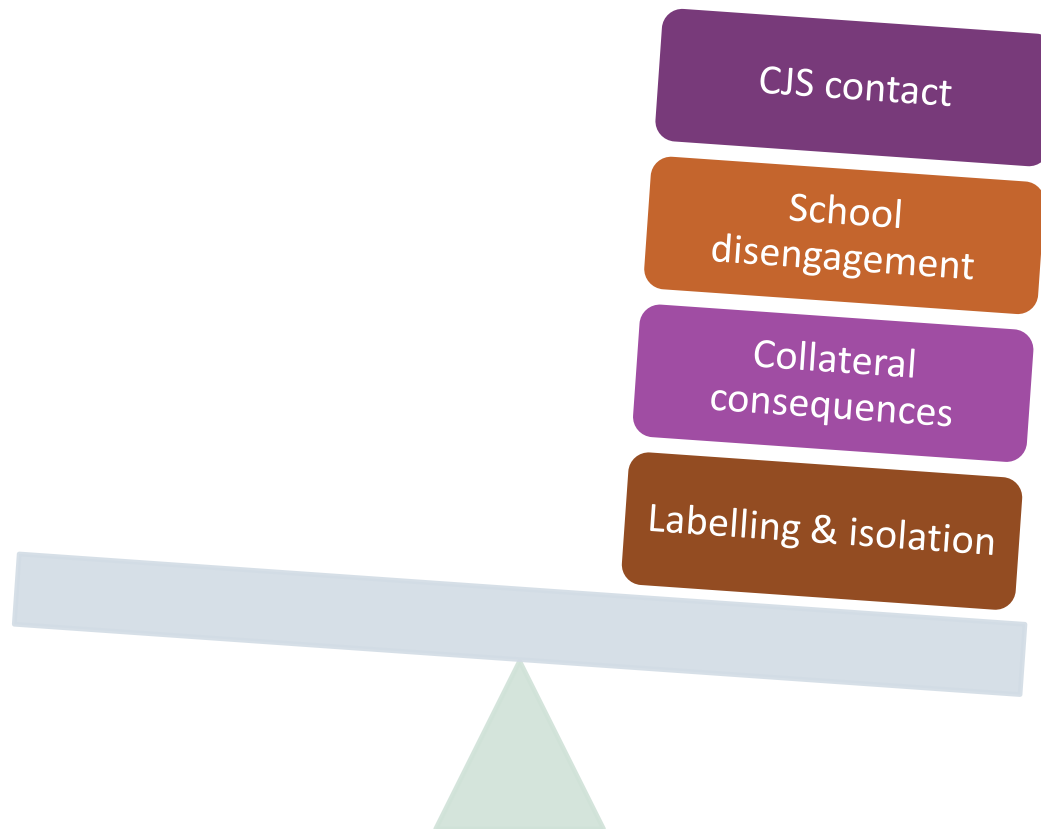


BENEFITS

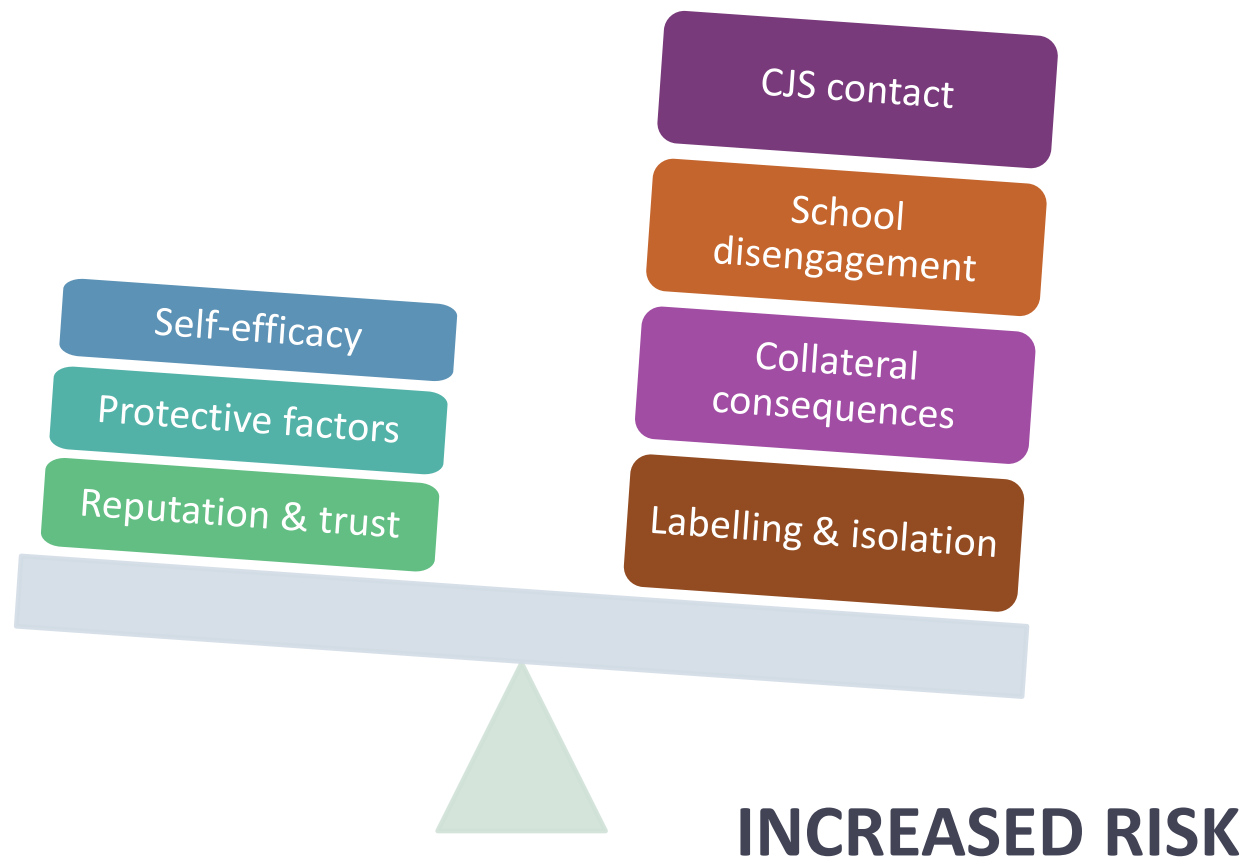
- RJ can focus on specific incident

- Greater efficiency



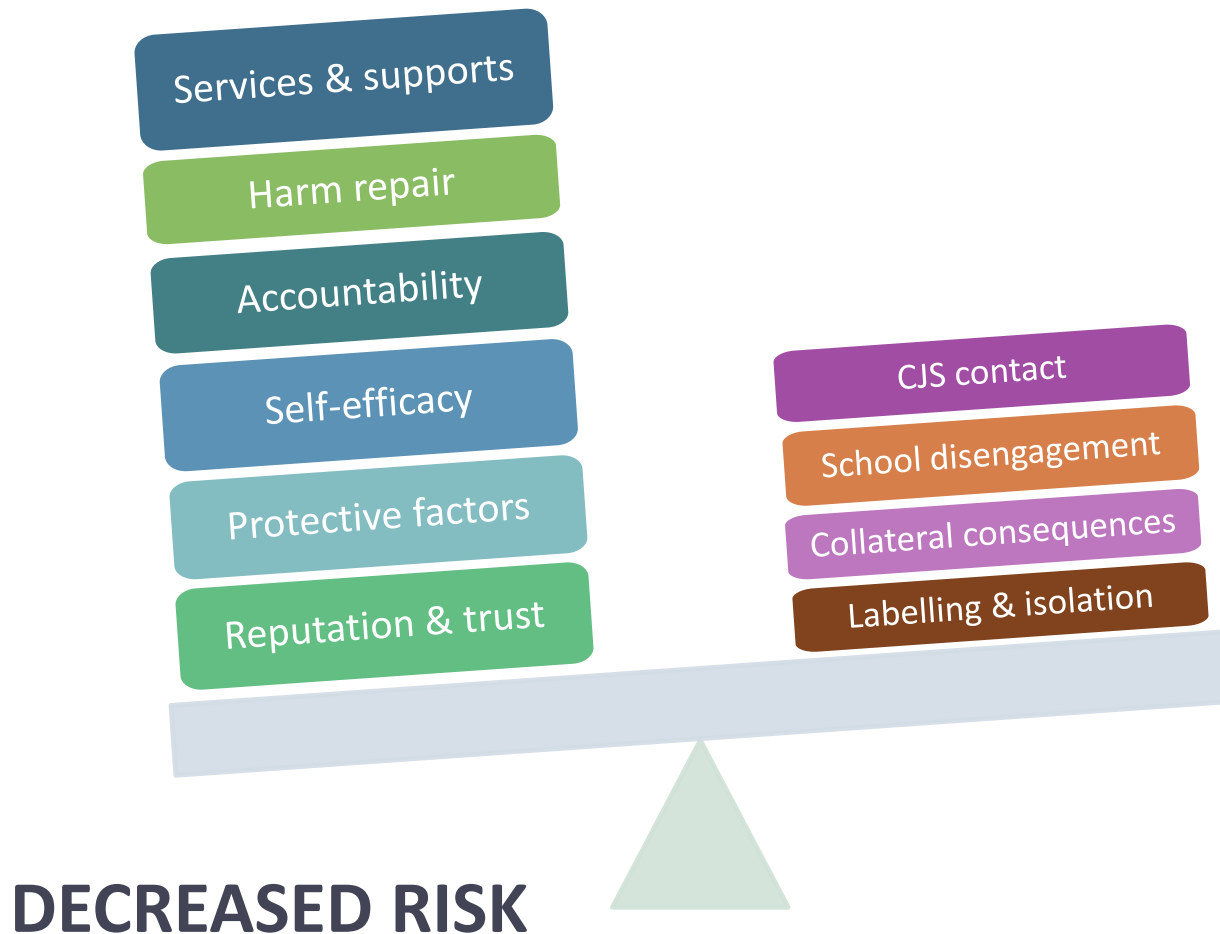

RESEARCH SHOWS...

Decreased recidivism

High levels of victim satisfaction

Increased accountability and empathy in offenders

Increased sense of procedural fairness (both victims and offenders)

Higher levels of restitution collection

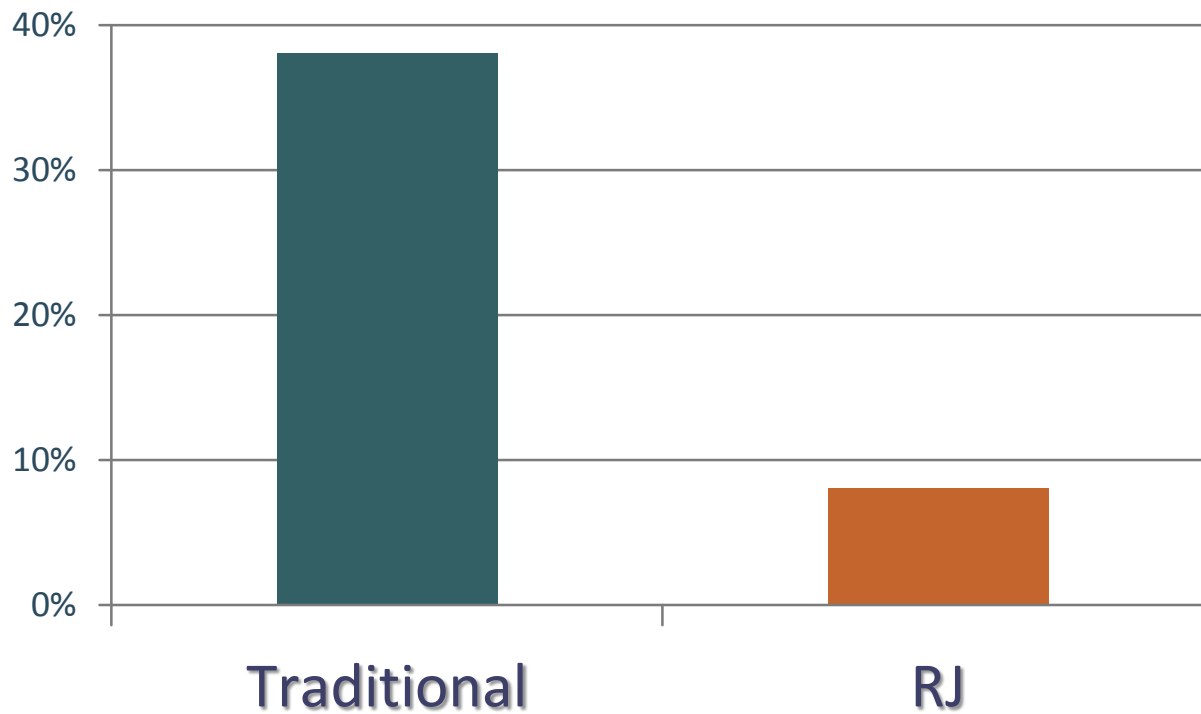

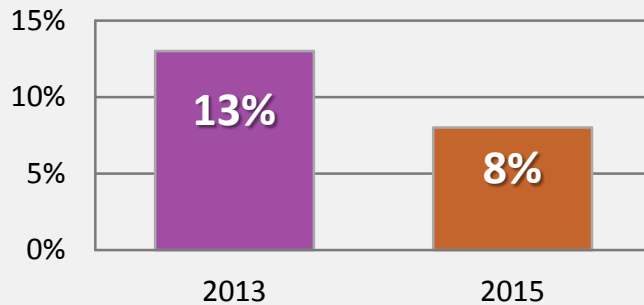

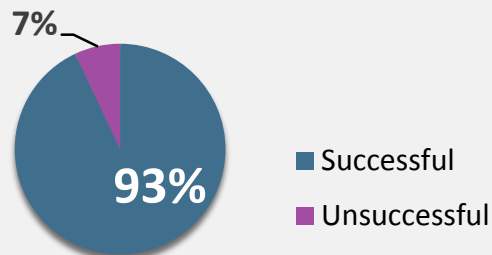

Juvenile Diversion Recidivism



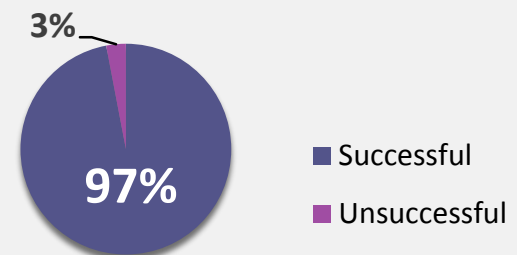
38% reduction in recidivism

(projected FY15-FY17)



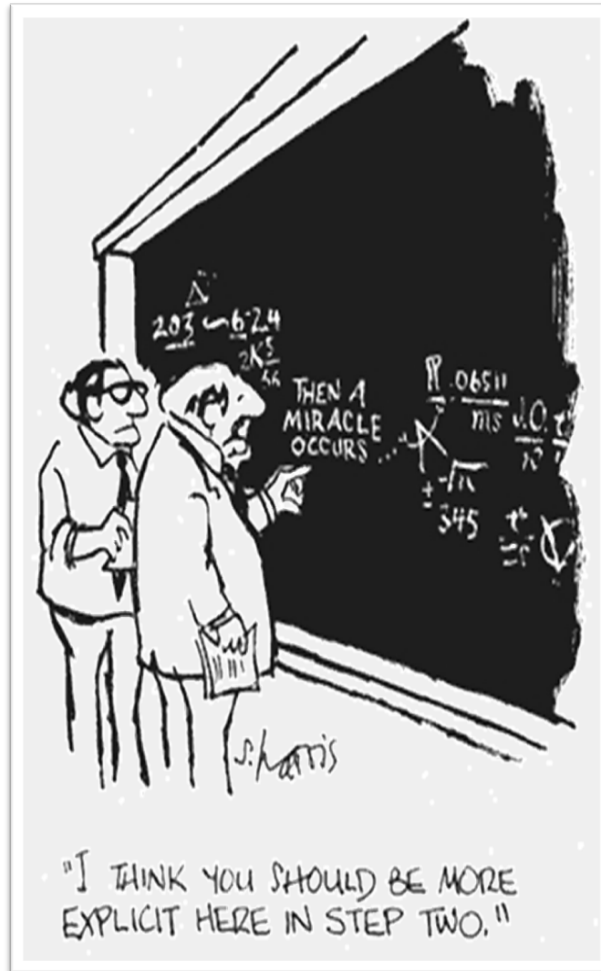
PARTICIPANT SATISFACTION

- 100% victim satisfaction with DA's Restorative Justice
- 99% community member satisfaction
- 95% diversion participant satisfaction
- 100% say RJ is a good way to handle certain offenses in their community



CHALLENGES

IMPLEMENTATION



DISCRETION

Discretion exists at all decision-making points:

- Whether to suspend or expel
- Whether to involve law enforcement
- Whether to charge
- Whether to arrest or summons
- Whether the DA files charges (and which charges)
- Whether to divert
- Plea bargaining
- Sentencing

WHAT CAN WE DO?



- **Collaborate** and communicate with schools and community organizations
- **Monitor** our program for quality, equity, and fidelity to RJ
- Institute **procedures and processes** to support quality, equity, fidelity
- Take a **county-wide approach** to increase access and equity to interventions like diversion and RJ
- **“Do the right thing”**

SCHOOL + DA PARTNERSHIP

Diversion

- Communication with school personnel
- Monitor attendance & grades
- Support problem-solving, decision-making, goal-setting
- Improve school engagement, pro-socials, & extracurriculars
- Connection with mentoring and other supports as indicated

Restorative Justice

- Participation in RJ process – SROs, teachers, Principals and APs, coaches, counselors, and others
- Impact statements
- Input for steps young person can take to repair harm from incident
- Reintegration into school community
- Reputation repair (self & school)

SCHOOL + DA PARTNERSHIP

- **71%** of DARJ conferences for school-based incidents involved school admin, SROs, teachers, or other representatives
