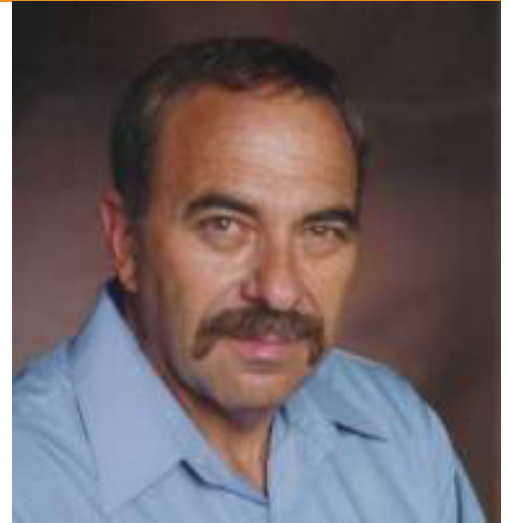

## Morning and Final Keynote: Dr. John Nicoletti

**Dr. Nicoletti** will analyze the latest school attacks discussing insider vs. outsider threats and how schools can minimize vulnerabilities. He will also discuss how we thoughtfully consider student mental health issues in these latest conversations.

**John Nicoletti, PhD, ABPP** received his Ph.D. in Counseling Psychology from Colorado State University in 1972. He has since established himself as a national expert in police psychology, violence risk assessment, workplace and school violence prevention, as well as crisis intervention and trauma recovery. Dr. Nicoletti has been asked to take part in several high profile investigations, including the Columbine High School and Virginia Tech shootings.
