According to the FBI "Active shooter is a term used by law enforcement to describe a situation in which a shooting is in progress and an aspect of the crime may affect the protocols used in responding to and reacting at the scene of the incident. Unlike a defined crime, such as a murder or mass killing, the active aspect inherently implies that both law enforcement personnel and citizens have the potential to affect the outcome of the event based upon their responses." In this session you will learn how first responders handle these events today and what you can expect when they arrive to your emergency. This is a collaborative presentation from Aurora Police and Fire discussing best practices and lessons learned.

10:10 AM - 11:40 AMPlenary - Assessing the Risk: The Intersection of Stalking, Dating Violence and
Technology Misuse on College Campuses

Under the new Clery regulations, college campuses are required to have policies in place to prevent and respond to incidents of stalking on college campuses. College students experience the highest rates of stalking. Unfortunately stalking, both within the context of dating violence and as a standalone event, is often unrecognized and underreported. This session will focus on stalking prevalence, behaviors and the use of technology to stalk and assist you in enhancing your campus response to stalking.

a. Making Campus Safer: BIT, Case Management and Mitigating Risk

Hans Foote, University of Colorado, Boulder

At CU Boulder they have had an active BIT for over 6 years. This session will cover some of the lessons they have learned. How they have developed a strong BIT, use of structured professional judgement, selecting a threat assessment tool, integrating case management, using the risk rubric from the National Behavioral Intervention Team Association (NaBITA) to classify, track and prioritized cases; and half-day BIT retreats 2-3 times a year are just some of the important lessons that will be discussed.

b. Community Resilience to Violent Extremism in Colorado,

Amanda Rocque, Deputy Civil Chief, U.S. Attorney's Office for the District of Colorado

This presentation will focus on all forms of violent extremism, ranging from groups inspired by international terrorism to homegrown domestic violent extremists. We will discuss the different extremist threats facing Colorado today, how violent extremist groups recruit and radicalize individuals, and steps that communities, schools, and law enforcement can take to prevent violent extremism.

c. Investigation of Campus Stalking: Considerations for Safety

Jennifer Landhuis, National Stalking Resource Center

The traditional campus investigation paradigm is to investigate crimes as incident-based complaints that exist within their own singular set of circumstances. Stalking cases can present a challenge to this as stalking is a course of conduct crime comprised of a series of events that, in and of themselves, are often not illegal or against campus policy. This session will explore the challenges and opportunities for building stalking cases by focusing on investigative strategies and responses that put victim safety at the center. Participants will learn how to identify stalking behaviors and place them in the proper context, with an emphasis on gathering corroborating evidence including technology based evidence.

d. From the Quad to the Courtroom--Campus Sexual Assault Cases in a Post-Title IX Era

Nicole Leon, Project Director, Denver's Sexual Assault Interagency Council & Det. Laura Franklin, Denver Police Dept.

While Title IX has existed for decades, the 2011 "Dear Colleague" letter and subsequent federal clarification of the law, sensationalized media coverage and the Office for Civil Rights investigations that followed have drastically shifted how higher education institutions respond to sexual violence on campus. As campus survivors can pursue reporting options through both the criminal justice system and their campus Title IX office, the result is often concurrent investigations through both processes, which creates unique challenges that can sometimes hinder or compromise a criminal case. This workshop will discuss challenges arising for communities in instances of co-occurring criminal and Title IX investigations and will highlight the Sexual Assault Interagency Council (SAIC), a multidisciplinary collaborative dedicated to improving the response to sexual assault in Denver, and their efforts to work collaboratively with campuses to promote a victim-centered response and ensure the integrity of both criminal and Title IX cases. Presenters will share case study examples and concrete steps communities can take to develop relationships and address challenges, as well as share promising practices.

2:00 PM – 3:30 PM Plenary – Jared Loughner: A Threat Assessment Case Study and Lessons Learned Manuel "Manny" Amado, Director of Public Safety - Regis University

This presentation will cover events and behavior displayed by Jared Loughner while a Pima student that was observed and addressed by college officials leading up to his suspension from Pima Community College. Approximately three months after his suspension, Jared Loughner opened fire at a Tucson, Arizona, Safeway supermarket killing six people and injuring 13 others including Congresswoman Gabrielle Giffords. This tragic event garnered national attention. The College also came under scrutiny and criticism for allegedly not doing enough to prevent the shooting. This presentation is meant to clarify information as well as give a firsthand view as to the threat assessment process leading up to Loughner's suspension.
