

Sex Offense Working Group / CCJJ: Comprehensive Sentencing Task Force

Initial meeting: Wednesday, June 12th, 1:30-4:30pm, HMF Law offices

(Tentatively scheduled for the Wednesday of every month that precedes the CCJJ meeting/usually the 2nd Wed.)

Charge: During the January 2013 Commission on Criminal and Juvenile Justice Meeting, the Commission established priority areas of study for the coming year. One of the priority areas identified during this meeting centered on three specific issues regarding sex offenses and sex offenders in Colorado. The intent of this study is limited in scope to the areas identified below:

1. Indeterminate vs. Determinate – Review the potential for creating a new determinate F4 Offense
2. Lifetime Supervision – Explore the possibility of creating a remedy whereby an offender may work their way through successful supervision and be eligible to be removed from lifetime supervision.
3. If a new F4 felony is created with a determinate sentencing structure – assess the impact of this statutory change on the need for and availability of additional sex offender specific treatment both in the department of corrections as well as in the community.
