Prevention Working Group

Action

Present Recommendation to Drug Task Force in February for vote.

Discussion:

Carmelita Muniz gave an update from the Prevention Working Group. They were asked to rework some of their recommendations. The recommendations proposed last month by the Prevention Working Group involved data collection at the state and local level; community prevention through community collaborative 1451 programs; and standards to the Juvenile Assessment Centers. The Prevention Working Group felt its priority should be the issue of data collection.

Recommendation: Invest in both state and local level data collection, analysis and reporting using the Healthy Kids Colorado Survey to support trend and gap analysis, resource allocation and community level planning and programming efforts.

- 1. The Healthy Kids survey is the result of over 14 years of work to coordinate and integrate school survey efforts in the state.
- 2. Contains the Center for Disease Control's Youth Risk Behavior Survey
- 3. Includes substance use/abuse, access to drug/alcohol, mental health, nutrition and physical activity, sexual behavior and scales predictive of risky behaviors.
- 4. Survey is administered to schools throughout the state in two ways: State and local levels.
- 5. State estimates are used to monitor trends over time and to detect newly emerging patterns in health and risk behavior, including substance use. Using the trends helps providers know what programs are important and where they would be useful.
- 6. The survey is conducted every two years. It was done in 2011 and will be done 2013.
- 7. Cost of the survey is \$392,747. \$142,000 has been raised through block grants and through local communities and schools.
- 8. There is no dedicated funding source for these funds. Can the Task Force

	forward a recommendation on to the CCJJ without the funding piece?
