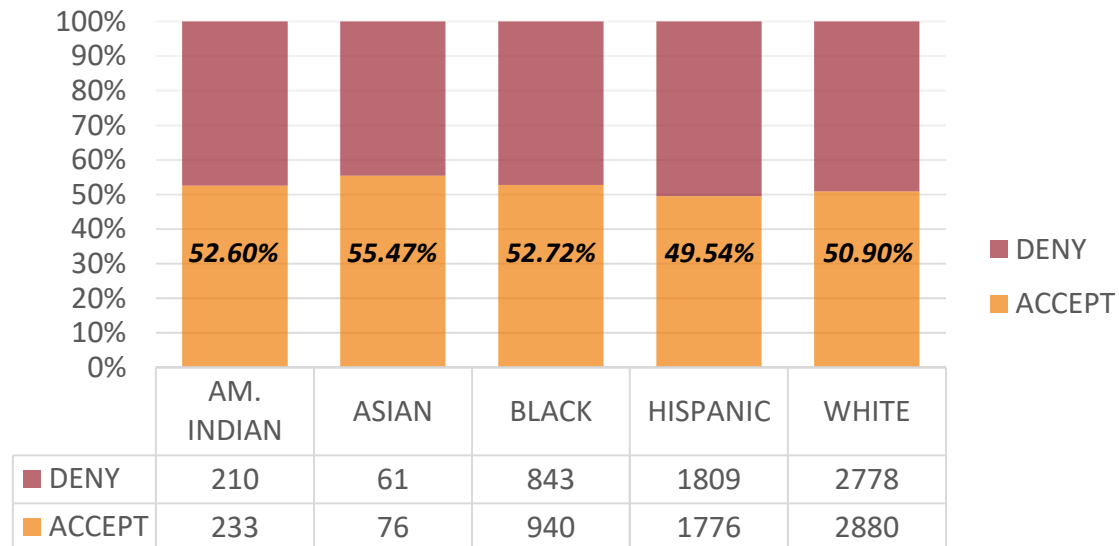

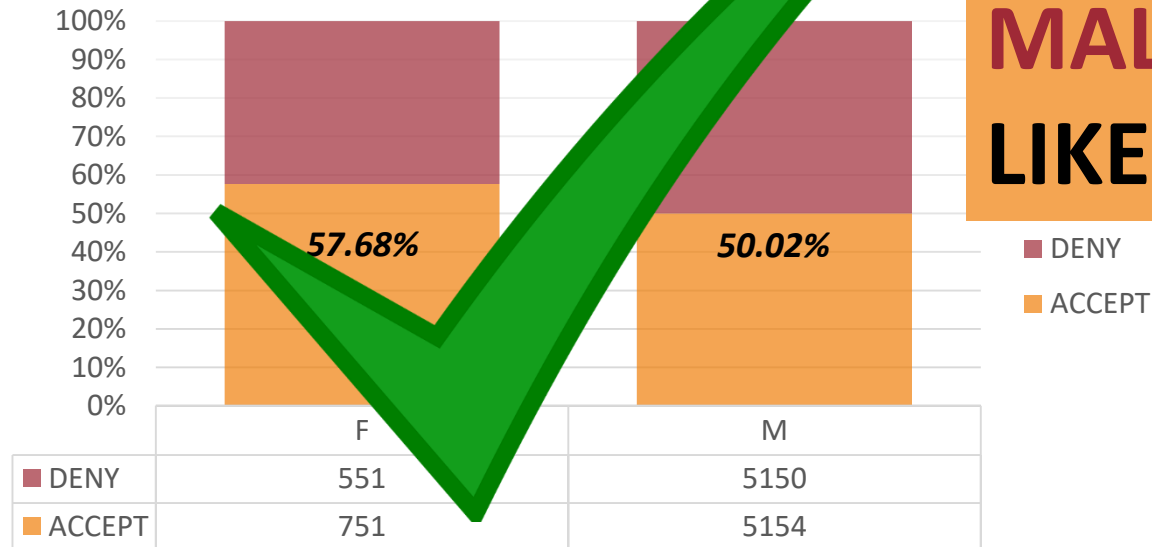

Gender Impact - SIGNIFICANT?

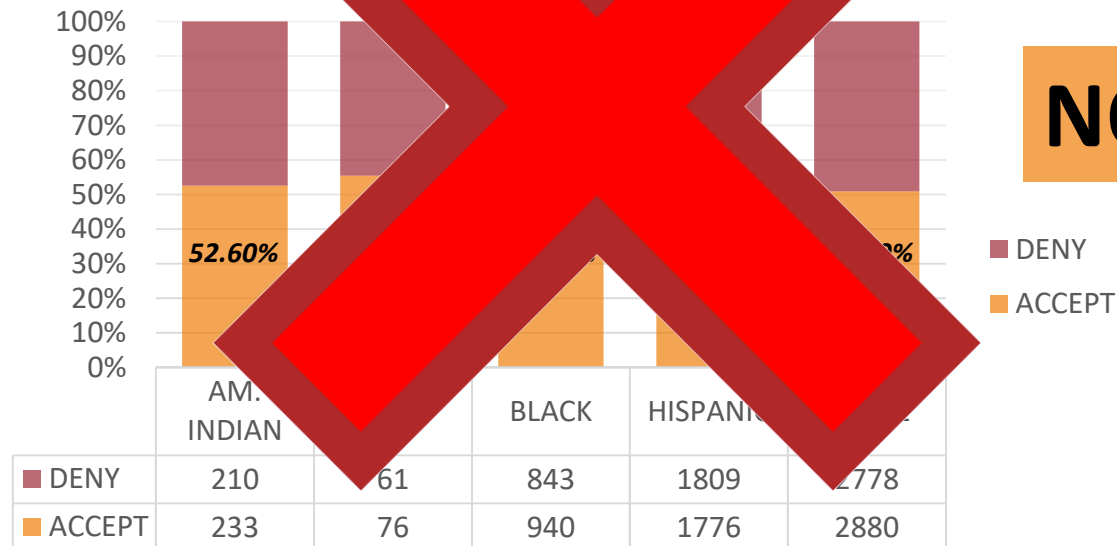

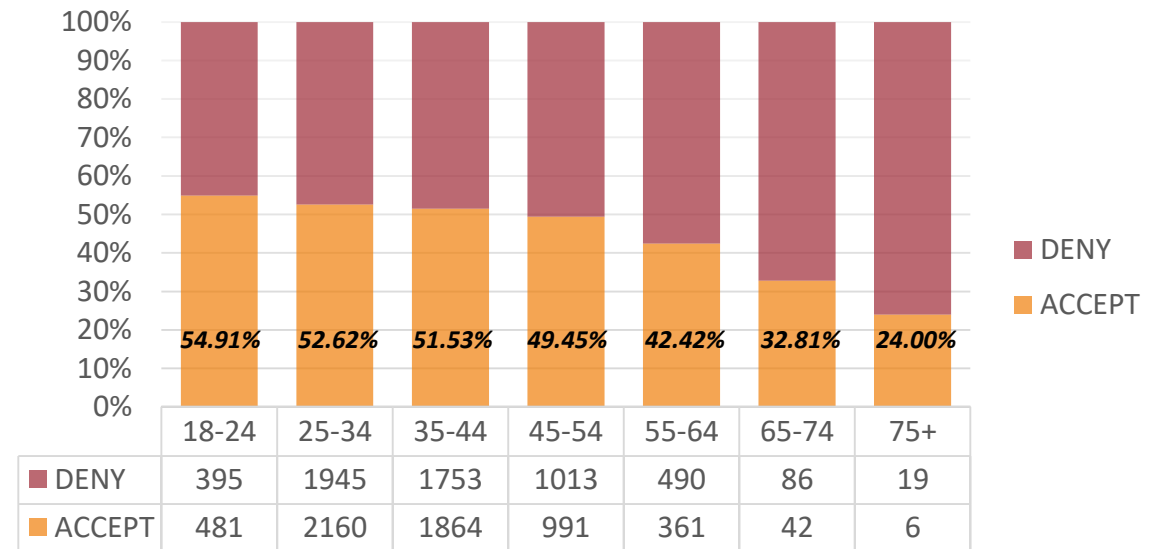

 - Total Accept decisions: 5,948 (50.8%)
 - Total Deny decisions: 5,753 (49.2%)

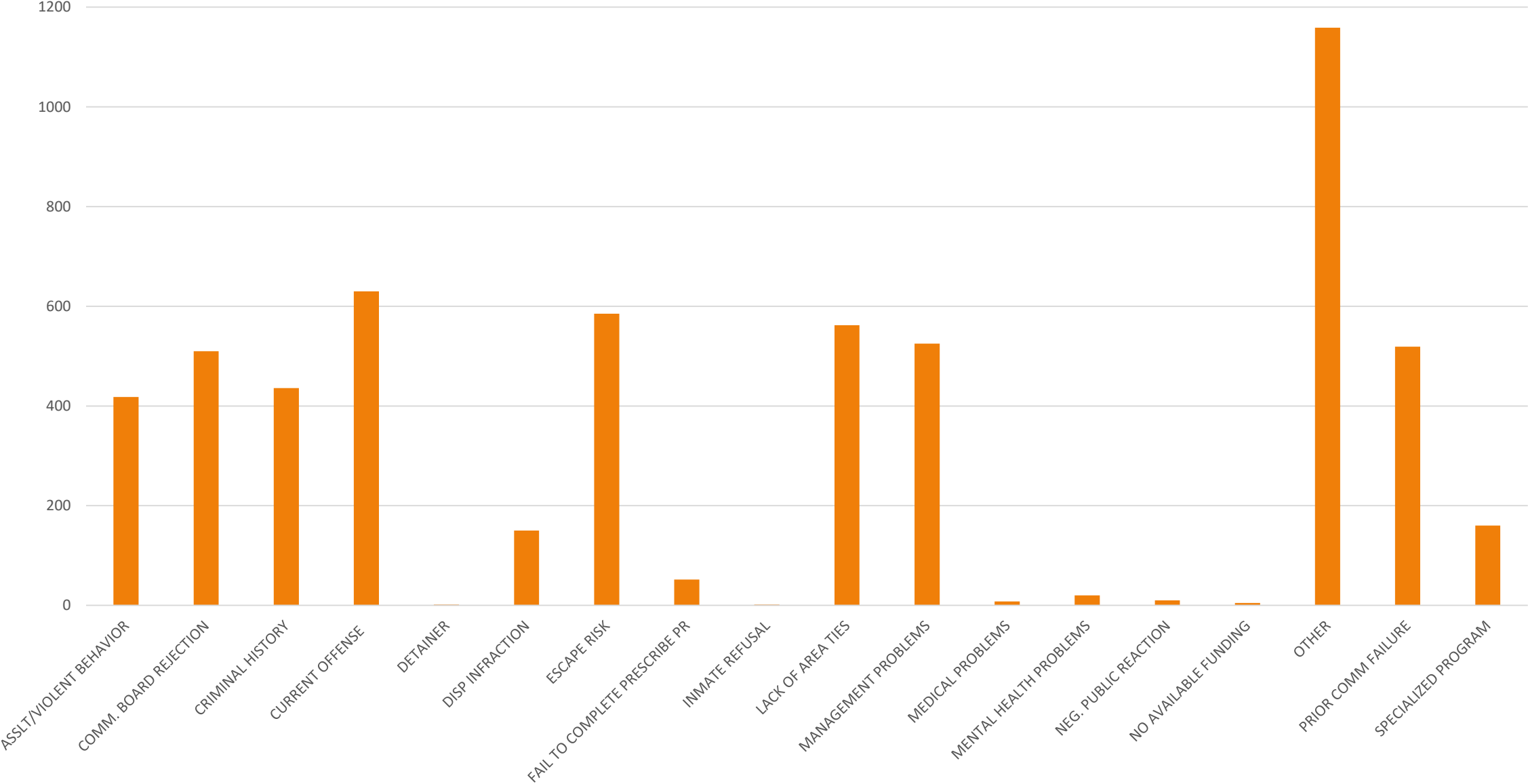
Citizenship Q&A

Q: How does the number of referrals *Not of US Citizenship* to community corrections compare to referrals of US Citizenship?

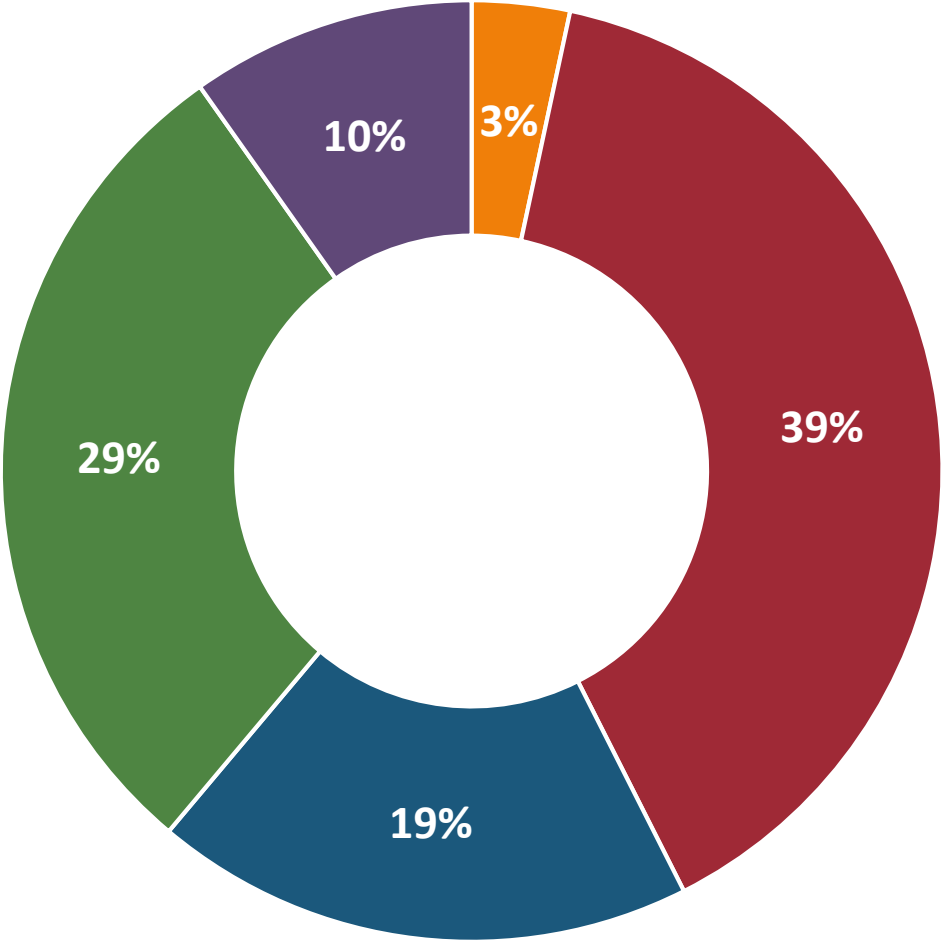
A: Foreign born offenders make up only slightly more than 7% of CDOC population, and those with detainers (indicating possibly undocumented) about 4%.

In FY20, *Not of US Citizenship* made up 2.1% of total individuals referred (100 / 4,834)

All Denial Reasons, N=5753



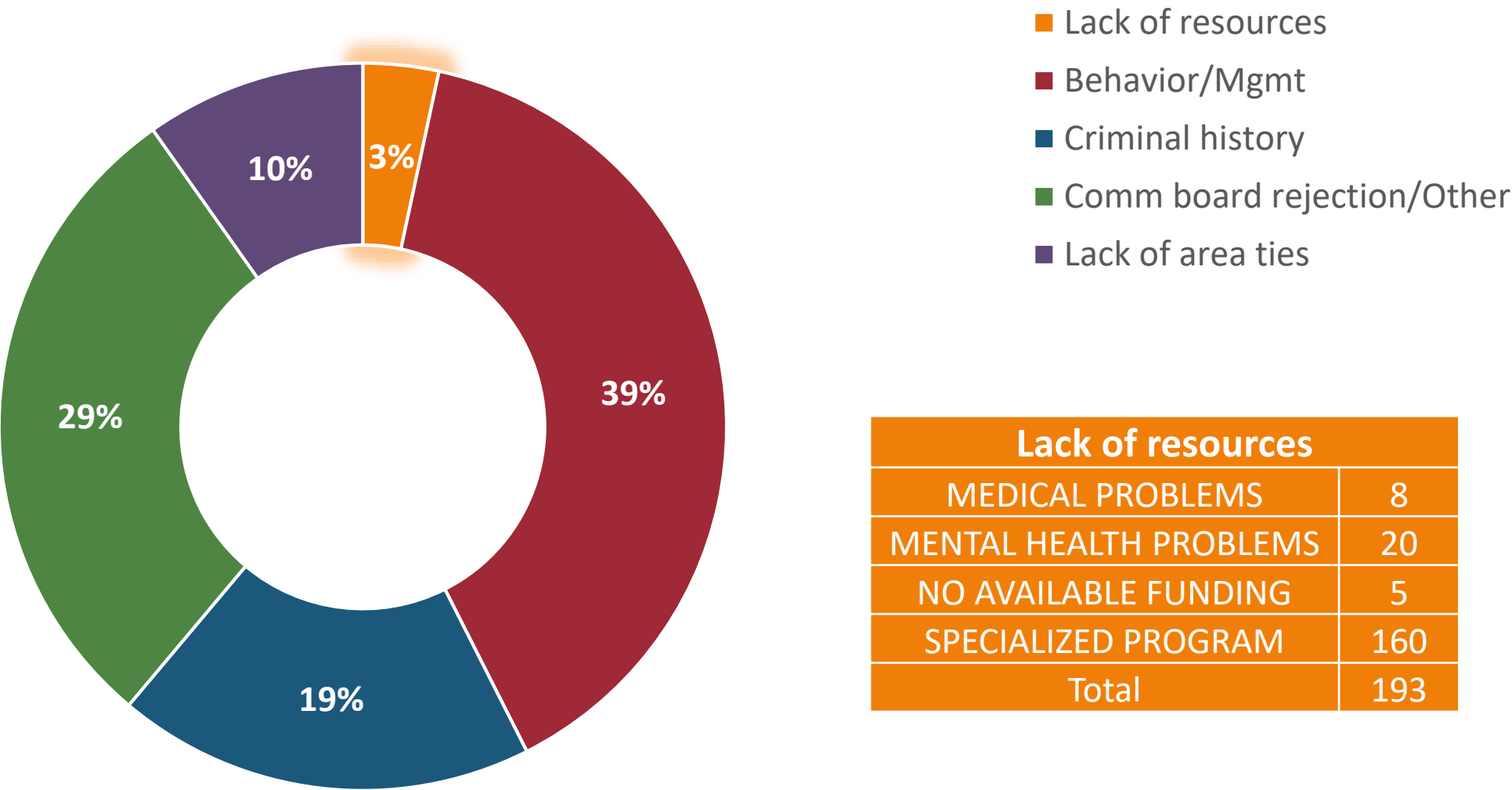

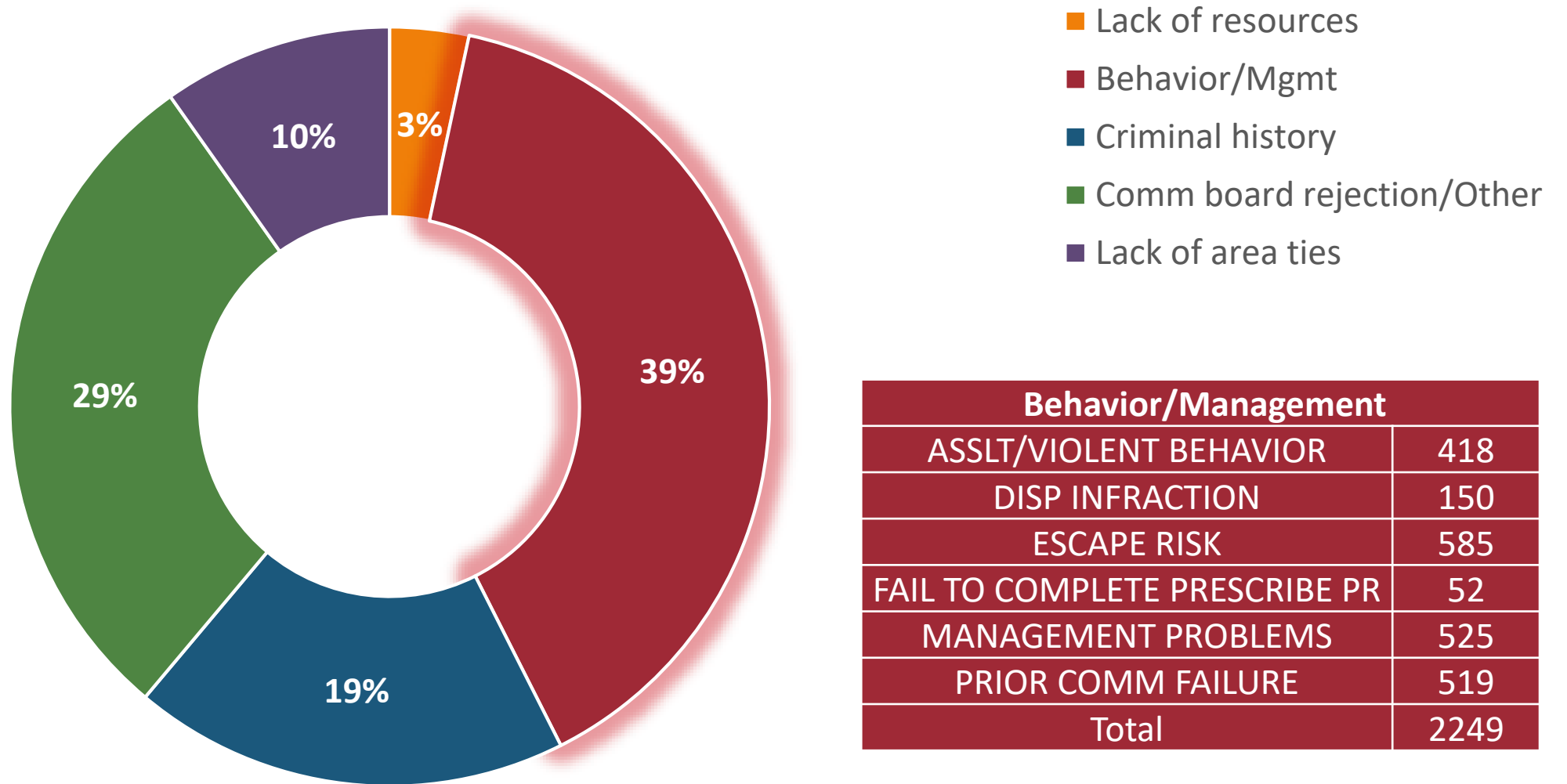

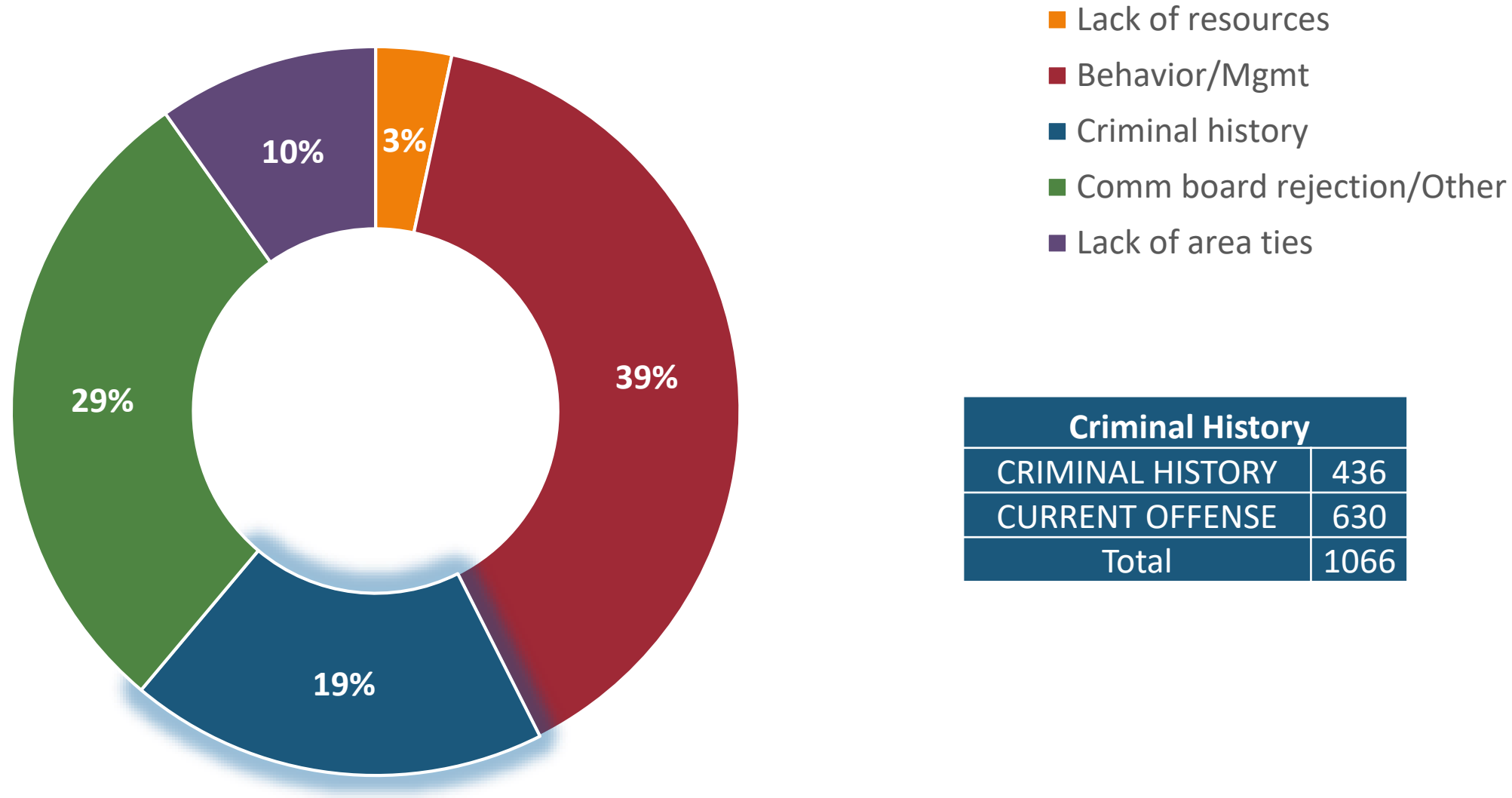

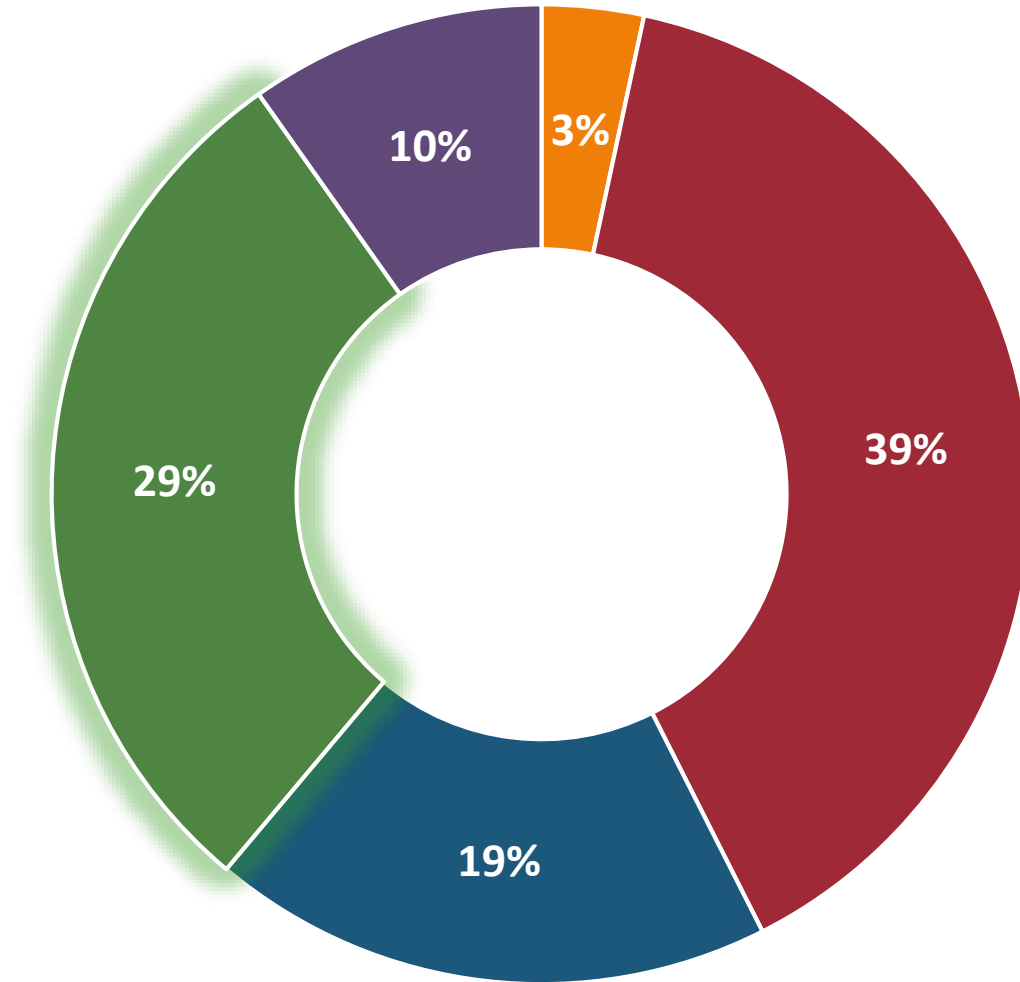

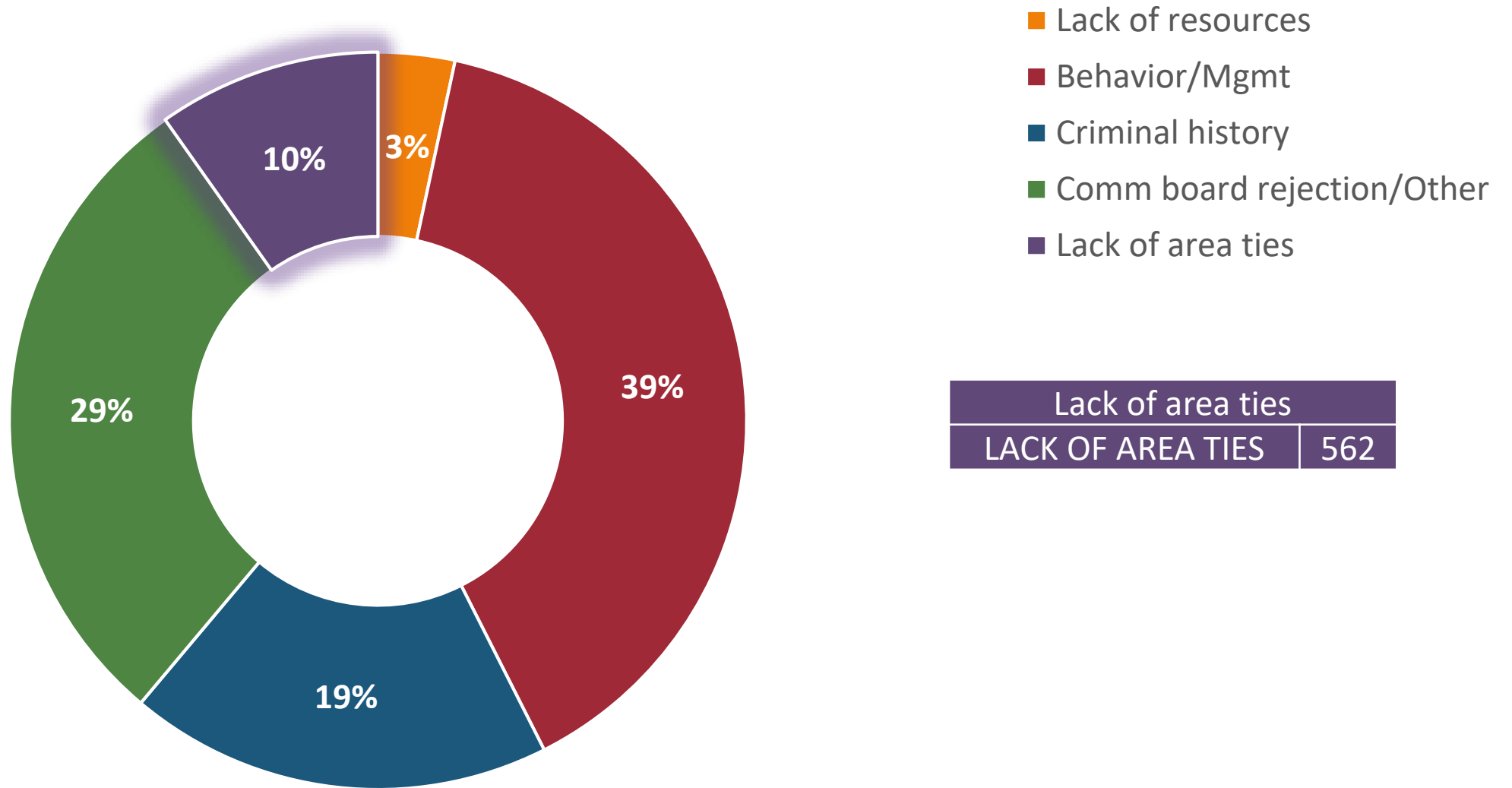

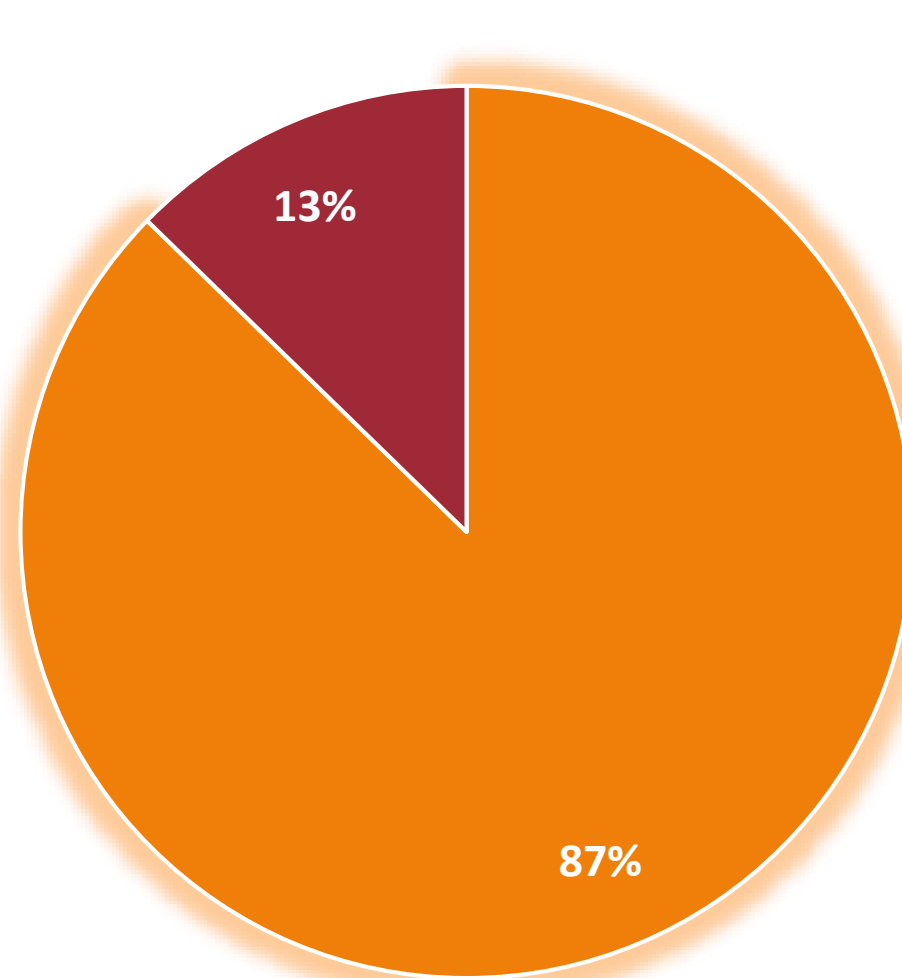

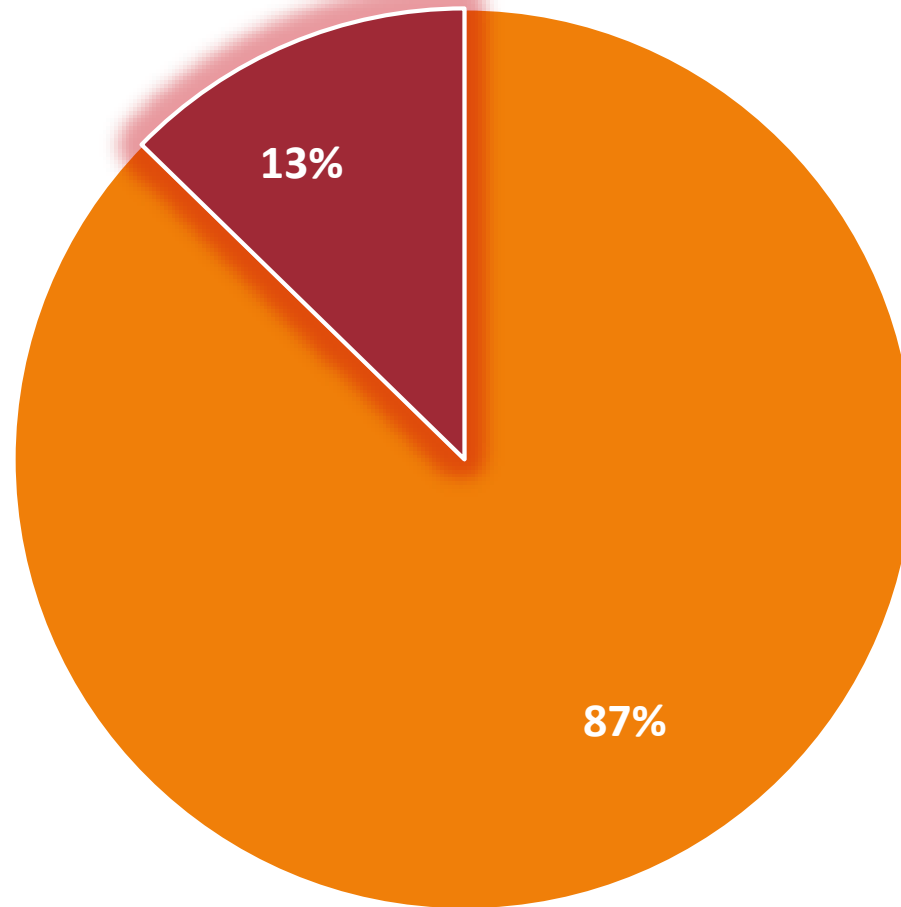
