

# The Juvenile Justice Task Force: Background and Remaining Tasks

#### Legislative Origins

- The Colorado Commission on Criminal and Juvenile Justice.
- The Legislators mandated the Commission to work on juvenile issues 16-11.3-101(h) and 16-11.3-103(e).

#### **Commission Directives**

- August 2010 the Commission created a Juvenile Justice Task Force.
- The Commission directed the Task Force to work on certain issues including the Children's Code.

# Work Identified by the Commission

- Children's Code
- Information sharing
- Statewide inconsistencies
- Disproportionate minority contact
- Truancy
- Training and education
- Prevention and intervention
- Clarify and streamline services and funding

# Work History of the Task Force

- March 2011 held 2-day retreat to identify problem areas in juvenile justice system.
- Finalized a mission, vision, and guiding principles to fulfill CCJJ directive. Presented to CCJJ in March, 2012.
- Formed work groups to work on problem areas identified in retreat: Education, Judicial and Assessments.

#### Work Accomplishments

- FY12-JJ#1 Educational materials provided to juvenile detention facilities.
- FY13-JJ#1 Amended Department of Education rules regarding age restrictions for GED.
- FY13-JJ#2 Revised enforcement of Compulsory School attendance statue to address issues including the definition of absence, policies and procedures regarding attendance, identification of at-risk students, truancy charges, and parental roles.

# Work Accomplishments continued

- FY13-JJ#3 Revised Sex Offender Deregistration Statute to allow a person who *committed* an offense while under 18 years of age to deregister as an adult after successful completion of the terms of the sentence.
- FY13-JJ#4 Revised Escape statute to provide that an adjudicated juvenile who turns 18 while in custody, not in a state-operated facility, commits a misdemeanor 3 rather than a felony if convicted.
- Revised statewide Juvenile Screening and Assessment Guide.

#### Work Accomplishments continued

- FY15-JJ#1 Create a petty ticket option for law enforcement as an alternative to formal proceedings.
- FY15-JJ#3 Create first steps to provide for statewide standards of professionalism throughout the juvenile justice system.

- ✓ Clarify services and funding streams.
