Internal Policy/Procedure
Majority Threshold
Approve: When the total of "A" votes is ≈ 51%.
Disapprove: When the total of "B" votes is ≈ 51%.

Recommendation
Supermajority Threshold
Approve: When the total of "A" and "B" votes is ≈ 66%.
