# FY2010 RECOMMENDATION/FY10-D46 TRANSPARENCY OF FISCAL SAVINGS RESULTING FROM CCJJ RECOMMENDATIONS

# **Actions/Updates**

#### **2013 UPDATE**

#### 2012 ACTION/IMPLEMENTATION

This recommendation was addressed with HB 2010-1352.

As of June 2012 the Division of Behavioral Health was allocated \$1.45 for FY 2012, and \$1,819,900 for FY 2013 to helop jails screen for and provide care to inmates with substance use disorders or a co-occurring mental health disorder. In addition, programs are expected to provide continuity of care to these same inmates upon their release from incarceration. The JBBS program supports the County Sheriffs in providing screening, assessment and treatment for substance use disorders and co-occurring substance use and mental health disorders to people who need such services while they are in jail. The amounts listed below have been allocated to the following Sheriff's Departments and subcontracted providers (this information was extracted from the DBH spending plan that was distributed at the June 2012 meeting of The Interagency Advisory Committee on Correctional Treatment, or IACCT).

# **Description**

Establish a transparent mechanism to ensure that fiscal savings resulting from CCJJ recommendations are reallocated toward treatment programs.

#### **Discussion**

A transparent mechanism must be immediately established to ensure the reallocation of any fiscal savings realized from the implementation of the Commission's recommendations concerning drug and DUI law modifications. This reallocation must be directed toward expanding and sustaining evidence-based community- and jail-based treatment programs and evaluating the efficacy of these programs.
