Community Corrections Referral Reporting

Quarters 1, 2, 3 & 4 FY20

Several community corrections boards, in cooperation with the Colorado Association of Community Corrections Boards and Community Corrections Coalition, have developed a survey that captures the number of referrals, board denials, and provider denials for each jurisdiction. Recognizing that there are different screening processes in each jurisdiction, only the final decision as to whether a referral is approved or denied is recorded.

The report documents the number of referrals submitted to each Judicial District and the percent of community corrections referrals that are accepted within a Judicial District. The transition referrals, approvals, and denials include all transition referrals screened by each Judicial District, including primary, secondary and tertiary. A transition primary referral is a referral that is sent to the jurisdiction that an inmate is planning to parole to. Secondary and tertiary referrals have been denied by the primary jurisdiction and sent to alternate jurisdictions for screening. In some jurisdictions, the number of secondary and tertiary transition referrals exceed the number of primary referrals received.

HB 18-1251 requires the Division of Criminal Justice to publish an annual report that includes referral trends and acceptance data. This report is submitted to the Division of Criminal Justice, as well as to other stakeholders.
