<p style="text-align: center;">Issue/Topic</p> <p style="text-align: center;">Working Group Formation and Membership <i>Richard Stroker, All Members</i></p> <p style="text-align: center;">ACTION: DCJ Staff to compile Working Group membership document from emails.</p>	<p>The Task Force member discussed the potential working group topics and identified the following four groups:</p> <ul style="list-style-type: none"> • Structure Working Group • Sentence Progression Working Group • Decision Making, Sentencing Alternatives, and Probation Working Group • Parole Working Group <p>After some discussion, it was agreed that “sentence enhancements” would be addressed by the Structure Working Group and that the “purpose of probation” would be addressed by the Decision Making, and Sentence Alternatives Working Group.</p> <p>The group discussed the membership of each working group, including the size of the groups and the importance of diverse representation within each group. The group agreed to email Damien Angel (DCJ staff) their preferences for which Working Group they would like to serve.</p>
