<p>Welcome &amp; Introductions <i>Dean Williams</i></p>	<p>Working Group Leader Dean Williams thanked members for participating in the meeting and proceeded with introductions. <p>Define Transitional Confinement Program Elements <i>Members</i></p>	<p>Dean Williams reminded the members that the focus of this Working Group is to expand opportunities for incarcerated individuals to help successful transition to the community and consequently reduce recidivism. Dean acknowledged the recent discussion (see minutes 12/23/20) and explained that he suggested a Transitional Confinement program as he felt this would implement small changes in the correctional system compared to other alternatives such as focusing on modifying the Intensive Supervision Program-Inmate (ISP-I).</p> <p>Rick Kornfeld supported the concept of a Transitional Confinement program and stated that, while there is no vote at the Working Group level, he was hopeful that the Working Group could reach consensus and bring a recommendation forward for the Sentencing Reform Task Force’s consideration.</p> <p>Greg Mauro said he didn’t want to miss an opportunity to fix ISP-I and was concerned that the Transitional Confinement program has the same components of the ISP-I but excludes the local community corrections boards’ discretion.</p> <p>Dean Williams acknowledged the concerns and agreed that all alternatives should be considered. In an effort to advance today’s discussion, Dean proposed to define the Transitional Confinement program elements and revisit other options at future meetings.</p>

<p style="text-align: center;"><b>Issue/Topic</b></p> <p style="text-align: center;">Define Transitional Confinement Program Elements <i>Members</i> (continued)</p>	<p>DISCUSSION</p> <ul style="list-style-type: none"> <li>• Would DOC pay for housing, treatment, education, employment, and other social support? DOC would pay for housing and treatment with the exception of those medical expenses that are paid by employers (worker compensation) or federal entities. The program would not have fiscal impact on local communities and individuals will remain under the DOC supervision.</li> <li>• The issue of the limited resources for those who are near their MRD was mentioned.</li> <li>• A concern was expressed about the acceptance in a program of individuals who have been denied by Parole, community corrections or ISP-I. Dean responded that only 40% of individuals are referred to community corrections, and that in many cases, inmates do not submit applications for ISP-I. Some individuals do not have the confidence that they would be accepted in Community Corrections or other programs.</li> <li>• It was suggested to not include VRA crimes as it would add another layer of uncertainty for victims of crime as to what a sentence to DOC means. Victim input is solicited when an inmate is seeking release to community corrections and/or parole.</li> <li>• Who will have the discretion to accept individuals in the Transitional Confinement program? Will there be stakeholder input?</li> <li>• Is there a way to run transitional release through the parole board? Could the parole board release someone to transitional confinement? That might help address concerns about (a) creating a new governmental layer and (b) simply giving authority to a state agency to bypass local decision-making.</li> <li>• What services/treatment would individuals receive compared to other programs? Dean responded that those would be primarily home-based such as social belonging programs, reentry services, etc. Andrew added that this would get individuals in environments that are conducive to change, give them a sense of belonging and an opportunity to practice reentry skills.</li> <li>• The development of a pilot program was suggested. The duration of the pilot should be determined as well as the number of individuals eligible to the program. Additionally, data requirement should be included so the pilot could be evaluated and programs compared.</li> </ul>
