<p>Welcome & Introductions <i>Glenn Tapia, WG Leader</i> <i>Richard Stroker, CCJJ Consultant</i></p>	<p>Glenn Tapia, welcomed everyone and solicited introductions from the other group members. Glenn then provided a brief overview of the meeting agenda:</p> <ul style="list-style-type: none"> • Review results of “Purpose of Probation” survey completed by members • Review current statutory purpose of Parole/Community Corrections • Discuss content ideas for Purpose of Probation • Public comment

Issue/Topic	Discussion
<p>Presentation: Purpose of Probation Survey <i>Glenn Tapia, All</i></p>	<p>Glenn presented the results of the Purpose of Probation survey. The following purposes were discussed:</p> <ol style="list-style-type: none"> 1. To serve as a sentencing option as a response to crime with a goal to prevent future criminal behavior and victimization. 2. To support people in a process of restoration and repair of harm to the person, to the victim, and to the community. 3. To engage people in the initiation of behavior change through provision and brokering of education, therapeutic, and skill-building services. 4. To achieve an effective balance of supervision, accountability, behavior change, and reparation. 5. To help people account for their behavior in the interest of serving justice, harm reduction, and supervision in the interest of safer community placement. 6. To coordinate with victims of crimes for their involvement in the process of justice. 7. To serve as a cost-effective community-based alternative to incarceration?

<p>Topics to Discuss at the February Meeting <i>Glenn Tapia, All</i></p>	<p>Glenn reviewed the Working Group’s charge from the CCJJ to evaluate the level of probation supervision regarding proper dosage and approaches (e.g., avoiding over-supervision). He informed the group that they would be discussing this portion of their charge and preparing answers to the following questions for the next meeting:</p> <ol style="list-style-type: none"> 1. What does over-supervision look like in Colorado probation in concrete terms? 2. What is the ideal state of probation supervision? In other words, what does proper supervision look like in concrete terms?
