<b>Issue/Topic</b>	<b>Discussion</b>
<p>Welcome, Agenda &amp; Status of Work <i>Michael Dougherty, WG Leader</i></p>	<p>Michael welcomed the group and members of the public, then provided a brief overview of the agenda. Michael updated the group on the voting outcomes for the recommendation elements from the previous meeting of the Sentencing Reform Task Force (SRTF). He stated that those elements passed, but the following aspects were asked to be reevaluated or amended in light of discussions by SRTF members:</p> <ul style="list-style-type: none"> <li>• POWPO (Possession of a Weapon by a Previous Offender) statute</li> <li>• Violation of Criminal Protection Orders to become M1, rather than M2</li> </ul> <p>The group agreed to postpone discussion of POWPO and Violations of Criminal Protection orders until Christie Donner and Dan Rubenstein could join at the next Study Group meeting.</p> <p>Michael and Maureen presented a chart that organizes the current elements under study and those that will be undertaken in the near future.</p>

<p>Report from Study Group <i>Maureen Cain, Michael Dougherty, Tom Raynes, &amp; Members</i></p>	<p>The Study Group presented documents that contained recommended changes to various statutes. Changes to the following were recommended and discussed by the Working Group (WG):</p> <ul style="list-style-type: none"> <li>• County Jail Sentencing Alternatives</li> <li>• DUI Sentencing (misdemeanor traffic)</li> <li>• County Jail Time Credits</li> <li>• Fines</li> <li>• Title 42 (traffic) crimes that were not addressed previously by the WG</li> </ul> <p>Following a brief discussion of each, there were no objections to the recommended changes to County Jail Sentencing Alternatives, DUI Sentencing, Jail Time Credits, or the Title 42 offense designations.</p>
