Legislative Updates Michael Dougherty

Discussion

Michael mentioned that several members of the Working Group have been very engaged with this legislative session and provided the following updates:

- House Bill 2022-1229: S.B.21-271 Clean-up is making its way through the
 legislative process. Senate Bill 2021-271 created a civil infraction as a
 penalty for violations of the law that do not rise to criminal conduct. S.B. 21271 included procedures for civil infractions. The bill repeals those
 provisions and replaces them with new procedures for handling civil
 infractions.
- House Bill 2022-1257: FY22 CCJJ Recommendations. Six substantive recommendations from the CCJJ are contained in H.B. 22-1257. There were robust discussions about the criminal offenses related to professional licensing, the probation recommendations, and the list of offenses that would be POWPO¹-eligible. Based on that discussion, as well as the conversations since the hearing, it seems as though many of the questions and concerns have been addressed. The bill is making its way through the House. Because it is critically important to add the offenses that the CCJJ approved for the POWPO statute, members of the Sentence Structure WG will continue to monitor the bill's progress.

Discussion

Jes asked whether amendments were introduced to the POWPO statute to include aggravated motor vehicle theft and distribution of dangerous drugs. Michael responded that while robust discussions occurred at the Legislature, no amendments were introduced.

Valarie asked for more information about the arguments against the revised POWPO list. Michael responded that some members felt the list should be expanded to include aggravated motor vehicle theft and dangerous drug distribution. Michael believed that the overall concern was more related to the increase of criminal offenses and public safety.

Michael stated that, after much discussion regarding concerns addressed with legislators and various interest groups, the following amendments to H.B. 22-1257 were introduced:

1. Add the following language in Section I, page 3 to: "if the person fraudulently represents the self as a licensed professional".

- 2. Remove "electricians" from the list of professions. The practice without a license would remain a misdemeanor offense.
- 3. Remove (VI) direct-entry midwifery from the list, as it is already included in (VIII) Professional Nursing.

Michael mentioned that the CCJJ Legislative Subcommittee had met just prior to the current meeting and agreed that the amendments continued to reflect the intent of the CCJJ recommendations.

The Sentence Structure Study Group met this morning and the group will continue to work on the enhanced felony grid. The group reviewed the first 37 offenses and placed them into the new classifications F1-F5 (F6 classification would be removed). The group is also exploring the extreme indifference 1st degree murder statute and will consider expanding it to include vehicular homicide.
