

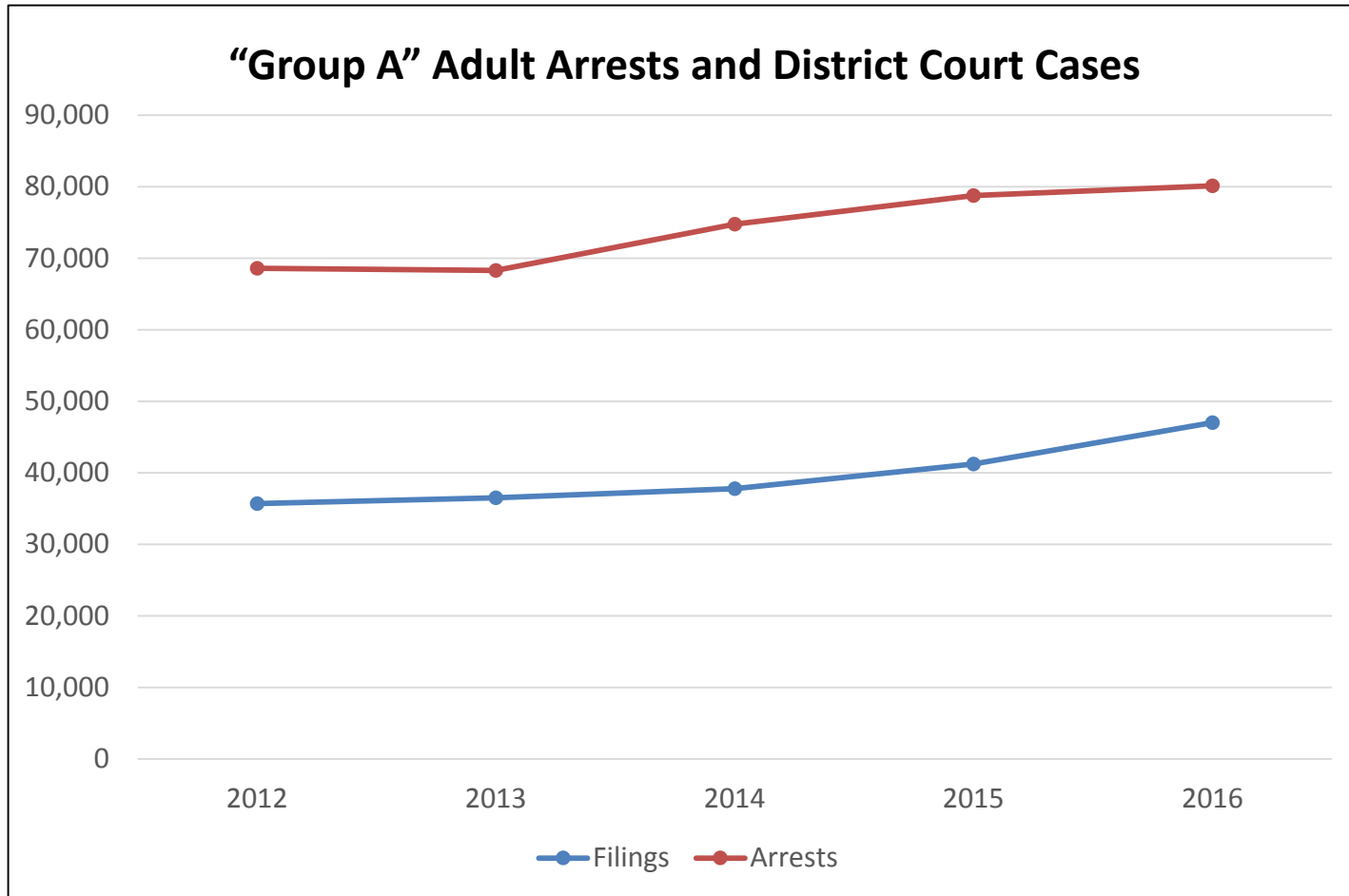

DOC Population Drivers: Increase in Felony Filings

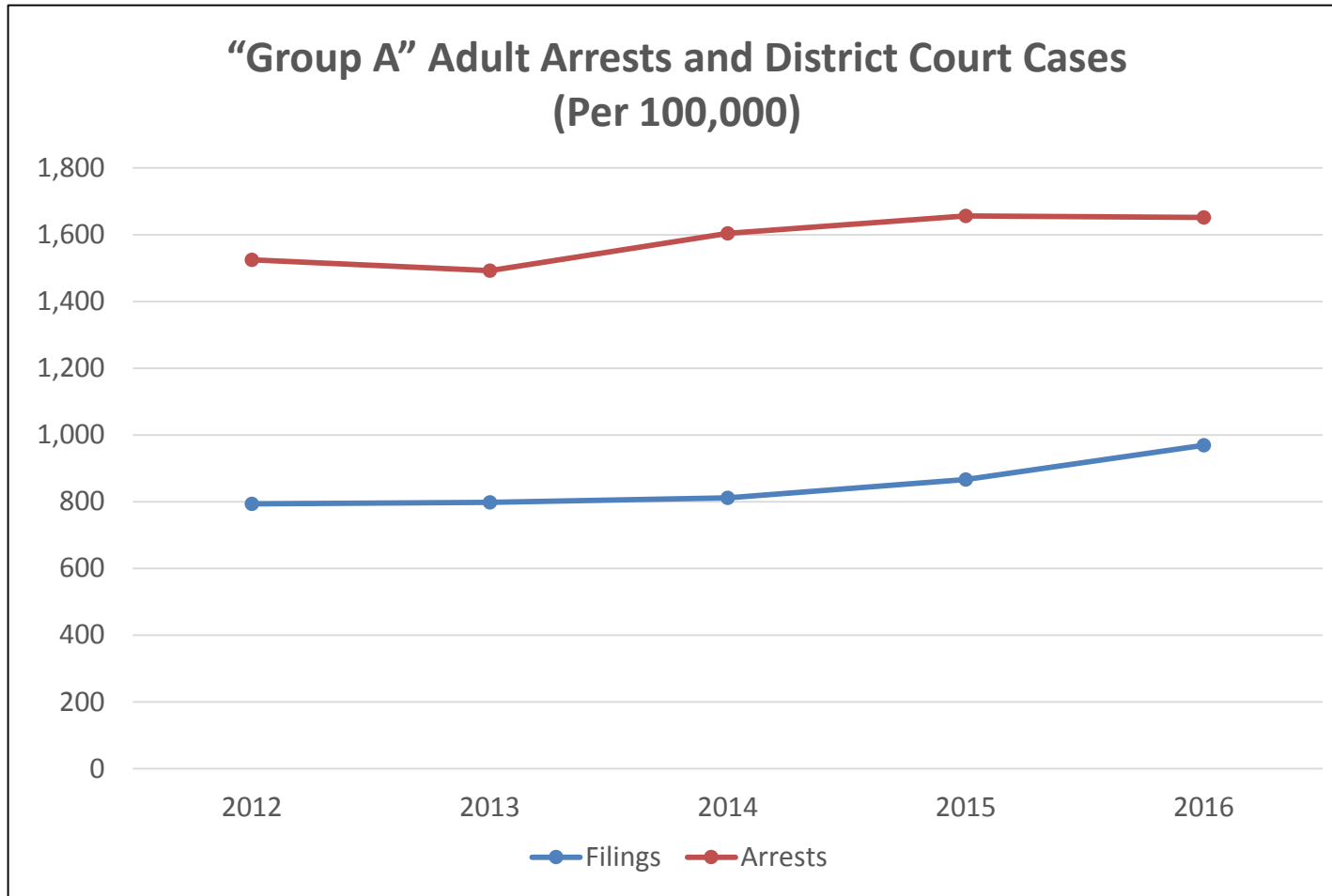

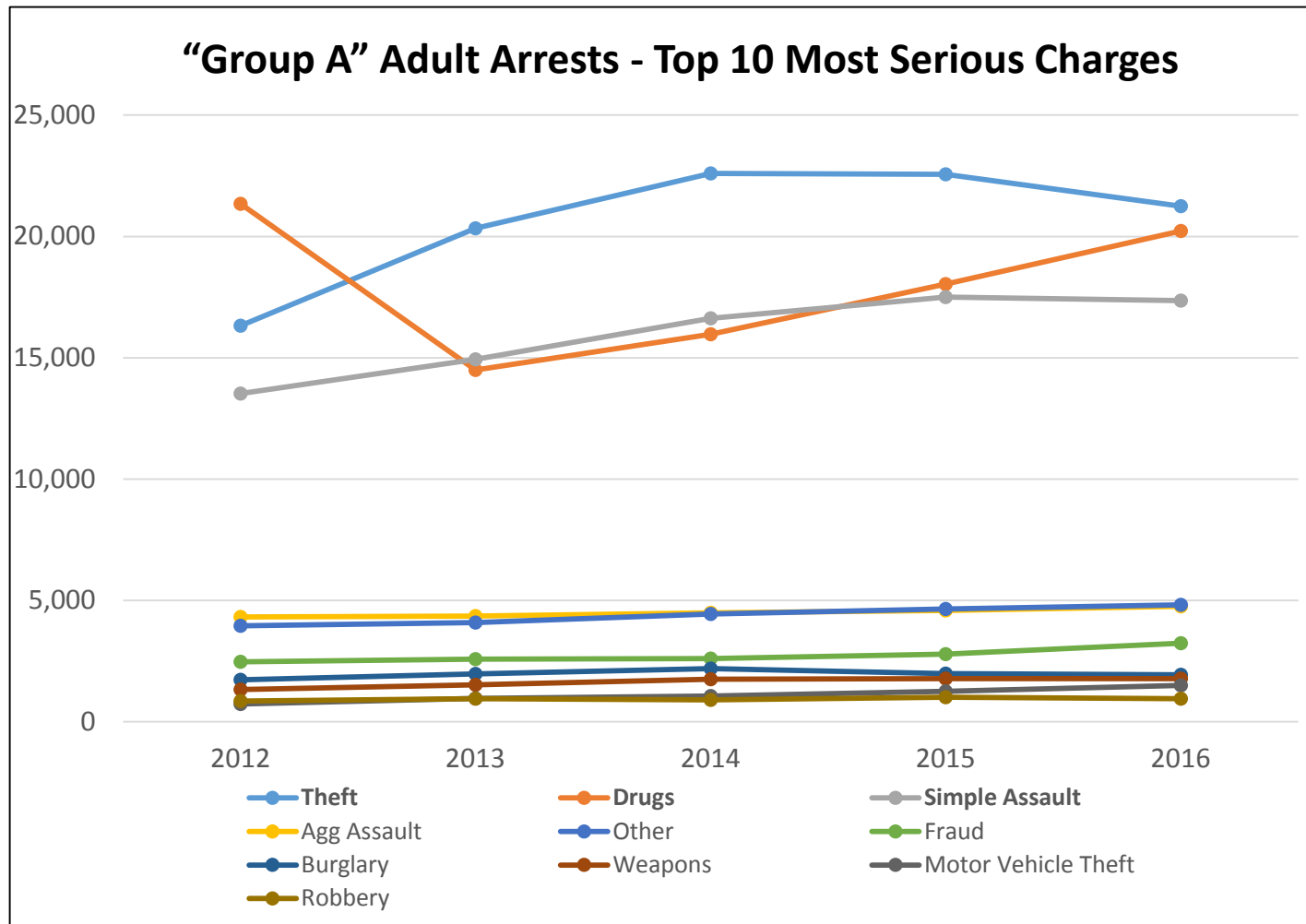
Data Sources: Court records were extracted from Judicial Branch's Integrated Colorado Online Network (ICON) information management system via the Colorado Justice Analytics Support System (CJASS) and analyzed by DCJ/ORS. National Incident Based Reporting System (NIBRS) "Group A" Arrest records obtained from the Colorado Bureau of Investigation.

Notes: "Group A" Arrests for purposes that would not result in a filing, for example failure to appear and arrests by agencies for other jurisdictions, have been excluded. District court filings include some juveniles (Direct File).



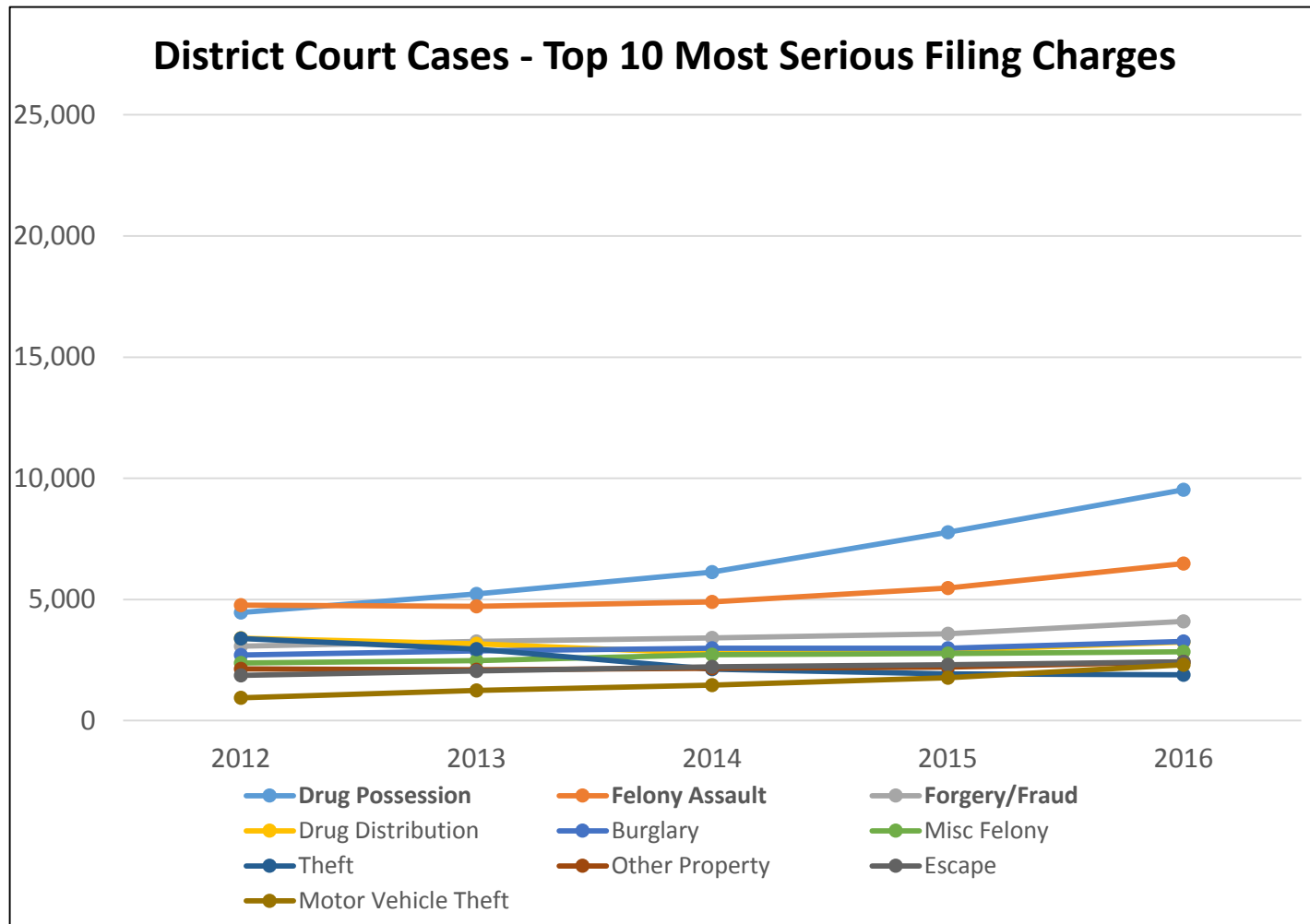
Data Sources: Court records were extracted from Judicial Branch's Integrated Colorado Online Network (ICON) information management system via the Colorado Justice Analytics Support System (CJASS) and analyzed by DCJ/ORS. National Incident Based Reporting System (NIBRS) "Group A" Arrest records obtained from the Colorado Bureau of Investigation. Population data obtained from Colorado State Demography Office.

Notes: NIBRS "Group A" Adult arrests include cases that would have been filed in county court rather than district court. District court filings include some juveniles (Direct File). As a result the two trend lines are not directly comparable.



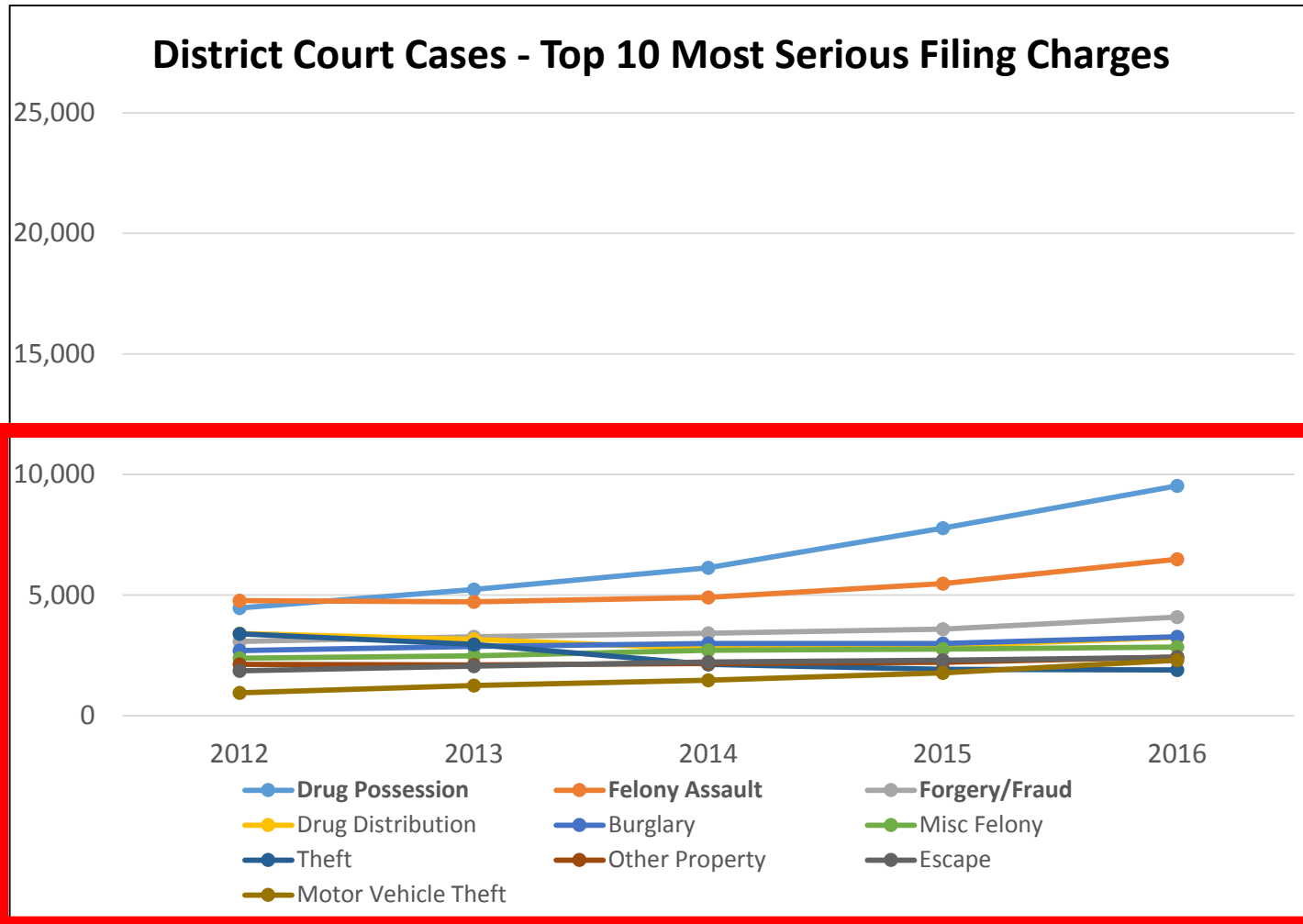
Data Sources: National Incident Based Reporting System (NIBRS) "Group A" Arrest records obtained from the Colorado Bureau of Investigation.

Notes: Arrests may contain multiple offenses. The most serious offense (using a crime hierarchy) was selected.



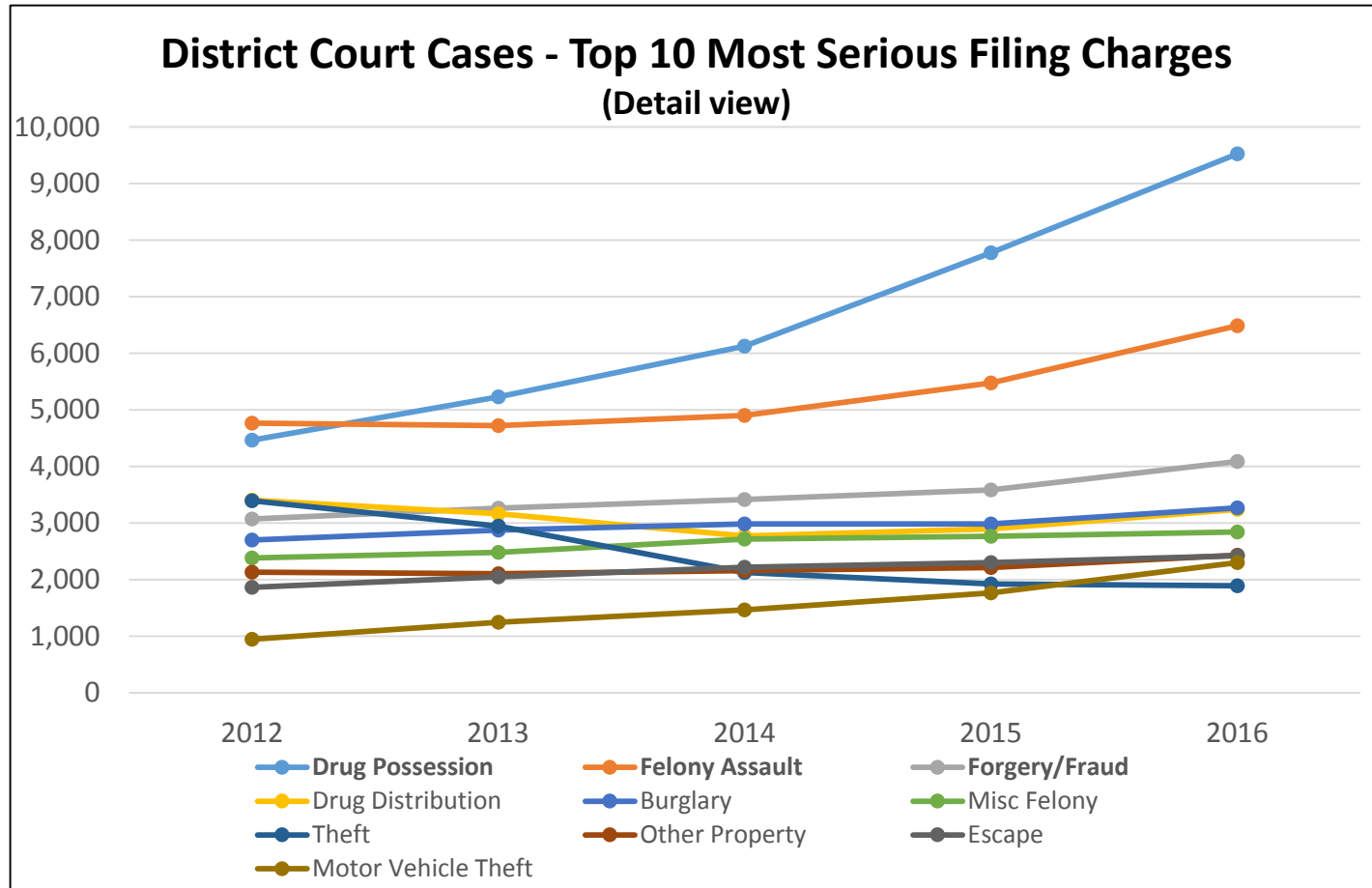
Data Sources: Court records were extracted from Judicial Branch's Integrated Colorado Online Network (ICON) information management system via the Colorado Justice Analytics Support System (CJASS) and analyzed by DCJ/ORS.

Notes: This slide displays the number of district court filings on the same scale as the previous slide (page 4), which displayed the number of "Group A" adult arrests. District court filings include some juveniles (Direct File).



Data Sources: Court records were extracted from Judicial Branch's Integrated Colorado Online Network (ICON) information management system via the Colorado Justice Analytics Support System (CJASS) and analyzed by DCJ/ORS.

Notes: This is a duplicate of the previous slide with the area highlighted in red that is presented in an expanded "detail view" on the next slide. This slide displays the number of district court filings on the same scale as the page 4 slide, which displayed the number of "Group A" adult arrests. District court filings include some juveniles (Direct File).



Data Sources: Court records were extracted from Judicial Branch's Integrated Colorado Online Network (ICON) information management system via the Colorado Justice Analytics Support System (CIASS) and analyzed by DCJ/ORS.

Notes: The most serious filing charge was found by sorting all the filing charges by felony level and selecting the highest felony. This technique was different from selecting the most serious arrest offense because felony level is not present in the arrest data. As a result the most serious offense selected on the arrest may differ from the most serious charge selected on the case filing. In addition, arrest charges and filed charges may differ due to prosecutorial discretion. District court filings include some juveniles (Direct File).
