Members considered a motion to WITHDRAW CCJJ SUPPORT of Senate Bill 2020 - 161 (Concerning Pretrial Release) as amended because it no longer reflected CCJJ Recommendation: FY20-PR #03 (Implement Bail Bond Reform) [Decision by simple majority under CCJJ "Policy on Legislative Recommendations"*].

VOTE OPTIONS

- Votes of "Support" (A) were IN FAVOR of the motion to withdraw CCJJ support of the bill.
 - Votes of "Do not support" (B) were NOT IN FAVOR of the motion to withdraw CCJJ support of the bill.
- THEREFORE, by a majority, CCJJ support of the bill is not withdrawn.**

Supermajority Threshold
Approve: When the total of "A" and "B" votes is ≈ 66%.
