## The BHA & the Criminal Justice System

The BHA will build on partnerships and relationships between Behavioral Health and Criminal Justice and support shared reform efforts.

- There will be a representative of the Criminal Justice sector on the Advisory Council.
- There could be a Criminal Justice working group that repots to the Advisory Council.
- There will be a core position within the BHA which brings CJ expertise to the BHA

Focus on joint recommendations:

- Review the Behavioral Health Task Force and the Statewide Needs Assessment recommendations for criminal justice and justice-involved populations and prioritization of those recommendations. Provide feedback to the BHA to support more rapid implementation:
  - o Include recommendations on continuum gaps and service changes
  - Include recommendations on how to better align programs across the continuum currently
  - Review SB 19-222: Comprehensive Plan to Strengthen and Expand the Behavioral Health Safety Net System recommendations and changes for justice-involved populations and then, which additional recommendations from the BHTF and Statewide Needs Assessment remain and should be prioritized
- OBH is kicking off plans for a strategic roadmap focused on criminal justice reform efforts



## This is not final

The information we are sharing today is based on a concept of the Behavioral Health Administration (BHA) as of November 2021. This BHA model will continue to evolve with additional feedback from stakeholders, direction from the Governor's Office, and through final authorization from the General Assembly through future legislation. Any resource implications will be considered as part of the annual budget process.

The Behavioral Health Reform Executive Committee works with the Governor's office to guide implementation of the recommendations from the Task Force, including the creation of the BHA.



BHA Bill (BH21-1097) introduced that requires a plan to be developed for the creation of the BHA and to establish the BHA with specified duties by July 1, 2022.



## What is the BHA

- The BHA will lead the coordination of behavioral health efforts across agencies, creating shared goals, improving collaboration, driving accountability and transparency for a person-centered, outcome-oriented and consumer and data driven behavioral health system for ALL Coloradans.
- The BHA will provide an opportunity to **streamline our overall system** so that we are smarter about investing our dollars and more responsive to the needs of Coloradans.
- The BHA will elevate the voice of Consumers and Family Members with lived experience of behavioral health in Colorado
- Equity is central to the mission of the BHA and addressing behavioral health disparities is a priority
- The BHA will **problem solve** and implement solutions through **collaboration** and effective relationships
- The BHA will impact the **entire behavioral health system**, **including the commercial system** from prevention to recovery and continue to shift intervention "upstream" to impact health early on.
- The BHA will enhance and focus on whole person care and improve the quality of care for complex populations
- The BHA will strive to be a diverse, inclusive and equitable entity in vision, strategy and operations



## Collaboration is Key



#### Across All Payers, State Departments & Sectors

- The BHA will partner with all Colorado state departments to ensure there is a collaborative and networked approach along the behavioral health continuum from prevention to treatment and recovery.
- The BHA will also work with local governments, intermediaries, providers, and other key partners to generate solutions and build shared accountability for outcomes for Coloradans.




## Proposed BHA Governance Overview

## The BHA Will Be Initially Housed in CDHS



#### On or before November 1<sup>st</sup>, 2021:

CDHS shall develop a plan for the creation of the Behavioral Health Administration, including the integration or alignment of HCPF and DOI



#### **On or before July 1**<sup>st</sup>, **2022:** The BHA is established in CDHS



#### On or before November 1<sup>st</sup>, 2024:

CDHS shall provide a report concerning recommendations on whether the BHA should remain in CDHS or be transferred to a different state department.



## The BHA Will Evolve



The design of **the BHA is the beginning and not an end state**. The BHA will change over time in response to what works and what needs to be adapted or added to meet the vision and purpose of the BHA.

A cabinet level Commissioner with other partners in the governance model will also change the way the BHA functions through lessons learned and natural adaptation.



## BHA is Already Impacting Collaboration

The work of the BHTF and the ongoing development of the BHA have already improved coordination and shared visioning for BH across departments and branches of government.

- Shared strategy and prioritization of funding and budgeting
- Greater appreciation of roles and opportunities to work together
- Infrastructure development with claims processing, data warehouse and analysis
- SB-19-222 incorporated ideas from CJB and other partners
- Recent criminal justice reform recommendations







## Immediate Next Steps

- Governor will complete a national search for a BH Commissioner for his cabinet
- Continue engagement with stakeholders for seamless implementation
- Draft BHA authorizing legislation for 2022 session with BHA functionality and fiscal note
- Ensure BHA is operational by July 1, 2022
- Communicate about the BHA and its benefits
- Initiate implementation plan for developing the BHA with phased functionality
- Continue cross-agency collaboration and cross-functional efforts and federal fund maximization
- Outline timeline for implementation of remaining BHTF recommendations
