Announcements:

- Staff Announcements:
 - Jesse Hansen Announced:
 - The Department of Regulatory Agencies (DORA) 2022 Sunset Report of the DVOMB will formally be published by October 15th.
 - The Denver Domestic Violence (DV) Task Force reached out to the staff of the DVOMB to discuss concerns around capacity of domestic violence offender services. There are a number of initiatives underway to support and address those concerns, including a short survey for DVOMB Approved Providers to participate in that was highlighted in the October newsletter.
 - Anthony Antuna passed away on September 30th. He was a retired law enforcement officer from Greeley and a longtime advocate for victims.
 - Carolina Frane announced:
 - The Application Review Committee (ARC) is finished processing all of the DVOMB Approved Provider renewals.
 - The ARC also received a few variances seeking to expand the allowable group size due to capacity issues. These variances have been approved so long as the co-facilitator is listed with DORA, a DVOMB Trainee, or a student in a formal internship to co-facilitate.
 - DORA recently eliminated the unlicensed psychotherapist designation. This change has implications to the Trainee Application given that listing with DORA is a required component. The ARC has reviewed a few variances from the Trainee Application seeking relief from this change. The ARC will be exploring possible modifications to Section 9.0 in response to these changes.
 - Carolina had a successful presentation at the Domestic Violence (DV) Summit in Colorado Springs.
 - Marina Borysov announced the following updates regarding training events:
