<u>LEGISLATIVE SESSION UPDATES – (Presentation): (Attachment #2)</u> – Joel Malecka, CDPS Legislative Liaison

Jesse Hansen (DVOMB Staff) introduced Joel Malecka, the Colorado Department of Public Safety Legislative Liaison. He noted that the 2023 Legislative session has ended, and mentioned that the SOMB has been re-authorized through the Sunset process for another 5 years.

BREAK: 9:38 – 9:47 (due to technical issues)

Joel Malecka (CDPS Legislative Liaison) noted that there were 42 incoming new legislators with only 25 having 1-2 years' experience. He indicated that decision making was challenging this past session due to the number of new legislators who may not have known how the legislative process works.

Joel Malecka (CDPS Legislative Liaison) highlighted the details of the following bills that were pertinent to the DVOMB:

- HB23-1222 Cases of Domestic Violence in Municipal Court concerning the jurisdiction of municipal courts to hear domestic violence offenses.
- HB23-1268 Private Treatment for Out-of-state Defendant concerning changes to the process for a person servicing a criminal sentence in Colorado for a conviction in another state to participate in a private treatment program.



- SB23-170 Extreme Risk Protection Order Petitions concerning extreme risk protection orders, and, in connection therewith, making an appropriation.
- HB23-1178 Court Personnel and Domestic Violence Agencies concerning enhancing court personnel's recognition of domestic violence to access federal funding, and, in connection therewith, including the recognition of child abuse.
- HB23-1108 Victim and Survivor Training for Judicial Personnel concerning the creation of a task force to study victim and survivor awareness and responsiveness training requirements for judicial personnel, and, in connection therewith, making an appropriation.
- HB23-1107 Crime Victims Services Funding concerning funding for crime victim services.

Joel Malecka (CDPS Legislative Liaison) reiterated that the SOMB was renewed for another 5 years.

Board Discussion:

Andrea Bradbury (DVOMB Member) asked for an update on the SOMB Raise the Floor bill, HB23-1249 regarding raising the juvenile culpability age from 10 – 12 years of age. Joel Malecka (CDPS Legislative Liaison) responded that there was an amendment that significantly changed the bill. He noted there was a lot of discussion regarding how to keep juveniles from entering the Criminal Justice system at a young age, and mentioned that Diversion programs are used over 90% of the time for juveniles. Joel Malecka indicated that the bill appropriates \$15,000,000.00 to develop future policy, and he mentioned that this bill gives the opportunity to review the data from Colorado and nationally to inform policy.

Jessed Hansen (DVOMB Staff) highlighted that HB23-1222 indicates that municipalities must follow guidelines and standards that are consistent with the DVOMB Standards (Section V (e.).

Chris L.R. (ODVSOM Program Manager) thanked Joel Malecka for the fabulous job and the hard work he did during this Legislative year. Joel Malecka responded that his success reflects all the help and support he has received from the Division of Criminal Justice.

<u>REVISIONS TO THE DVOMB ADMINISTRATIVE POLICIES (Decision Item)</u>: (Attachment #3) – Karen Morgenthaler (DVOMB Member), and Jesse Hansen (DVOMB Staff)

Stephanie Fritts (DVOMB Chair) introduced the revisions to the DVOMB Administrative Policies agenda item and indicated that this is a voting item.

Jesse Hansen (DVOMB Staff) highlighted the recent revisions to the DVOMB Administrative Policies. He noted the new departmental text revisions requirements that indicate "BOLD and CAPITALIZED" text are new revisions and "Red" strike-though text are items to be removed. Jesse Hansen indicated that this is due to Americans with Disabilities Act and "Accessibility" policies that are required by the Division of Criminal Justice.

Jesse Hansen (DVOMB Staff) noted and reviewed the following information:

- Danielle Lewis (CDPS Attorney General Counsel) reviewed and approved these revisions
- <u>I. Listing Status as a Provider</u> defined Practicing Status, Not Currently Practicing Status, and Inactive Status
- Changed the term "Trainee" to "Associate Level Candidate" throughout the document
- <u>II.C.2.</u> Added Professional Standards and Ethics
- <u>III. Administrative Requirements for Approved Providers</u> Added the Administrative Requirements from Section 10 of the Administrative Standards.
- <u>VI. Approaches to Promoting and Supporting Compliance with the Standards</u> Added language based on the Sunset Amendments issued in 2022 regarding Compliance Reviews and Process. He noted that



there are 3 types of Standard Compliance Reviews (Voluntary, Random, and For Cause), and indicated that there are 3 review levels within those types: Level 1 – Implementation Verification, Level 2 – Work Product Review, and Level 3 – Site Visit & File Review.

- <u>VI.</u> ARC Determination of Standard Compliance Reviews: Added language regarding outcomes of the various Standards Compliance Review types/levels.
- <u>VI.C.</u> Formal Complaints Language has been added for the DVOMB to investigate complaints, and noted that it can take 12-18 months for a decision when DORA reviews complaints. Jesse Hansen indicated that this gives the Application Review Committee (ARC) to investigate own complaints and render dispositions while still sending the complaints for DORA for their review.

Sandy Campanella left the meeting at 10:12 am

Jesse Hansen (DVOMB Staff) indicated that the vote is to send these revisions out for public comment.

<u>REVISIONS TO SECTION 9.0 AND ELIGIBILITY REQUIREMENTS FOR CERTIFIED ADDICTION</u> <u>TECHNICIANS (Decision Item): (Attachment #4)</u> Karen Morgenthaler (DVOMB Vice-Chair), and Carolina Frane (DVOMB Staff)



Carolina Frane (DVOMB Staff) introduced the reason for the changes to Section 9.0 and the eligibility requirements for the Certified Addiction Technicians Associate Level Provider candidates, based on DORA changes.

She reviewed the following revisions:

- <u>Section 9.01</u> Trainee Level Applicant changed to "ASSOCIATE LEVEL PROVIDER CANDIDATE" for Certified Addiction Technicians Associate Level candidates as long as they are properly supervised and received supervisor approval to treat or evaluate clients independently.
- <u>Section 9.03 VI. A.</u> Added language for Full-Operating level providers requiring that "A QUARTER OF THE REQUIRED CONTINUING EDUCATION HOURS MAY BE DEMONSTRATED THROUGH COMMUNITY EDUCATION AND TRAINING ON ISSUES RELATED TO DOMESTIC VIOLENCE."
- Changed the Department of Regulatory Agencies (DORA) addiction label language

Karen Morgenthaler (DVOMB Member) indicated that the Certified Addictions Technicians (CATs) with a Bachelor's degree can now apply to be an approved DVOMB provider as long as they are working toward their certified addictions counselor certification. Carolina Frane (DVOMB Staff) indicated that the supervisor must hold a Licensed Addictions Counselor certification (LAC) as well.

Board Discussion:

Jeanette Barich (DVOMB Member) asked for clarification of the community education and what that looks like. Carolina Frane (DVOMB Staff) responded that a full-operating provider can provide training or information in the community such as at schools, victim centers, and to the general public. Jesse Hansen (DVOMB Staff) indicated that this gives those providers a benefit of CEUs when doing outreach independent of the Board.

PUBLIC COMMENT REVIEW AND RECOMMENDATIONS FOR THE WORKING CLINICAL DEFINITION OF DOMESTIC VIOLENCE (Decision Item): (Attachment #5) Erin Gazelka (DVOMB Member) and Jeanette Barich (DVOMB Member

Jesse Hansen (DVOMB Staff) introduced the public comment review and recommendations regarding the working clinical definition of domestic violence voting item. He indicated that this document will be a resource for providers when working with offenders who commit domestic violence offenses. Jesse Hansen indicated that this document clarifies the clinical considerations that treatment providers look at when working with this population.

Jesse Hansen (DVOMB Staff) reviewed the following information and revisions after Board discussion:

- Legal Definition of Domestic Violence no additional revisions were made to this definition
- Clinical Features for Domestic Violence and Abusive Behaviors after public comment review, the following revisions were made:
 - Added "Caution should be exercised when applying this definition and list of abuse types in circumstances that have not been identified through the legal system"
 - Added This definition "and list of abuse types" serve as a framework...
 - Added Domestic violence is an emerging, "cyclical," or established pattern of attitudes...
 - Added Abuse related to domestic violence "and should be considered and used for clinical purposes."

Jesse Hansen (DVOMB Staff) reviewed the revisions made to the Abuse Types after public comment review and current Board discussion as listed below:

Dominance

- <u>Financial Abuse</u> this definition was revised to read: "Controlling, exploiting, limiting, or withholding access to economic assets, employment or resources to negatively impact the financial capacity of the victim."
- <u>Psychological Abuse</u> this definition was revised to read: "An intense or repeated pattern of confusing or doubt inducing behavior that creates psychological stress, confusion, or doubt in the victim. This may include threats or acts of self-harm or homicide, denial of abuse, gaslighting, or stalking."
- <u>Verbal Abuse</u> this definition was revised to read: "Using words or verbal iterations as a means to control, coerce, manipulate, intimidate, ridicule, or degrade the victim and negatively impact their psychological health or otherwise cause harm."
- <u>Reproductive Abuse</u> this definition was revised to read: "Using coercion, control, deceit, manipulation or threats to impact pregnancy, sabotage of contraceptives, use of contraceptive, access to contraceptives, and unilaterally decides reproductive choices as a method to gain power and control over another person(s)."



- o Dissonance
 - <u>Substance Abuse</u> this definition was revised to read: "using mood altering substances as a tool to perpetuate coercive control against the victim, including but not limited to sabotaging sobriety or limiting resources." The use of mood-altering substances by an offender does not cause domestic violence nor is it an excuse for abuse."
- o Vengeance
 - <u>Administrative Abuse through Systems</u> after public comment, no changes to this abuse type were made.
 - <u>Úsing Children</u> after public comment, no changes to this abuse type were made.
- o Surveillance
 - <u>Technology-Facilitated Abuse</u> this definition was revised to read: "using technologies to bully, harass, stalk or intimidate. These behaviors may include non-consensual image sharing."
 - <u>Sexual Abuse</u> this definition was added as follows: "using any physical act, behavior, or exploitation that is sexual in nature and causes harm to the victim without consent."

Board Discussion:

Tally Zuckerman (DVOMB Member) questioned the need for these definitions as they are so broad in nature. Erin Gazelka (DVOMB Member) responded that these are in context with the Treatment Section (Section 5.0) of the Standards which are meant for use by the providers for the clients. She indicated that simplifying the definitions make it easier for the clients to understand them versus the actual legal definitions, and noted these are only to be used in a clinical setting.

Jessica Fann (DVOMB) expressed appreciation for these simplified definitions from the victim perspective.

Stephanie Fritts (DVOMB) noted that the definitions are not vague, and noted that they include a comprehensive list of the abuse types.

General Discussion:

Dr. Rachael Collie (ODVSOM Analyst) noted that regarding the legal definition versus the clinical definition issue that the use of "Clinical Features" in place of clinical considerations might be more helpful. Due to Dr. Collie's suggestion, this change was made.

Jesse Hansen (DVOMB Staff) noted that this definition document could be included in Section 1.0 of the Standards (Introduction) and noted this document could also be included in the Appendices and Glossary. Erin Gazelka, Stephanie Fritts, and Jessica Fann (DVOMB Members) supported this placement suggestion.

Talley Zuckerman (DVOMB Member) reiterated the need to clarify that this is the "clinical definition" and not the "Legal Definition." Jesse Hansen (DVOMB Staff) clarified that this would be placed in Section 1.01 (purview of the DVOMB) and then the addition of the Legal definition in Section 1.02, and the Clinical definition in Section 1.03.
