

2023 CONFERENCE FAQ

Q: Is the conference In person or Virtual?

A: BOTH! The Conference will be held July 11th through July 14th at the Beaver Run Resort in Breckenridge. All Pre-Conference Sessions, Keynotes, and Presentations will be recorded and available for viewing for 90 days. The virtual option will NOT be lived streamed. Online Only attendees will have access to the recordings for 90 days after they are posted to the Attendee Hub.

Q: Is there a Hybrid Option?

A: Yes! You can attend and few or as many conference days as you wish! Those who wish to attend ANY of the conference in Breckenridge must register for the In-Person Option! We are also hosting a Pre-Conference on Tuesday, July 11th. These are advanced, intensive workshops presented by experts in the field.

Q: When is the deadline to register and pay?

A: Deadline to Register for the conference is June 30th, 2023. The deadline to pay your outstanding balance is June 30th, 2023.

Q: Is the registration fee refundable?

A: No, there are no refunds if you don't attend the conference. All conference sessions will be available to view by all registrant for 90 days after the conference so you still be able to view the sessions.

Q: Can I switch my sessions at the last minute?

A: Yes, go to the event website, click on "Modify registration" and follow the prompts.

Q: When will you announce scholarship winners?

A: June 16th, 2023. Scholarship winners will still need to register for the conference by June 30th (they will be given a code at checkout)



Q: Can I register a group of people for my agency?

A: Yes, once you register the first person in your group, on the Registration Summary page you will see button "Add a group Member". Click on that button and follow the same registration process. In the end you will see an Order Summary page with everyone's registrations, a place where you can pay for everyone at once.

Q: How will I get my certificate of completion?

A: In Person attendees will get certificates of completion through the Attendee Hub once the survey is completed, the hours will be added to your online certificate. At the end of the conference, you will receive ONE certificate of completion with all of the sessions.

Recording Only attendees will need to register and stay in the session for a minimum of 75 minutes. Once that session is complete, you will receive a survey. When that is completed you will receive ONE certificate of completion with all of the sessions

Q: Can I earn continuing education towards my SOMB and DVOMB provider status?

A: Yes, all sessions offered at the Conference can be used as training hours for SOMB and DVOMB approved providers. Up to 20.50 credit hours can be earned during the three-day conference. You also have an option to watch other sessions on demand during the 90-day period after the conference and ear additional 62.75 credit hours.

Q: What fees am I being charged?

A: The cost of registration fee is \$395 for the In-Person Pre-Conference + Conference, \$320 for the In-Person Conference (No Pre-Conference), and \$290 for the Recording Only Option. If you pay with a credit card, there is a credit card processing fee of 3.95% which equals to about \$7.50. There is no processing fee if you pay by check. Early Bird Pricing will be available if you register by May 31st!
