| > | A status offense is: runaway, possession of tobacco, curfew violation, truancy. A juvenile picked up on a warrant, FTA, FTP where the original offense is a status offense remains a status offender. Underage drinking/possession of alcohol is no longer a status offense – it is a delinquent offense. A non-offender is a dependent/neglected juvenile or a juvenile in need of mental health services with no delinquent charges. Booking Exception: Law enforcement may complete the booking process of a status offender or non-offender in a secure booking area only if 1) there is no unsecured booking area available, 2) the juve under continuous law enforcement visual supervision, 3) there are no adult offenders present and 4) the juvenile is immediately removed from the secure booking area to a non-secure area for question further processing. | | | | | | | |
