Overview

The Alternative Metrics Working Group meeting commenced with participant introductions and a quorum check, revealing insufficient members for voting and prompting a revised agenda. The group reviewed a list of concepts, including pro-social skills and housing stability, stressing the importance of balancing individual and community metrics. They then focused on healthcare engagement, examining access and management of behavioral health issues, followed by a discussion on concepts related to success in criminal justice transition programs. The continuity of care across systems was emphasized, addressing issues like service wait times and transportation barriers. The meeting also introduced a proposal for developing an evaluation rubric using utility and feasibility scores for concept assessment, followed by considerations for gathering stakeholder feedback, particularly from those with lived experiences. The meeting concluded with action items assigned to various members, including creating scoring forms and visualizing data, alongside plans for further development of concept descriptions and stakeholder engagement strategies in future meetings.

 - Explored concept of participation in behavioral health treatment
 - Considered how to measure successful management of behavioral health issues
- Criminal Legal System Concepts
 - Examined concepts related to success in transition programs and parole
 - Discussed measuring success beyond traditional recidivism metrics
 - Explored gaps in program and treatment availability for clients
- Continuity of Care and Services
 - Discussed concept of continuity of care across different systems
 - Explored wait times for accessing needed services
 - Considered transportation as a factor in accessing services and treatment

MANDATES

Pursuant to 24-33.5-535, C.R.S. (Senate Bill 2024-029) the working group shall:

- Be appointed no later than November 30, 2024.
- Convene first meeting by February 1, 2025
- Meetings shall allow for remote participation
- Submit a report by July 1, 2025 that summarizes the efforts of the working group and any recommendations

The working group is required to:

- Study metrics and methods, other than recidivism, to:
 - Supplement current measures including those related to desistance (severity and timing) and risk reduction.
 - Comprehensively measure successful outcomes that consider various aspects of life (e.g. employment, housing, education, mental health, personal well-being, social supports, and civic and community engagement).
 - Enhance measures of criminal justice system performance and adherence to best practices in supervision program design and implementation.
- Identify methods to obtain information from those involved or recently involved in the system regarding supervision experiences.
- Identify gaps or barriers in data collection, measurement and data matching, and recommendations on addressing these gaps or barriers.
- Create an implementation timeline for these metrics and methods that addresses any data limitations and necessary resources.
- Identify customization of measures to account for age, gender, race, ethnicity, or risk of a cohort.
