^{**}Based on the State VALE statute §24-33.5-506(1)(b-c) state agencies do not have to participate in the competitive grant process for these funds. The amount allocated to the state agencies may be increased based upon the Legislature awarding increases for state employees salary/benefits. Any changes to the award figures are dependent upon the salary adjustments approved by the Joint Budget Committee in the long bill.
