Colorado Bureau of Investigation (CBI)*	This grant covers a portion of the costs of genetic testing of sex offenders using DNA analysis. This grant award is mandated by statute C.R.S. §17-2-201(5)(g)(III).	\$ 18,000
Colorado Department of Corrections (DOC)*	The Victim Services Unit (VSU) provides: 1) information to victims who are registered in the Victim Notification program regarding the status of offenders who are under the jurisdiction of DOC; 2) personal assistance and support to victims who attend Colorado Parole Board Hearings and Community Corrections Board reviews; and, 3) referrals to other victim services providers. State VAE Funds support 1.5 FTE for the VSU.	\$ 128,073
Colorado Department of Human Services/Division of Youth Corrections (DYC)*	The Division of Youth Corrections (DYC) Victim Services Program (VSP) is designed to meet the notification requirements of the Victim Rights Act (VRA). Victims are informed of any change of location and status changes of an identified youth under the jurisdiction of DYC. The Victim Services Coordinator is responsible for ensuring that the rights of all victims enrolled in the program are met throughout the state.	\$ 28,549
Colorado Department of Law Attorney General's Office *	The Victim Assistance Project provides statutorily mandated victim services under the Victim Rights Act (VRA) to those victims whose cases are handled by the Attorney General's Criminal Justice Section and Appellate Unit.	\$ 72,651
Colorado State Judicial Branch/Office of the State Court Administrator – Division of Probation Services *	This program is designed to maintain victim assistance personnel in probation departments throughout the state, and to ensure that Colorado probation departments are in compliance with the Victim Rights Act (VRA). This grant supports portions of an FTE for Victim Assistance Coordinators in several Judicial Districts.	\$ 54,393
Colorado State Patrol (CSP) *	The Colorado State Patrol victim advocates provide comprehensive services to victims of traffic crashes (and their families) on Colorado highways where an injury or death occurs. The advocates ensure compliance with the Victim Rights Act (VRA).	\$ 166,990

Colorado Coalition Against Domestic Violence (CCADV)**	Grant Funds will provide partial salary support for the Advocacy & Resources Director and two Advocacy and Resources Coordinator positions. Funded activities include providing general support, education, and technical assistance to membership programs as well as initiatives that will strengthen the skills of domestic violence advocates around Colorado.	\$ 35,930
Colorado Department of Human Services - Juvenile Parole Board**	The Victim Services Program is designed to enhance compliance with the Victim Rights Act (VRA) by: 1) providing notification services to VRA victims (when the offenders are eligible for parole); 2) ensuring that victims have the opportunity to address the Juvenile Parole Board; and, 3) making sure victims are notified of the outcome of parole hearings. The Victim Advocate will provide VRA training to parole board members. Training provided to DYC will focus on the parole board's policies/procedures that are related to victim attendance at parole hearings.	30,110
Colorado Department of Personnel & Administration**	The Colorado Address Confidentiality Program protects the confidentiality of a victim's location by providing a legal substitute address and a confidential mail forwarding system. In July 2011, this program was moved to the Department of Personnel and Administration from the Secretary of State's Office. Grant funds will support one .5 FTE Administrative Assistant to assist with enrolling victims in the address confidentiality program and forwarding their mail to the current location. The grant also provides assistance with the costs associated with forwarding mail to victims.	\$18,069
Colorado Nonprofit Development Center**	This program provides advocacy to lesbian, gay, bisexual, transgender, and queer victims of domestic, sexual, hate and bias motivated violence in Denver and Colorado Springs. Grant funds will be used for personnel.	\$21,258
Colorado Organization for Victim Assistance (COVA)**	Grant funds will provide partial support for six positions (Executive Director, Deputy Director, Training Coordinator, Program Supervisor, IT Coordinator and Administrative Assistant). Funds will support the training program, the annual statewide conference, and the Victim Assistance Academy. Funds will also support the administration of the Crime Victim Emergency Fund, the Victim Service Provider Communication and Collaboration Network, and special events.	\$117,636

Families of Homicide Victims & Missing Persons (FHVMP)**	Grant funds will provide partial support for three positions (Executive Director, Victim/Family Coordinator and the Outreach Coordinator). The project advocates for co-victims of unsolved homicide cases, raises public awareness about cold cases, reaches out to family members of cold cases, provides training to law enforcement on the needs of cold case victims, maintains a cold case database, and holds an annual conference.	\$ 9,500
Rocky Mountain Victim Law Center**	Grant funds will support an Attorney and Paralegal/Victim Rights Outreach position. The agency provides legal representation to victims of crime in Victims Rights Act (VRA) cases.	\$37,500

**Due to the calendar year award process, these figures represent a 6-month period (July 1, 2012 – December 31, 2012). Agencies are required to participate in the CY2013 competitive grant process. Therefore, award figures for the second half of FY2013 (January 1, 2013 – June 30, 2013) are not known at this time.

Colorado Organization for Victim Assistance (COVA)	This grant continues the Crime Victim Emergency Fund, which is funded by a combination of funds from the Colorado Department of Corrections Prison Industries Enhancement Program and State VALE grant funds. The Fund is used for unmet emergency needs of victims not covered by Victim Compensation funds. Requests must come through victim advocates who are responsible for verifying the need for the funds and for looking at other resources that may exist in the community.	\$26,000

Monies from the Department of Corrections – Based on a federal requirement, Prison Industry Enhancement Program must be utilized to directly compensate victims of crime. These funds are specifically earmarked for a Crime Victim Emergency Fund. This grant does not compete with other grant applications that receive funding from the general State VALE program.
