| VW | 0 | Colorado District Attorney's Council (CDAC) | \$ 117,532 | Grant funds will be used to support two part-time staff to coordinate the Ending Violence Against Women (EVAW) training project that provides multidisciplinary training, primarily in rural areas, on coordinating the community's response to domestic violence, sexual assault, stalking and dating violence victims. New component includes web-based assistance. |
| VW | 0 | Colorado Judicial Department, State Court Administrator's Office (VAWA Pass-through) | \$ 107,960 | Grant funds will be used to support one full-time Education Specialist to further develop the Judicial Department's distance learning program and to develop a "live" training for court personnel. Training topics will address domestic violence, sexual assault, stalking and dating violence. |
| VW | 0 | Colorado Coalition Against Sexual Assault (CCASA) | \$ 193,045 | Grant funds will provide partial salary support for the Executive Director, Outreach Coordinator, Program Manager and Program Coordinator positions. Funds will provide general support for outreach & membership services, the annual conference and the statewide Forensic Compliance Project. |
| VW | 0 | Memorial Hospital Central (SANE Project) | \$ 130,792 | Grant funds will be used to fully support two .5FTE and 1 FTE positions to coordinate a Sexual Assault Nurse Examiner/Sexual Assault Forensic Examiner Project to provide education/training to communities wanting to establish and/or improve a SANE/SAFE program. |
| VW | 1 | District Attorney's Office, 1st Judicial District | \$ 56,195 | Grant funds will be used to partially fund a Deputy District Attorney to prosecute misdemeanor domestic violence cases and to train prosecutors and victims advocates on domestic violence issues. |
| VW | 1 | Family Tree, Inc. | \$ 94,915 | Grant funds will be used to partially support four positions in the agency's Domestic Violence Services program to provides extensive and comprehensive services to victims of domestic violence. |
| VW | 2 | Denver City Attorney's Office | \$ 101,262 | Grants funds will support a Victim Advocate and a City Attorney to prosecute domestic violence cases and to participate in the Triage Team with other community partners; which will meet daily to review all domestic violence arrests in Denver. New component is a statewide training program to address domestic violence & sexual assault against elder victims. |
| VW | 2 | Domestic Violence Initiative | \$ 57,319 | Grant funds will support the Executive Director, two Victim Advocates and an Outreach Coordinator who will provide crime victims who have disabilities with advocacy, financial assistance, and support. This agency will also train agencies on how to provide specialized assistance to women with disabilities. |
| VW | 2 | Maria Droste Services of Colorado, Inc | \$ 22,270 | Grant funds will support contract clinicians to provide comprehensive mental health services to victims of crime who have serious mental health issues. |
| VW | 2 | SafeHouse Denver, Inc. | \$ 115,000 | Grant funds will support a Bilingual Domestic Violence Advocate, a Women's Shelter Advocate, a Children's Shelter Advocate, and Bilingual Women's Shelter Advocate to provide counseling and hotline services to women and child victims of domestic violence. Services are also available in Spanish. |
| VW | 2 | Denver Domestic Violence Task Force | \$ 10,000 | Grant funds will partially support the contract salary of the Domestic Violence Fatality Review Coordinator to analyze domestic violence related fatalities. |
| VW | 2 | District Attorney's Office, 2nd Judicial District | \$ 115,431 | Grant funds will be used to fund two positions, a 1 FTE Triage Team Coordinator and a .5 FTE Sexual Assault Prosecutor. |
| VW | 2 | Burli Nursing Consultants | \$ 55,000 | Grant funds will support a 1FTE SANE coordinator and a .5FTE Bilingual administrative assistants who will answer the agency's hotline. |
| VW | 3 | Advocates Against Domestic Assault | \$ 95,162 | Grant funds will support partial funding for four positions. The agency provides emergency shelter, and transitional housing for victims of domestic violence and sexual assault. |
| VW | 4 | T.E.S.S.A. | \$ 115,152 | Grant funds will partially support six staff positions to provide shelter and counseling services to domestic violence and sexual assault victims and their children. |
| VW | 5 | Advocates for Victims of Assault | \$ 61,274 | Grant funds will support portions of four staff positions to provide domestic violence and sexual assault victims with crisis counseling, legal advocacy, shelter, court and hospital accompaniment, individual and group therapy, and services in Spanish. |
| VW | 5 | Advocates of Lake County, Inc. | \$ 65,011 | Grant funds will support portions of three staff positions that will provide crisis intervention, court advocacy, Spanish translation, referrals, information, and assistance accessing resources for all crime victims. |
| VW | 5 | Summit Medical Center Health Foundation | \$ 47,984 | Grant funds will provide partial support for a Sexual Assault Nurse Examiner (SANE) Program Coordinator to oversee the SANE program at St. Anthony Summit Medical Center which will provide forensic exams for sexual assault victims and half of the request for SANE nurses. |

| VW | 7 | District Attorney's Office, 7th Judicial District | \$ 70,779 | Grant funds will partially support a specialized Sexual Assault Prosecutor and a .8 FTE sex offense victim specialist position. |
| VW | 10 | District Attorney's Office, 10th Judicial District | \$ 42,744 | Grant funds will provide partial support for four (1 FTE) Deputy District Attorney positions to work with domestic violence cases. |
| VW | 11 | District Attorney's Office, 11th Judicial District | \$ 20,905 | Grant funds will provide support for two advocates, one in Fremont County and one in Park County, who will provide services to victims in the Domestic Violence Fast Track program. |
| VW | 11 | Family Crisis Services, Inc. | \$ 63,015 | Grant funds will provide support for a Shelter Advocate, the Executive Director, and the Outreach and Education Coordinator positions. This agency provides shelter, advocacy and outreach & educational services to domestic violence, sexual assault and stalking victims in Fremont and Custer Counties. |
| VW | 12 | San Luis Valley Immigrant Resource Center | \$ 25,500 | Grant funds will support a Victim Advocate for domestic violence crime victims seeking V and T-Visas. |
| VW | 14 | Advocates - Crisis Support Services | \$ 80,916 | Grant funds will support four staff positions that provide comprehensive services for the agency's Domestic Violence Program and shelter, the SAFE/SART program, the Latina Outreach Program, and Volunteer Coordination/Shelter Management. |
| VW | 16 | District Attorney's Office, 16th Judicial District | \$ 38,102 | Grant funds will be used to partially support two Attorney positions to prosecute domestic violence and sexual assault cases. |
| VW | 17 | St. Anthony Health Foundation | \$ 55,342 | Grant funds will partially fund the SANE coordinator who coordinates the SANE program at St. Anthony North. |
| VW | 19 | District Attorney's Office, 19th Judicial District | \$ 55,964 | Grant funds will partially support two Victim Assistant positions that provide services to misdemeanor and felony domestic violence victims. |
