0.	Injects are specific scenario events or messages within the scenario that prompt players to implement the plans, policies, and/or procedures that require testing during the exercise. Each inject should be considered its own "event" within the timeline of the scenario. It is not always necessary to follow an inject with questions, however, they can be useful to foster valuable dialogue or help reach expected outcomes.	Expected outcomes represent management/administration's desired responses or actions to the questions or messages proposed during the delivery of injects. Expected outcomes should come directly from the plan being tested, as well as previous training staff may have received.	Learning points are the specific pieces of information or actions that management/administration hopes that personnel will learn or take away from the proposed inject questions and associated expected outcomes. These learning points often represent key pieces of the emergency operations plan that personnel should understand, or be aware of. It may simply be a reiteration of their roles and responsibilities during an emergency.	It can be useful to limit the time for the discussion of each inject so that all injects can be addressed during the given exercise timeframe.
