# THE DIRECTOR'S CORNER

Dear Colleagues: This month's Director's Corner is dedicated to preparedness.

#### **School Emergency Communication - Opportunity to Register**

- You will all remember the situation last April when the young woman, obsessed with the Columbine tragedy, made her way to Colorado. Schools across the state closed as a result but communications did not go smoothly.
- It has taken time but the state has created a website at the Colorado Information Analysis Center (CIAC) that will provide emergency information to many agencies including schools, when appropriate. This is your opportunity to opt into this notification system.
- Linked here is a three-page explanation of the new system and how schools can register.
- We will also be sending a copy of the instructions for registering to all schools for which we have contact information. We apologize if you receive this more than once, but we want to err on the side of caution.
- We are suggesting that more than one person on your school safety team register so that there is redundancy in your receipt of messages.

#### **Pandemic Disease Preparation**

- Fortunately, there have been no confirmed cases of the Coronavirus (2019-nCoV) in Colorado, but this would be a good time to brush up on your health procedures.
- Prevention: (from the Center for Disease Control <a href="https://www.cdc.gov/">https://www.cdc.gov/</a>)
- "There is currently no vaccine to prevent 2019-nCoV infection. The best way to prevent infection is to avoid being exposed to this virus. However, as a reminder, CDC always recommends everyday preventive actions to help prevent the spread of respiratory viruses, including:
  - Wash your hands often with soap and water for at least 20 seconds. Use an alcohol-based hand sanitizer that contains at least 60% alcohol if soap and water are not available.
  - Avoid touching your eyes, nose, and mouth with unwashed hands.
  - Avoid close contact with people who are sick.
  - Stay home when you are sick.
  - Cover your cough or sneeze with a tissue, then throw the tissue in the trash.
  - Clean and disinfect frequently touched objects and surfaces.
- These are everyday habits that can help prevent the spread of several viruses. CDC does have <u>specific</u> <u>guidance for travelers</u>."
- Our Resource Specialist, Isaac Baah, has pulled together resources from the Center for Disease Control and the REMS Technical Assistance Center.

### Updated Joint Guidance regarding HIPAA and FERPA

- The U.S. Department of Education and the Office for Civil Rights at the U.S. Department of Health and Human Services released updated joint guidance today addressing the application of the Family Educational Rights and Privacy Act (FERPA) and the Health Insurance Portability and Accountability Act of 1996 (HIPAA) Privacy Rule to records maintained on students.
- The guidance, which was first issued in November 2008, clarifies for school administrators, health care professionals, families, and others how FERPA and HIPAA apply to education and health records maintained about students.
- The revised guidance includes additional frequently asked questions and answers addressing when a student's health information can be shared without the written consent of the parent or eligible student under FERPA, or without written authorization under the HIPAA Privacy Rule.
