THE DIRECTOR'S CORNER

Happy New Year!

The staff of the Colorado School Safety Resource Center wishes everyone a safe and happy new year. While you were busy getting ready for your winter break and celebrating with family and friends, three important reports were released:

- The draft of the final report on the tragedy at <u>Marjory Stoneman Douglas High School</u> was released and a number of lessons learned can be gleaned from this report.
- The <u>Final Report of the Federal Commission on School Safety</u> was released on December 18th. This was followed quickly by a <u>document</u> from the National Association of School Psychologists outlining the components of the federal report with which they agree and those with which they disagree. Both make for interesting reading.

Congratulations to the first round of SAFER Grant Recipients:

- The State of Colorado's Legislature allocated \$4,857,354 for the SFY 2019 School Access For Emergency Response (SAFER) Grant Program Competitive Funding Results. The SAFER Program enacted by SB18-158 provides funding for interoperable communication hardware, software, equipment maintenance, and training to allow for seamless communications between existing school communications systems and first responder communications systems. It is with great pleasure that we announce that of the thirty-nine (39) applicants who had submitted their applications for this competitive funding opportunity, twelve local education providers were selected to receive funding. Thank you to all of those who applied for the SAFER Grant Program.
- Please do not be discouraged if you were not selected this time, as everyone is eligible to apply again in 2019. The funding announcement for the next SAFER will take place in the first calendar quarter of 2019, and we will post it then and forward to our list of superintendents.

Student/Staff Safety Summits

CSSRC staff conducted Student/Staff Summits in November and December. We traveled to Grand Junction, Ft. Morgan and Pueblo where over 300 middle and high school students joined us. Students were captivated by the two-hour keynoters and shared incredible insights and suggestions about issues of school safety within focus groups. CSSRC Updates

NFPA 3000

The CSSRC has teamed up with our CDPS partners: the Division of Fire Prevention and Control (DFPC), the Colorado State Patrol, and the Division of Homeland Security and Emergency Management which includes the Colorado Information Analysis Center (CIAC) to facilitate two workshops providing an overview of the NFPA 3000™ Standard for an Active Shooter/Hostile Event Response (ASHER) Program which gives guidelines for all emergency responders in an active shooter situation.

The first workshop was held in Loveland, CO, while the second was held in Pueblo, CO and both were attended by school, hospital, police, fire, emergency management and long term care staff. Participants were presented an overview of the NFPA standard followed by what participants expressed as the most useful part of the workshop, several hours of networking and problem solving around the tenants of ASHER programming. Facilitator's Guide to Sexting: What You Need to Know

The Center's online course for juveniles, <u>Sexting: What You Need to Know</u>, has been available since May of this year.

School Mental Health Professionals Meeting Update

The CSSRC has been periodically inviting school mental health professionals to meet and discuss current concerns in the schools. Recently, we met with about 15 professionals both in-person and on the phone to discuss the recent rash of youth suicides. Below are some of the takeaways from that meeting:

- Districts are using a variety of approaches to educate staff, students and to a lesser degree parents. More quick info sent home to **parents** would be helpful. You can access the Parent Awareness Series: Talking to Your Kids About Suicide here. You can access the Suicide Prevention Resources for Parents/Guardians/Families here.
- A number of those present talked about the stress that students are feeling and the need for schools to teach skills for handling that stress.
- It was also pointed out that the research tells us that one of the biggest risk factors for students is a **lack of sleep**. Encouraging students to ramp down their schedules and get more sleep would be most helpful.
- Most districts are relying upon the Colorado Crisis Services which are able to respond at varying degrees of success. If you have any issues with CCS, please let Mary Hoefler, the Director of the program at the Colorado Department of Human Services know. Information about when/where any glitches occur will help Mary rectify issues and also allow her to keep track if the system is not robust enough so she can report back to the legislature so that perhaps at some time in the future, more funds will be devoted to this. - A number of folks have been able to create Memoranda of Understanding with their local hospitals so that the hospitals will get parent permission to share information about a student when that student returns to school. We are planning a workshop on this for the next Suicide Sympoisum (TBD).
- Finally, it was requested that the Center create a master list of mental health related trainings so that everyone has access to others who might help train your staff. The CSSRC is in the process of doing this.

New Title IX Proposed Regulations Released:

Title IX is the federal law that prohibits discrimination on the basis of sex in education programs and activities that receive federal financial assistance (K through higher education). The definition of "discrimination" has been interpreted to include sexual harassment and assault. On November 29, 2018, the U.S. Department of Education published proposed regulations to finalize the repeal and replacement of previous guidance under the current and previous administrations. A <u>one-page fact sheet</u> provided by the Department is available, as well as <u>section-by-section summaries</u>. The Department has invited those who work at schools to consider how the changes might impact safety, and comment on the proposed changes to definitions and procedures. Responses to the proposals must be received by **January 28, 2019**. Instructions on the comment procedure are found <u>HERE</u>.
