### **I Matter**

- The [Colorado Department of Human Services \(CDHS\) Office of Behavioral Health \(OBH\)](#) has launched “a program to promote youth emotional and mental health.”
- [Colorado House Bill 21-1258](#) established this temporary behavioral health services program to provide access to mental health and substance use disorder services for youth, including addressing needs that may have resulted from the COVID-19 pandemic. The program is open to youth 18 years of age or younger, or 21 years of age or younger if receiving special education services.
- The program provides up to 3 free behavioral health sessions for youth in Colorado and reimburses participating providers, which are licensed clinicians from agencies and independent contractors.

## Be SMART

- In 2021, the Colorado Legislature passed a safe storage law ([CRS 18-12-114](#)) which requires parents to lock or store their firearms to keep them out of the hands of children.
- We want to get that information out because we know it can save lives.
- As you are probably aware, in Colorado suicide is the leading cause of death among 10-24-year olds.
- Nationwide, firearms are the #1 cause of death in children 1-19 years old.
- And, last year nationally there were 187 incidents of gunfire on school grounds, resulting in 42 deaths and 113 injuries. \* EveryStat.org
