To Our Mountain States Region Education Friends,

Pipe bombs sent through the mail by political motivation. Two people killed at a grocery store in Kentucky simply because of their skin color. Eleven people shot dead and six injured at a place of worship in Pittsburgh based on their religious and cultural values.

You, your students, their families, and your school communities may be impacted, in varying degrees, to these and other events that our occurring, seemingly daily, in our world. The School Safety Resource Center enjoyed a wonderful celebration of the **10th anniversary at the Summit** on October 1st and 2nd. Thanks to all our presenters, honored guests and participants. Some of the highlights of the last ten years include:

- Center staff have conducted 955 trainings for close to 42,000 participants. Of those trainings, more than 60 have been regional trainings. This has also included 10 Suicide Symposia with our partners at CDPHE, CDE and recently the AG's office.
- CSSRC distributes over 40,000 hardcopies of resources EACH YEAR
- The Center staff have been tweeting since 2012 with close to 5, 000 Tweets
- Staff have conducted over 11,000 consultations since 2008
- 13 online courses have been produced since 2012 including the two most recent on *Sexting and Suicide Awareness*.

But we aren't resting on our past accomplishments. I am very pleased to announce that our [new online course: Suicide Risk Factors and Warning Signs](#) can be accessed on Co-Train with the following course ID number 1080982. This course, designed by Dustin Hunter the Center's School Outreach Consultant, is primarily for *non-mental* health staff in your schools so that they not only have information for recognizing a student that might be at-risk of suicide, but more ease in starting the conversation with these students and understand the importance of a safe and timely referral. Like all of our online courses, they are free of charge and upon completion, participants are awarded a certificate that can be used for continuing education hours.

Before the winter break, the Center is hosting three **Student/Staff Safety Summits in Grand Junction, Ft. Morgan and Pueblo**. These will take place in November and early December at NO CHARGE. We are hoping for student teams from your middle and high schools along with supervisory staff. We are bringing in national speakers for all three of these events. We will also hold focus groups with students to get their perspectives on school safety. Please see the [attached flyer](#) for more details and registration information.

In early February, we will host a one-day event on Threat Assessment. The internationally recognized speaker and author on school shooters, **Peter Langman, Ph.D., author of *Why Kids Kill*** will spend four hours educating school staff on these individuals. School Safety Steps:

Now that the planning team has evaluated and ranked which threats, hazards, and vulnerabilities will be addressed in the school EOP, the planning team will need to develop goals and objectives to address those threats, hazards, and vulnerabilities.

Goals are broad, general statements that indicate the desired outcome in response to the threat, hazard, or vulnerability. The goals represent what personnel and other resources are supposed to achieve. An example for the hazard of fire, might be: *Protect all persons from injury and property from damage by the fire.*

Objectives are more specific and identifiable actions. Objectives lead to achieving goals and determining the actions that must be accomplished. Translating objectives into activities, implementing procedures, or operating procedures is part of planning. Two examples for the goal stated above, might be: *Evacuate all persons from the building immediately.* And: *Account for all persons.*

Just as with academic goals, school EOP goals and objectives should be measurable, actionable, and have a set timeline for completion.

By establishing goals and objectives for your school EOP, you should be able to:

- Establish metrics to help measure planning effectiveness.
- Identify priorities to be addressed by the planning team.
- Determine resources needed before, during, and after an incident.
- Identify when elements of the response are complete and when the operation is successful.

All of these will assist the planning team in establishing courses of action and writing the functional and hazard annexes (appendices), which we will cover next month.
