## THE DIRECTOR'S CORNER

### Welcome Back!

Earlier this week **we sent letters electronically to all superintendents, BOCES directors, IHE, charter school and private school leaders.** The letter links to a survey that Governor Polis' office has asked us to conduct. The state is interested in knowing where schools (pre K through college) are in their emergency planning and what resources are still needed. We are trying to collect information on individual school buildings.

If you are a school leader and didn't receive a copy of the [letter](#) and [link to the survey](#), please access both here and help us get a substantial return so that state officials are aware of your accomplishments and gaps. The final report will be an aggregate of the results with no identifying information shared.

- The Center has been facilitating a Threat Assessment Working Group. At the most recent meeting, a cross analysis of threat assessment documents from Colorado and other states was reviewed.
- Although the working group does not expect to adopt a common protocol, efforts have been made to assist districts in covering all the necessary information to protect students and hopefully minimize risks for the district.
- During this analysis, staff from the CSSRC have made changes to the protocol (originally based on the work of Adams County school districts and the Center) that we have been using for training.

“As most of you know, the US Court of Appeals for the Ninth Circuit ruled that the [COPS Office](#) does have statutory authority to award immigration related bonus points to applicants. This decision reverses a district court injunction that prevented the COPS Office from implementing its programs as designed. Once the Ninth Circuit’s decision to reverse the injunction has taken effect, our office is prepared to launch the COPS Hiring Program (CHP) and the Community Policing Development Microgrants Program as soon as possible.
