- We have transitioned to One Chance to Grow Up as marijuana is being legalized and commercialized across the country- we have lessons to share!




Let's set the record straight:

- We are here to talk about kids and the impacts of marijuana and marijuana product use
- Our time together is not about adult use or the pros/cons of marijuana legalization
- Today, I will be referring to this drug as marijuana as that is the verbiage that was used in Amendment 64
- Regardless if you or someone you know uses marijuana, we should be able to agree that marijuana and kids do not mix
- We supported FDA approved Epidiolex (CBD derived from the marijuana plant) as well as funding for research

What we do & why it matters

Educate

- > Hundreds of meetings and briefings with schools and community groups, local governments and other organizations including CO State Dept of Revenue, which regulates MJ
- Participation in several State and Local committees
- Many successful and some unsuccessful efforts to stop cities and counties from adopting commercial MJ

Use Media to provide sound and accurate information

- Hundreds of earned media stories, opinion pieces and paid media advertising throughout CO, DC and in states pursuing legalization
- Offer THC Photos as an unbiased, realistic source for products on the legal market- it's no longer a plant!



What (continued)?

Change policy through putting safeguards in place

- Significant positive impacts on CO policies through advocacy and bill sponsorship-Over 24 bills passed:
 - Product labeling including THC, CBD and Potency
 - > Warning Labels- including improved mental health warnings
 - Child resistant packaging
 - Edible markings
 - > Pregnancy warnings
 - > 150 additional behavioral specialists in the schools
 - Potency studies
 - Delivery and social consumption restrictions

Significant positive impact at the national level

> Direct access to key Senator and Representatives- educating on the MORE and SAFE Banking Acts



HB21-1317 highlights

Enhancing health and safety protections in these areas:

- Potency research review to be determined by University of Colorado, School of Public Health and scientific review committee
- Adoption of a medical marijuana tracking system that treats medical more like a medicine and required training for doctors recommending
- Required toxicology and data collection for all "non natural deaths" ages 25 and under
- Making it more difficult for 18-20 yr olds to get a med card therefore, reducing marijuana available for distribution in our schools
- > Reduction of daily purchase limit of marijuana concentrates for 18-20 yr olds



THC Potency Matters





After the Dutch observed negative impacts from rising THC potencies, a team of health experts concluded that THC potencies above 15% should be considered a hard drug, like cocaine.

Nearly 93% of all products found in CO in 2020 were over 15%

Massive increase in THC Potency





Multiple studies show serious problems with high THC: addiction, psychosis, depression, anxiety, sleep problems, suicide, violence.

Commercialization Has Radically Changed Marijuana

Packaging and THC portion amounts minimize risks to consumer and better address inaccurate assumptions vs actual product effects

THEN



Before 2000, THC Potency in Marijuana was under 5%



NOW



Today, THC potency in products like shatter can exceed 90%.





High-potency THC linked with a TRIPLED risk for psychosis

Study analyzed 780 people ages 18–65, 410 with first-episode psychosis and 370 healthy controls

HIGH-POTENCY THC (15% THC or more) 3X INCREASED RISK OF PSYCHOSIS

DAILY USE (15% THC or more) 5X INCREASED RISK OF PSYCHOSIS

LOW POTENCY (less than 5% THC) HAD NO ASSOCIATED RISK FOR PSYCHOSIS






High Potency THC is hurting CO Kids

*CDPHE Monitoring Health Concerns Related to Marijuana in Colorado: 2018 summary


- Weekly use associated with: deficits in learning, memory, math and reading skills as well as up to 8 point reduction in IQ points
- MJ use is associated with failure to graduate from high school and/or finish college
- More likely to experience psychotic symptoms as adults (such as hallucinations, paranoia and delusional beliefs
- Marijuana is addictive
- Nearly 49% of teens who regularly use marijuana said they have driven while high
- Quitting marijuana use can help regain some deficits-one can lower risks of adverse cognitive and mental health outcomes by stopping








Significant increase in Adolescent Marijuana-Associated Emergency Dept/Urgent Care Visits in Colorado




